He served as a Senior Vice President and Director of Laboratory Operations for Oak Ridge National Laboratory for Battelle Memorial Institute (Battelle Inc.). He served as a Senior Vice President for U.S. Department of Energy Science Programs of Battelle Inc. Dr. Wadsworth worked in California at Stanford University, and Lockheed. He serves as Member of Independent Governors at Lawrence Livermore National Security, LLC. He serves as Director of 360ip Pte Ltd. Dr. Wadsworth has been an Independent Director of Carpenter Technology Corp. since January 11, 2006. He serves as a Trustee at Ohio State University. He serves as a Director of Velocys, Inc. He served as a Director of Achieve, Inc., since June 11, 2009. Dr. Wadsworth served as Director of Homeland Security Programs of Battelle and part of the White House Transition Planning Office for the newly formed U.S. Department of Homeland Security. From 1992 to 2002, Dr. Wadsworth served at the Lawrence Livermore National Laboratory in Livermore, California and also served as Deputy Director of Science and Technology since 1995. Previously, he served with Lockheed Missiles and Space Company, Research and Development Division. He was elected to the National Academy of Engineering in 2005, and has been elected Fellow of several technical societies. He holds adjunct consulting and honorary professorships from various universities in the U.S. and China, and has been the recipient of numerous technical awards and prizes. Dr. Wadsworth earned a Bachelor's Degree in Metallurgy in 1972, Ph.D., D. Met in 1975 and D. Eng. from Sheffield University, England.
