Your complaint regarding the actions of Ohio State University Trustees and Administration in the firing of OSU Marching Band Director Jon Waters has been received by the Office of the Ohio Inspector General.

Upon receiving a complaint, it is the policy of this office to assign a complaint number. Your complaint has been assigned [REDACTED]. In addition, each complaint is evaluated by the Inspector General's Intake Committee to determine whether it falls within the Office's jurisdiction and if so, whether it merits action by this Office. Every effort is made to promptly and reasonably respond to your complaint. While we cannot affix a definite time frame to respond, we are committed to ensuring that the review of your complaint is conducted fully, fairly, and impartially. If you have not received a response within six weeks of filing your complaint, please do not hesitate to contact us at 1-800-686-1525 to check the status.

A complaint offering credible allegations of wrongful acts or omissions that fall within our jurisdiction is assigned to a deputy inspector general for further investigation. However, if the intake committee determines that no investigation is warranted, or if the complaint concerns a matter outside the jurisdiction of the Office of the Inspector General, an effort will be made to properly refer your complaint. The Office of the Inspector General does not offer legal advice or opinions to complainants.

If your complaint results in the opening of an investigation, there is no average or even estimable time in which investigations are concluded. Various factors determine the length of an investigation, including the nature of the allegations, the number of interviews to be conducted, and the amount of documents to be gathered and reviewed.

The Office of the Inspector General remains dedicated to the principle that no public servant, regardless of rank or position, is above the law, and the strength of our government is built on the solid character of the individuals who hold the public trust.
