The Panama Papers is a trove of 11.5 million confidential documents detailing more than 214,000 offshore companies represented by the Panamanian law firm, Mossack Fonseca. They were leaked to the German newspaper Süddeutsche Zeitung a year ago.



The newspaper teamed with The International Consortium of Investigative Journalists (ICIJ), BBC England, The Guardian, Le Monde and others to analyze the 2.6 terabytes of data before first releasing the results of their work on April 03, 2016.

LEAK SOURCE: "Mossack Fonseca is doing real harm to the world."

The source of the leak demanded anonymity, communicated only through encrypted channels, never met the recipients and never asked for remuneration. He said his life was in danger, but believed Mossack Fonseca was doing real harm to the world.

The leak dwarfs previous leaks. The researchers are combing through 4.8 million emails, 2.1 million PDF documents, 1.1 million images and 3 million database files.




NEVADA ACCOMPLICES PROTECTED BY OBAMA EXECUTIVE ORDER 13526

FATCA sounds good on the surface. It required American holders of offshore accounts to report them to the IRS. The global community through the Organization for Economic Co-operation and Development (OECD) passed even stiffer rules requiring disclosure of underlying owners and officers of offshore accounts. This punched a hole in the secrecy veil that has been the main attraction of offshore accounts.

Tellingly, only the United States, Bahrain, Nauru, Panama and Vanuatu have refused to sign OECD.

Did Nevada make any law changes before this?

Researchers wondered if Obama's executive order and FATCA were connected to a common Cartel agenda.


BINGO, STEP 3: Nevada corporation law – complete anonymity

Magically, when the Federal Circuit panel was named by Chief Judge Randall R. Rader, Wallach was assigned as one of the three judges—even though he had no patent law experience. Wallach ruled against Leader's patent property rights while he held Facebook financial interests, including Fidelity Contrafund—the largest mutual fund holder of Facebook pre-IPO stock. 


FIG. 9—James P. Chandler, III, Rader's law professor; adviser to Clinton, Bush, Obama, Reid, Wallach; IBM attorney; NSA, FBI adviser; Judiciary adviser; and, former attorney to social networking inventor, Ohio innovator Leader Technologies, from whom he stole the invention for the IBM Eclipse Foundation Cartel. Top photo: CAFC.

We are an opinion blog that advocates for strong intellectual property rights. We welcome commenters and contributors. The Leader v. Facebook patent infringement case first came to our attention after learning that the trial judge, Leonard P. Stark, U.S. District Court of Delaware, ignored his jury's admission that they had no evidence to support their on-sale bar verdict, but the judge supported it anyway.

The judicial misconduct has deteriorated from there, replete with two of the three judges on the Federal Circuit appeal panel, Judges Alan D. Lourie and Kimberly A. Moore, holding Facebook stock that they did not disclose to the litigants, and later tried to excuse through a quick motion slipped in at the last minute by the Clerk of Court, Jan Horbaly, and his close friends at The Federal Circuit Bar Association. (The DC Bar subsequently revealed that Mr. Horbaly is not licensed to practice law in Washington D.C.)

The judges ignored shocking new evidence that Mark Zuckerberg withheld 28 hard drives of 2003-2004 evidence from Leader Technologies that could prove actual theft (and therefore claims even more serious than infringement). In addition, Facebook's appeal attorney, Thomas G. Hungar of Gibson Dunn LLP, has close personal ties to just about every judicial player in this story. The misconduct appears to reach into the U.S. Patent Office through abuse of the reexamination process by Facebook. We will stay focused on Leader v. Facebook until justice is served, but we also welcome news and analysis of intellectual property abuse in other cases as well.

Hundreds of protesters flocked to the U.S. Capitol Monday for a demonstration against the role of money in politics, prompting arrests of more than 400 by the Capitol police force.

The demonstration was part of a series of "Democracy Spring" protests planned in Washington this week by a coalition of groups.

The demonstrators chanted slogans like "one person, one vote" and "money out of politics" as they sat on the East Front of the Capitol. One sign read "Things go better without Koch," a reference to the billionaire businessmen David and Charles Koch, who have promised to lead an almost \$900 million campaign to back favored candidates this election cycle.

The demonstrators also protested state voter ID laws, saying they suppress voter participation. Another chant protested Democratic "superdelegates" -- party figures, such as members of Congress, who are given votes at the Democratic National Convention but are not elected by primary elections or at party caucuses.

TOO CORRUPT AND TOO BIG TO FAIL?-GOLDMAN SACHS

Too Big to Fail (TBTF) is a major concern regarding the stability of our economic system. It was a major problem during the Great Recession, requiring over \$425 billion in bailout money. \$700 billion for the Troubled Asset Relief Program (TARP) was approved by Congress of your money to subsidize "Too Big to Fail" financial institutions. In fact, former Goldman Sachs employee Neel Kashkari, the new president of the Federal Reserve Bank of Minneapolis since January, was in charge of TARP and now is conducting a major project this year to create a recommendation to Congress to prevent it from happening again.

Yet Goldman Sachs, as mentioned in numerous reports above, is one of the major culprits -both in terms of corruption (the \$5B fine it agreed to pay on Monday), its market concentration, and its personnel placement.

According to its own 2015 Annual Report (page 7), Goldman Sachs now manages \$1.25 TRILLION in assets.

To put that in perspective, the U.S. GDP is \$18 trillion. So Goldman Sachs controls the equivalent of about 6.9% of our economy. As you can read in the chart below, Goldman Sachs, if it were a sovereign country, would have control over the 12th largest economy in the world-bigger than Australia, Russia, Spain and Mexico (the next four smaller economies).



Zuckerberg's advocacy group FWD.us released a statement Wednesday calling Trump's proposal that the U.S. deport 11 million illegal immigrants "absurd."

Posted by FWD.us president Todd Schulte, the statement doesn't name Trump specifically but calls out the "voices yelling for mass deportation," an immigration reform idea Trump has supported.

FWD.us's statement reads as a retort to Trump's first policy paper on immigration reform, in which he refers to Florida Senator Marco Rubio as "Mark Zuckerberg's personal senator," implying Rubio takes his immigration policy cues from the Facebook co-founder.

Here's what the FWD.us post says about the consequences of mass deportation:

"[D]eporting 11.5 million people would cost U.S. taxpayers \$400 to \$600 billion dollars, and would take at least 20 years to complete. Even worse, this mass deportation would reduce our GDP by \$1.7 trillion--over 5 percent. Many industries would be hit hard, others--like agriculture, construction and hospitality--would be devastated."

FWD.us also fired back against proposals to limit programs like the H-1B visa that allows U.S. companies to employ foreign workers, calling any plan to "radically restrict pathways" for skilled immigrants to come to the U.S. "just wrong." In his plan, Trump is calling for making it more expensive to hire H-1B visa holders, as well as making it more difficult for companies to replace U.S.

While Trump and Zuckerberg's FWD.us represent policy positions that are in direct conflict, SiliconBeat points out that Trump has supported some proposals favored by those in the tech industry, such as efforts to help foreign students stay and work in the U.S.

Now that even terrorist organizations are savvy with social media, the CIA's investment arm, In-Q-Tel, is pouring more money into companies that help make sense of noisy social networks. As The Intercept reports, In-Q-Tel quietly made investments in Dataminr, a company that uses a Twitter stream to spot trends and threats for authorities; Geofeedia, which collects geotagged social posts; PATHAR, a company that directly mines social accounts for ties to terrorism and radicalization; and TransVoyant, which also monitors social networks.

In-Q-Tel has been making bets on similar companies over the last decade, so these investments aren't particularly shocking. But they show what's important to the agency today: It needs solid tools for sorting out everything happening on social networks. These four companies are just a handful of the 38 new investments revealed by The Intercept, via a program from this year's CEO Summit. The firm also invested in the likes of Lookout, which focuses on mobile security, and Transient Electronics, which is developing dissolvable semiconductor tech.
