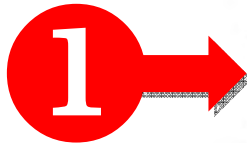

DLL plainly cannot show such features, since a DLL is a binary shared library and is not executable by different language processors.

Finally, new independent claim 34 incorporates a number of additional aspects informally discussed with the Examiner as distinguishing Laborde, such as content object access control being performed by a system core, distinct from the runtime environment executing the various applications, and the shared data model including privacy attributes associated with content objects and being taken into account by the system core as part of the object access control. Thus, claim 34 is distinguishable from Laborde for these additional reasons, in addition to the reasons already noted with respect to independent claim 1.

The remaining claims depend, directly or indirectly, from one of claims 1, 16, and 34, and recite additional patentably distinguishable features and limitations. Thus, they are distinguishable from Laborde for at least the same reasons discussed above with regard to their respective independent claims.

### Conclusion

Thus, claims 1-20, 23, and 25-34 are patentably distinguishable from Laborde.

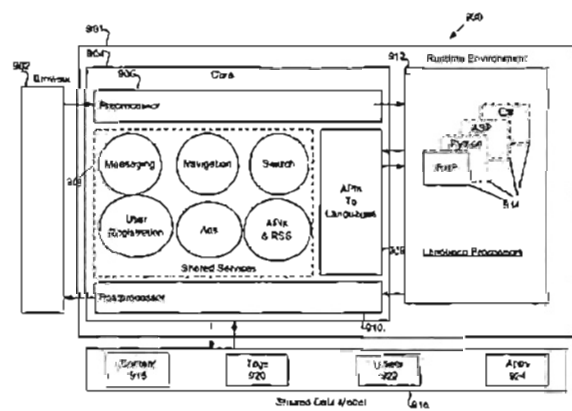
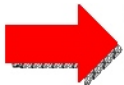
