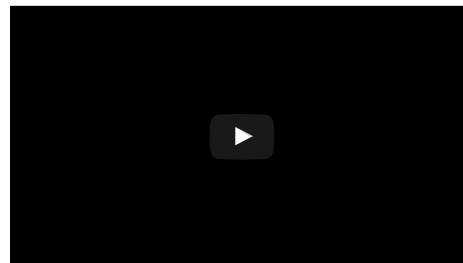

Clinton Foundation (or **The Clinton Global Initiative**) is a party or represents a party, unless I am first authorized to participate, pursuant to 5 C.F.R. § 2635.502(d).

The scanned documents were in poor condition. One could be excused for thinking that the State Department attorneys used a special "make this email nearly unreadable" printer setting. Many of the scans were skewed and pixilated, making them hard to read. The sloppy condition forced AFI investigators to painstakingly review them page by page. Automatic searches were impossible.

In general, our researchers have found a correlation: the more damning the document, the more degraded the reproduction. The bottom line is that our taxpayer-funded State Department lawyers are using their salaries to hide and deface public property.

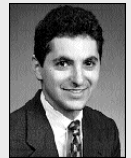

However, the State Department fraudulently misstates the statute, broadening it from "personnel and medical files" to "Information" and even wholly rewritten to just "Personal privacy information." Such obviously intentional misstatements of the law to protect Hillary are themselves aiding and abetting the crimes:

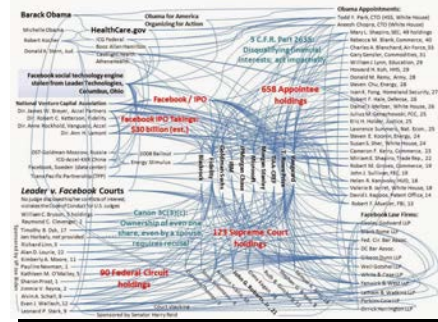

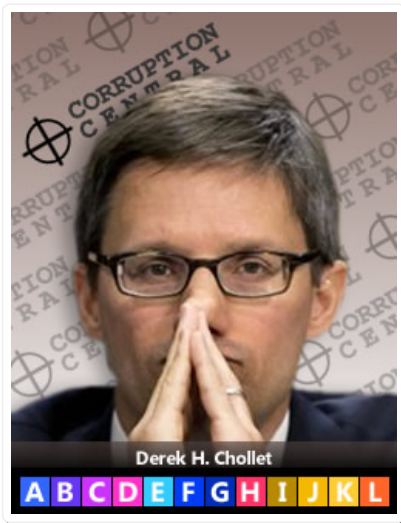

Here is another clearly fraudulent use of B6 to hide the identity of a correspondent from the Clinton Climate Initiative. B6 is also used for DENNIS CHENG, the middle man between the State Department and the Clinton Foundation. In this email, Cheng's Clinton Foundation email address is blanked out using B6. Here Cheng asked Abedin for her full name—HUMA MAHMOOD ABEDIN—and asks if her personal email is working yet—an evident effort to hide their unethical coordination.

**NEW, SEP. 07, 2016:** Another Hillary insider who was a likely go-between for The Clinton Foundation, George Soros' Open Society Foundations and the secret executive order White House intelligence agency was DEREK H. CHOLLET.

Chollet helped edit Hillary's first speech on "Internet Freedom" that promoted Facebook and Twitter as political tools for election rigging. Chollet is a former adjunct professor at George Washington University (where James P. Chandler is emeritus professor intellectual property). He was on Obama's transition team and worked for Hillary from as principal deputy director of policy planning (2009-2011). Then he became Obama's senior director on the national security council. Unless most of Hillary's interactions with Clinton Foundation employees, Facebook and John Podesta were about health and personnel records, which they were not, none of them should have been redacted.

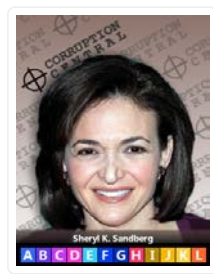

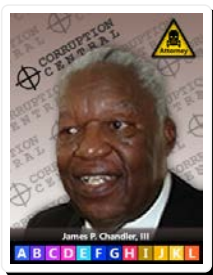





## CURRENT EDITORIAL FOCUS

We are an opinion blog that advocates for strong intellectual property rights. We welcome commenters and contributors. The Leader v. Facebook patent infringement case first came to our attention after learning that the trial judge, Leonard P. Stark, U.S. District Court of Delaware, ignored his jury's admission that they had no evidence to support their on-sale bar verdict, but the judge supported it anyway.

The judicial misconduct has deteriorated from there, replete with two of the three judges on the Federal Circuit appeal panel, Judges Alan D. Lourie and Kimberly A. Moore, holding Facebook stock that they did not disclose to the litigants, and later tried to excuse through a quick motion slipped in at the last minute by the Clerk of Court, Jan Horbaly, and his close friends at The Federal Circuit Bar Association. (The DC Bar subsequently revealed that Mr. Horbaly is not licensed to practice law in Washington D.C.)

The judges ignored [shocking new evidence](#) that Mark Zuckerberg withheld 28 hard drives of 2003-2004 evidence from Leader Technologies that could prove actual theft (and therefore claims even more serious

than infringement). In addition, Facebook's appeal attorney, Thomas G. Hungar of Gibson Dunn LLP, has close personal ties to just about every judicial player in this story. The misconduct appears to reach into the U.S. Patent Office through abuse of the reexamination process by Facebook. We will stay focused on Leader v. Facebook until justice is served, but we also welcome news and analysis of intellectual property abuse in other cases as well.

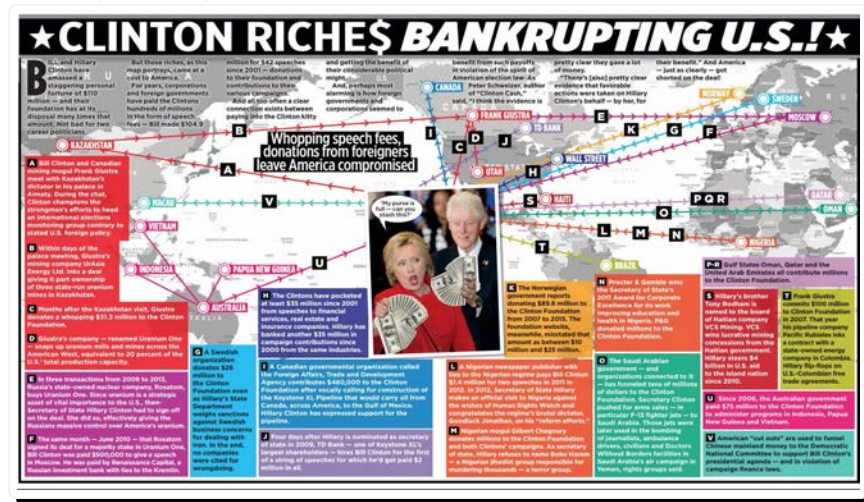


FIG. 7—CLINTON CORRUPTION MAP. An AFI reader just asked us to post this graphic that summarizes many of the elements of the Clinton corruption across the globe. The reader also asked that other readers pass on this graphical overview describing why we cannot allow such a corrupt person as Hillary Clinton to ever be President of the United States. Source: Unknown.

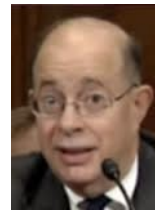

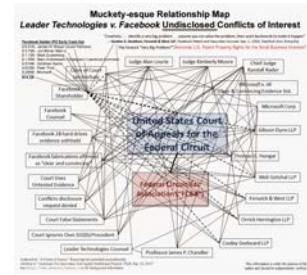

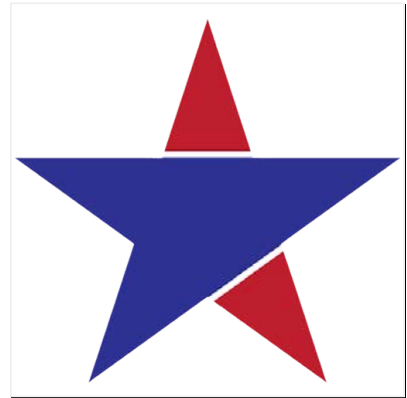

Kristian Saucier's attorneys argued in a court filing last week that Clinton had been "engaging in acts similar to Mr. Saucier" with information of much higher classification. It would be "unjust and unfair for Mr. Saucier to receive any sentence other than probation for a crime those more powerful than him will likely avoid," attorney Derrick Hogan wrote.

U.S. District Judge Stefan Underhill sentenced Saucier to one year in prison and a \$100 fine, along with six months home confinement, 100 hours of community service and a ban on owning guns, his legal team says. Prosecutors had asked for six years behind bars.

"We're very pleased," says Greg Rinckey, another defense attorney for Saucier.

Although relieved, Rinckey does say that "it could be argued here that depending on what your name is, that's the type of justice you get in the United States."

Two of journalism's most radical figures are now silenced, or shunned. Nick Denton, the Brit whose Gawker website has whipped away the lace curtains that covered (mainly) sexual privacy since 2002, has been bankrupted by vengeful and wealthy men.

Julian Assange, the Australian whose Wikileaks organization has revealed (mainly) U.S. secrets, has been left alone and friendless – dropped even by one-time allies after dumping troves of unredacted information taken from the files of U.S. and Turkish political parties.

Both men tried to create new standards for investigative journalism; both have failed so far. They've failed in their efforts to emulate the paper that sees itself, with some justification, as fashioning the model for that brand of reporting -- the New York Times. The Times has, for more than a century, stated its guiding principle on the top left-hand corner of its front page. "All the News That's Fit to Print" was chosen as the paper's slogan by Arthur Ochs in 1896, the year he bought the publication. It was meant to differentiate the Times from the popular "yellow press" that, like Gawker, specialized in gossip, if way less racy. Ochs wanted to attract, by a display of ethical propriety, the burgeoning, respectable bourgeoisie of the city.

The New York Times has long taken the lead in publishing the secrets of U.S. (and other) administrations--but shorn of personal details. If it tore aside a veil concealing a sex scandal, it did so with reluctance and justified its decision to publish to itself and to its readers on the grounds of public interest. Joseph Lelyveld, editor during the hottest period of the Bill Clinton-Monica Lewinsky affair, was genuinely conflicted about whether or not the story was fit to print. Because it was at the centre of a move to impeach the president, it was.

The New York Times' stature has made it a template for the respectable press. The British and other tabloids have always thumbed their noses at such propriety So does the new generation of leakers, who think "fit to print" is mainly cowardice in the face of government disapproval.

Judge Orders State Dept. to Hand Over New Clinton Emails by September 13  
Published August 25, 2016

A federal court ruled Thursday that the State Department has until Sept. 13 to begin handing over emails recovered by the FBI from Hillary Clinton's private server.

The order came in a Freedom of Information Act lawsuit filed by Judicial Watch, a conservative-leaning watchdog group, over communications between Clinton and the White House from the day of and week after the Sept. 11, 2012 terror attack in Benghazi.

"The State Department shall search the material, determine whether any responsive records exist, and complete its first production of non-exempt records, to the extent any exist, by September 13, 2016," the court ruled.

The United Nations could take over control of the Internet on October 1, when the Internet Corporation for Assigned Names and Numbers (ICANN) passes from U.S. administration to the control of a multilateral body, most likely the United Nations International Telecommunications Union (ITU).

While the administration and its defenders have denied that the UN will have authority over ICANN, the Wall Street Journal's L. Gordon Crovitz points out that ICANN will need to be run by a state agency in order to retain its antitrust exemption, which makes it almost certainly that the UN will step in to take control.

Congress can still act to prevent the transfer: Sen. Ted Cruz (R-TX) and Rep. Sean Duffy (R-WI) have introduced the Protecting Internet Freedom Act, which would prevent the transfer of ICANN without Congressional approval.

The largest payout ever given to an informant, the \$104 million awarded to Birkenfeld were part of the IRS's whistleblower program, which rewards informants up to 30 percent of collected funds and fines from pursued claims. Around the time of the award, the IRS was seeking to shrink potential whistleblowers' payout, which drew fierce criticism from a number of lawmakers. The IRS program, which was revamped in 2006 to offer higher rewards and incentives, was created to encourage informants to come forward with allegations of potential wrongdoings in an effort to help the agency recover an estimated \$100 billion a year of underpaid taxes.

From today, banks must:

- Provide a confidential whistleblowing hotline which is accessible not just for employees, but any member of the public who wishes to blow the whistle on their activities;
- Tell their staff about the whistleblowing services already provided by the financial regulators (the FCA and PRA), and how to access them;
- Present an annual Board report on whistleblowing;
- Inform the financial regulators if it loses a whistleblowing case in an employment tribunal; and
- Ensure that its staff are appropriately trained on whistleblower protection.

Whistleblower's champion

In addition to the above, each bank must appoint a senior manager (known as a "whistleblowers' champion") who takes ultimate responsibility for ensuring that whistleblowing systems and processes are robust and fit for purpose. The whistleblowers' champion role is hugely important because the regulators consider the ability of the bank to handle whistleblowing complaints properly directly impacts on their fitness and propriety to carry out regulated work.
