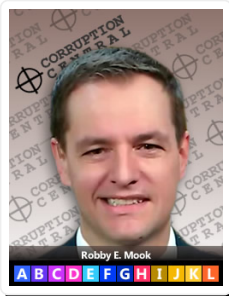
On Oct. 18, 2014,

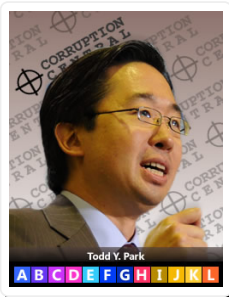

Now it gets even more devious.

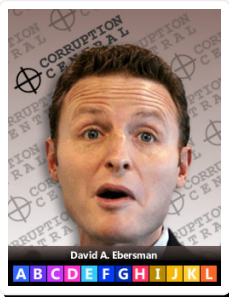
CASTLIGHT HEALTH SCAM

Castlight Health's directors and large shareholders include a number of significant Facebook relationships and holdings, including:

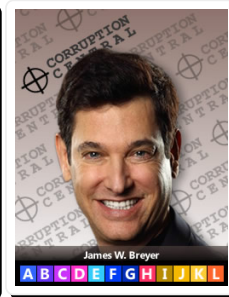
- 1. **DAVID A. EBERSMAN**, chief financial officer at Facebook.

- 5. **FIDELITY CONTRAFUND**, the largest mutual fund investor in Facebook.



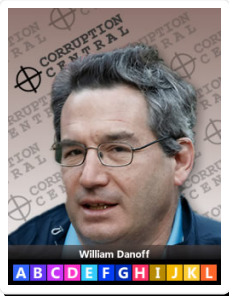
