### CURRENT EDITORIAL FOCUS

We are an opinion blog that advocates for strong intellectual property rights. We welcome commenters and contributors. The Leader v. Facebook patent infringement case first came to our attention after learning that the trial judge, Leonard P. Stark, U.S. District Court of Delaware, ignored his jury's admission that they had no evidence to support their on-sale bar verdict, but the judge supported it anyway.

The judicial misconduct has deteriorated from there, replete with two of the three judges on the Federal Circuit appeal panel, Judges Alan D. Lourie and Kimberly A. Moore, holding Facebook stock that they did not disclose to the litigants, and later tried to excuse through a quick motion slipped in at the last minute by the Clerk of Court, Jan Horbaly, and his close friends at The Federal Circuit Bar Association. (The DC Bar subsequently revealed that Mr. Horbaly is not licensed to practice law in Washington D.C.)

The judges ignored [shocking new evidence](#) that Mark Zuckerberg withheld 28 hard drives of 2003-2004 evidence from Leader Technologies that could prove actual theft (and therefore claims even more serious than infringement). In addition, Facebook's appeal attorney, Thomas G. Hungar of Gibson Dunn LLP, has close personal ties to just about every judicial player in this story. The misconduct appears to reach into the U.S. Patent Office through abuse of the reexamination process by Facebook. We will stay focused on Leader v. Facebook until justice is served, but we also welcome news

Judge Leonard P. Stark, U.S. District Court of Delaware, trial judge in *Leader Techs, Inc. v. Facebook, Inc.*, 770 F. Supp. 2d 686 (D.Del. 2011). Judge Stark heard his jury foreman admit that the jury made the on-sale bar decision without any evidence other than speculation, and yet he supported that verdict anyway. Just months before trial, Judge Stark allowed Facebook to add the on-sale bar claim after the close of all fact discovery and blocked Leader from preparing its defenses to this new claim. Judge Stark allowed the claims despite Leader's prophetic argument that the action would confuse the jury and prejudice Leader. He also permitted the jury to ignore the *Pfaff v. Wells Electronics, Inc.* test for on-sale bar, even after instructing the jury to use it. (See that [Jury Instruction No. 4.7 here.](#)) He also contradicted his own instruction to Leader to answer Interrogatory No. 9 in the present tense (2009), then permitted the jury to interpret it as a 2002 admission as well. Facebook's entire on-sale bar case is based upon this interrogatory. (Editorial: Hardly sufficient to meet the "heavy burden" of the clear and convincing evidence standard.)

After debunking all of Facebook's evidence on appeal, Judge Moore created new argument in the secrecy of chambers to support Facebook and prevent the on-sale bar verdict from being overturned—a clear breach of constitutional due process.



Judge Evan J. Wallach, U.S. Court of Appeals for the Federal Circuit, member of the three-judge panel in Leader Techs v. Facebook, Inc., 678 F.3d 1300 (Fed. Cir. 2012). Judge Wallach is not a patent attorney. This begs the question as to why a judge with no knowledge of patent law was assigned to the case. Would anyone ask a dentist to perform brain surgery? The Federal Circuit was specially formed to appoint patent-knowledgeable judges to patent cases. There is no evidence so far in the judicial disclosures that Judge Wallach holds stock in Facebook, although when he was asked on a motion to disclose potential Facebook holdings and other conflicts of interest, he refused along with the other judges. Donald Trump's election as U.S. president raises concern that Washington may increase the intrusiveness of domestic intelligence gathering, former U.S. spy agency contractor Edward Snowden said on Monday, warning that democratic checks and balances were losing ground to authoritarianism.

Snowden lives in Moscow under an asylum deal after he leaked classified information in 2013 that triggered an international furor over the reach of U.S. spy operations. He spoke at a teleconference hosted by Buenos Aires University's law school.

"We are starting to substitute open government for sheer authoritarianism, a government based not upon the principle of informed consent granted by people who understand its activities but rather a trust in personalities, a trust in claims, a trust in the hope that they will do the right thing," Snowden said.

He has contributed nearly \$300,000 to committees that supported Hillary Clinton for president, and his Facebook page is replete with photos he has taken with the former secretary of state and other top Democrats.

He’s given hundreds of thousands of dollars more to various Democratic politicians, and has visited the White House on several occasions. One of Guzel’s Facebook photographs shows him sitting in on a meeting with President Obama.

And writing under his title as chairman of the DNC's heritage council and as an officer with the National Democratic Ethnic Coordinating Council, Guzel endorsed Clinton in an op-ed published in The Hill on Nov. 2.

Salvadoran police and the country's General Prosecutor seized 20 computers. Authorities live-tweeted the action as officers invaded the law office.

The raid of Mossack Fonseca's El Salvador office was one of hundreds of official reactions to Panama Papers – a mix of investigations, fines, high-profile resignations, police raids, arrests, national legal reforms and international conclaves.

Government officials and activists expect the developments to continue for years to come as outrage fueled by Panama Papers revelations drives politicians and citizens alike to bring light to a shadowy financial system that, for decades, has resisted reform.

THE WASHINGTON POST late Friday night published an explosive story that, in many ways, is classic American journalism of the worst sort: The key claims are based exclusively on the unverified assertions of anonymous officials, who in turn are disseminating their own claims about what the CIA purportedly believes, all based on evidence that remains completely secret.

These unnamed sources told the Post that "the CIA has concluded in a secret assessment that Russia intervened in the 2016 election to help Donald Trump win the presidency, rather than just to undermine confidence in the U.S. electoral system." The anonymous officials also claim that "intelligence agencies have identified individuals with connections to the Russian government who provided WikiLeaks with thousands of hacked emails" from both the DNC and John Podesta's email account. Critically, none of the actual evidence for these claims is disclosed; indeed, the CIA's "secret assessment" itself remains concealed.

A second leak from last night, this one given to the New York Times, cites other anonymous

officials as asserting that “the Russians hacked the Republican National Committee’s computer systems in addition to their attacks on Democratic organizations, but did not release whatever information they gleaned from the Republican networks.” But that NYT story says that “it is also far from clear that Russia’s original intent was to support Mr. Trump, and many intelligence officials – and former officials in Mrs. Clinton’s campaign – believe that the primary motive of the Russians was to simply disrupt the campaign and undercut confidence in the integrity of the vote.”

Deep down in its article, the Post notes – rather critically – that “there were minor disagreements among intelligence officials about the agency’s assessment, in part because some questions remain unanswered.” Most importantly, the Post adds that “intelligence agencies do not have specific intelligence showing officials in the Kremlin ‘directing’ the identified individuals to pass the Democratic emails to WikiLeaks.” But the purpose of both anonymous leaks is to finger the Russian government for these hacks, acting with the motive to defeat Hillary Clinton.
