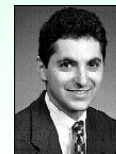

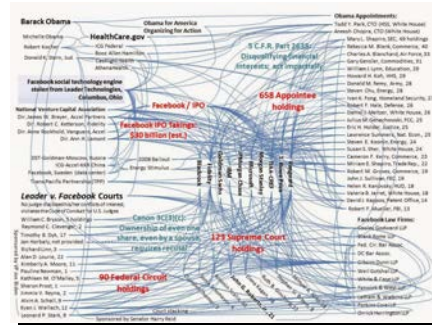

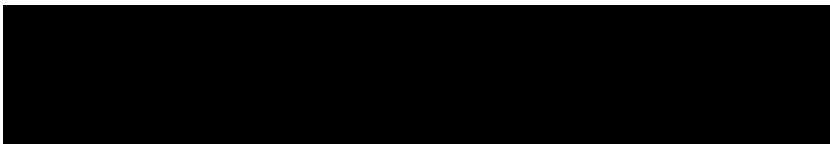
Fig. 3—Michael T. McKibben, Chairman & Founder, Leader Technologies, Inc., Columbus, Ohio, true inventor of social networking, including U.S. Patent No. 7,139,761. Proved in federal court that Facebook infringes his patent on 11 of 11 claims. After the trial, the judges protected Facebook without disclosing they ALL held Facebook financial interests and had deep relationships with Facebook's attorneys White & Case, Cooley Godward and Gibson Dunn.

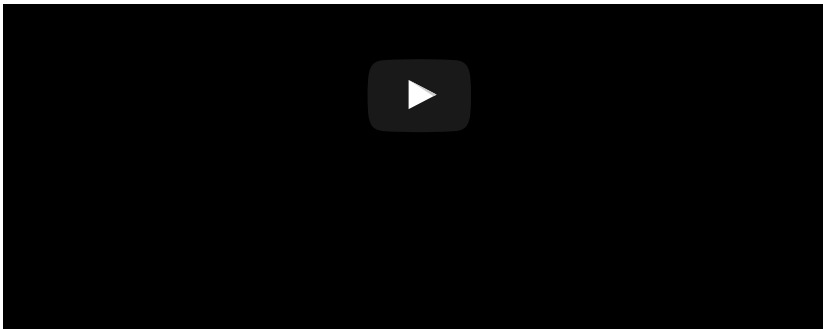


Fig. 4—<https://youtu.be/Ap74zO5D7dI> | [Raw *.mp4 video file](#)

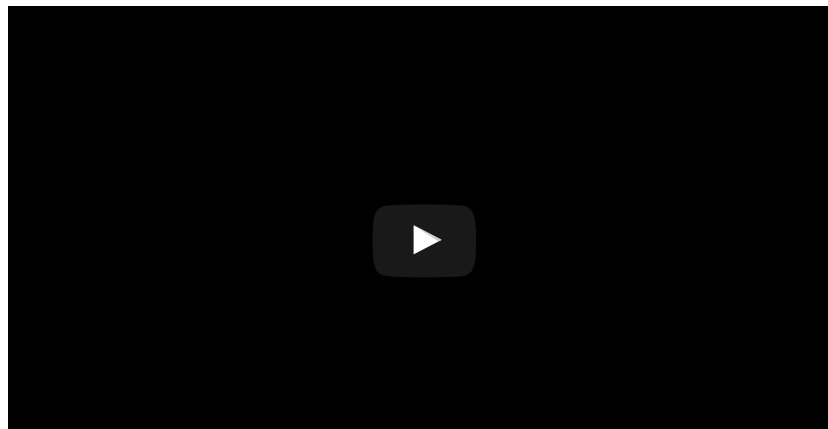


Fig. 5—Jesus Christ the Good Shepherd.

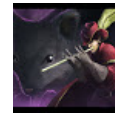

3. Corporate directors are legally liable, both civilly and criminally, if they make fraudulent certifications to shareholders and customers.

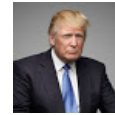

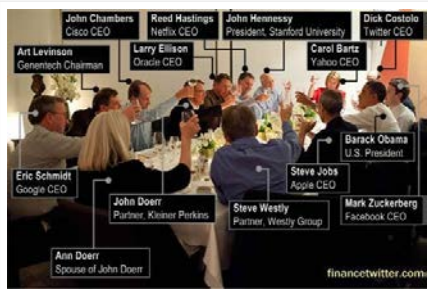


Fig. 8—[On Feb. 17, 2011](#), President Obama toasted their deception of the American public and the world with 13 members of the IBM Eclipse Foundation NSA Deep State shadow government in Silicon Valley. Conspirators pictured are Barack Obama (U.S. President), Mark Zuckerberg (Facebook CEO), Steve Jobs (Apple CEO), Steve Westly (Westly Group Partner), John Doerr (Kleiner Perkins Partner), Anil Doerr (John Doerr Spouse), Eric Schmidt (Google CEO), Art Levinson (Genentech Chairman), John Chambers (Cisco CEO), Larry Ellison (Oracle CEO), Reed Hastings (Netflix CEO), John Hennessy (Stanford Univ. President), Carol Bartz (Yahoo CEO) and Dick Costolo (Twitter CEO).

The judicial misconduct has deteriorated from there, replete with two of the three judges on the Federal Circuit appeal panel, Judges Alan D. Lourie and Kimberly A. Moore, holding Facebook stock that they did not disclose to the litigants, and later tried to excuse through a quick motion slipped in at the last minute by the Clerk of Court, Jan Horbaly, and his close friends at The Federal Circuit Bar Association. (The DC Bar subsequently revealed that Mr. Horbaly is not licensed to practice law in Washington D.C.)

The judges ignored [shocking new evidence](#) that Mark Zuckerberg withheld 28 hard drives of 2003-2004 evidence from Leader Technologies that could prove actual theft (and therefore claims even more serious than infringement). In addition, Facebook’s appeal attorney, Thomas G. Hungar of Gibson Dunn LLP, has close personal ties to just about every judicial player in this story. 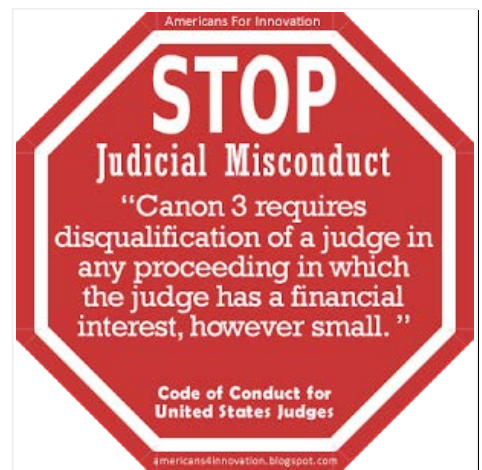

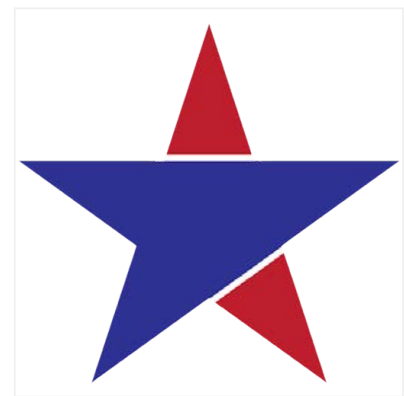

armed forces for the chemical attack, which choked scores of people to death in the town of Khan Sheikhoun in a rebel-held area of northern Syria hit by government air strikes. While Washington said it believed the deaths were caused by sarin nerve gas dropped by Syrian aircraft, Moscow offered an alternative explanation, claiming the poison gas had leaked from a rebel chemical weapons depot struck by Syrian bombs.

The strike, which was launched midday Tuesday, targeted a major rebel ammunition depot east of the town of Khan Sheikhoun, Russian Defense Ministry spokesman Major-General Igor Konashenkov said in a statement. The warehouse was used to both produce and store shells containing toxic gas, Konashenkov said. The shells were delivered to Iraq and repeatedly used there, he added, pointing out that both Iraq and international organizations have confirmed the use of such weapons by militants.

The same chemical munitions were used by militants in Aleppo, where Russian military experts took samples in late 2016, Konashenkov said. The Defense Ministry has confirmed this information as "fully objective and verified," Konashenkov added.

According to the statement, Khan Sheikhoun civilians, who recently suffered a chemical attack, displayed identical symptoms to those of Aleppo chemical attack victims.

Naturally, Syrian rebels disagreed: Hasan Haj Ali, rebel commander of the Free Idlib Army rebel group, and quoted by Reuters called the Russian statement a "lie".

The first large-scale attack of this type to become public did so when the FBI tried to shut down the Playpen child pornography website (after running it itself more efficiently for a couple of weeks in an effort to catch more people who visited the website).

prompted many defense lawyers to make the case that the FBI had no jurisdiction in the first place. Other judges in some of the Playpen cases agreed, but the whole warrant wasn't put into question until it reached Minnesota judge Franklin Noel.

"[T]he Government claims legal authority from this single warrant, issued in the Eastern District of Virginia, to hack thousands of computers in 120 countries and to install malicious software for the purpose of investigating and searching the private property of uncounted individuals whose identities and crimes were unknown to the Government before launching this massive worldwide search," said judge Franklin Noel.

Unknowing Violation?

Agent Macfarlane, who requested the warrant, feigned ignorance, implying that he wasn't aware that the FBI's NIT malware would go beyond its jurisdiction. Of course, that would mean he had no idea how Tor works in the first place. However, the whole idea of the Tor network is that it routes people's connections through multiple countries before reaching the final destination. This is what gives Tor users "anonymity." It's unlikely that a law enforcement agent who targets Tor users with techniques specifically designed to catch them wouldn't know how the tool works.

"I don't necessarily think that he destroyed my life," Jeff Simpson told the newspaper after describing years of molestation from age 13 on. "But I believe a lot of the problems I have stemmed from this."

Murray, a gay rights pioneer-turned-leading opponent of President Donald Trump's immigration policies, canceled a planned event after news of the lawsuit broke Thursday and held a brief news conference the next day.

The mayor, 61, took no questions, but dismissed the suit as accusations from a "troubled" man.

Past cyber attacks on scores of organizations around the world were conducted with top-secret hacking tools that were exposed recently by the Web publisher Wikileaks, the security researcher Symantec Corp (SYMC.O) said on Monday.

That means the attacks were likely conducted by the U.S. Central Intelligence Agency. The files posted by WikiLeaks appear to show internal CIA discussions of various tools for hacking into phones, computers and other electronic gear, along with programming code for some of them, and multiple people familiar with the matter have told Reuters that the documents came from the CIA or its contractors.

Symantec said it had connected at least 40 attacks in 16 countries to the tools obtained by WikiLeaks, though it followed company policy by not formally blaming the CIA.

The FBI gained approval from a secret federal court last summer to conduct communications surveillance against Carter Page, a former adviser to Donald Trump's presidential campaign, The Washington Post is reporting.

The revelation confirms for the first time that a federal surveillance warrant, known as a FISA warrant, was issued for a member of the Trump campaign as part of a federal investigation of potential ties between the Republican's associates and the Russian government.

In the application for the warrant, federal officials laid out what they said was evidence that there was probable cause showing that Page was acting as an agent of the Russian government, officials told The Post.

That evidence included contacts in 2013 with Russian spies who tried to recruit Page in New York City. The details of that recruitment attempt were laid out in a sealed FBI complaint filed in Jan. 2015. BuzzFeed News published the complaint earlier this month. Page denied that he was successfully recruited or that he shared any sensitive information with the agents.
