The agency wants to operate more like commercial companies, not the government, CIA CIO John Edwards said.

For the CIA, going commercial never felt so good.

John Edwards, who became the spy agency's top tech executive last year amid the intelligence community's seismic shift to cloud computing, said striking a deal with Amazon Web Services was the "best decision we ever made."

Speaking Wednesday at the AWS Public Sector Summit in Washington, D.C., Edwards gave a glimpse at unclassified advancements in how the 17 agencies of the intelligence community use the C2S cloud. Broadly, he said cloud computing at the CIA has led to improved security, upped mission impact and avoided costs with maintaining decades-old legacy systems.

"We want to be like commercial companies, not the government," Edwards said. "[Cloud] is the most innovative thing we've done, and it's having a material impact on the CIA and IC."

CIA SPIES ON YOU AT HOME THROUGH YOUR WIRELESS ROUTER

Today, June 15th 2017, WikiLeaks publishes documents from the CherryBlossom project of the CIA that was developed and implemented with the help of the US nonprofit Stanford Research Institute (SRI International).

CherryBlossom provides a means of monitoring the Internet activity of and performing software exploits on Targets of interest. In particular, CherryBlossom is focused on compromising wireless networking devices, such as wireless routers and access points (APs), to achieve these goals. Such Wi-Fi devices are commonly used as part of the Internet infrastructure in private homes, public spaces (bars, hotels or airports), small and medium sized companies as well as enterprise offices. Therefore these devices are the ideal spot for "Man-In-The-Middle" attacks, as they can easily monitor, control and manipulate the Internet traffic of connected users. By altering the data stream between the user and Internet services, the infected device can inject malicious content into the stream to exploit vulnerabilities in applications or the operating system on the computer of the targeted user.

The wireless device itself is compromised by implanting a customized CherryBlossom firmware on it; some devices allow upgrading their firmware over a wireless link, so no physical access to the device is necessary for a successful infection. Once the new firmware on the device is flashed, the router or access point will become a so-called FlyTrap. A FlyTrap will beacon over the Internet to a Command & Control server referred to as the CherryTree. The beacons information contains device status and security information that the CherryTree logs to a database. In response to this information, the CherryTree sends a Mission with operator-defined tasking. An operator can use CherryWeb, a browser-based user interface to view Flytrap status and security info, plan Mission tasking, view Mission-related data, and perform system administration tasks.

Missions may include tasking on Targets to monitor, actions/exploits to perform on a Target, and instructions on when and how to send the next beacon. Tasks for a Flytrap include (among others) the scan for email addresses, chat usernames, MAC addresses and VoIP numbers in passing network traffic to trigger additional actions, the copying of the full network traffic of a Target, the redirection of a Target's browser (e.g., to Windex for browser exploitation) or the proxying of a Target's network connections. FlyTrap can also setup VPN tunnels to a CherryBlossom-owned VPN server to give an operator access to clients on the Flytrap's WLAN/LAN for further exploitation. When the Flytrap detects a Target, it will send an Alert to the CherryTree and commence any actions/exploits against the Target. The CherryTree logs Alerts to a database, and, potentially distributes Alert information to interested parties (via Catapult).

The judges ignored [shocking new evidence](#) that Mark Zuckerberg withheld 28 hard drives of 2003-2004 evidence from Leader Technologies that could prove actual theft (and therefore claims even more serious than infringement). In addition, Facebook's appeal attorney, Thomas G. Hungar of Gibson Dunn LLP, has close personal ties to just about every judicial player in this story. The misconduct appears to reach into the U.S. Patent Office through abuse of the reexamination process by Facebook. We will stay focused on Leader v. Facebook until justice is served, but we also welcome news and analysis of intellectual property abuse in other cases as well.

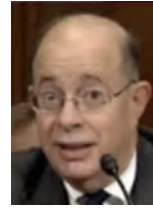

APPLE VALLEY, Minn. — WHEN President Obama nominated James B. Comey to lead the F.B.I., he lauded Mr. Comey as someone who understands the challenge of “striking a balance” between security and privacy, and had been “prepared to give up a job he loved rather than be part of something he felt was fundamentally wrong.”

High praise, but was it deserved? We may find out today, when the Senate Judiciary Committee holds a hearing on his confirmation.

Mr. Comey’s reputation for courage and probity rests largely on a dramatic episode in March 2004 when he and the current F.B.I. director, Robert S. Mueller III, tried to squelch the George W. Bush administration’s warrantless wiretapping program. But that was just one night in the 20 months that Mr. Comey served as deputy attorney general.

And while it was not the only time he expressed reservations, Mr. Comey apparently did eventually sign off on most of the worst of the Bush administration’s legal abuses and questionable interpretations of federal and international law. He ultimately approved the C.I.A.’s list of “enhanced interrogation” techniques, including waterboarding, which experts on international law consider a form of torture. He defended holding an American citizen, Jose Padilla, without charges for more than three years as an “enemy combatant,” and subjecting him to interrogation without counsel to obtain information from him. (Mr. Padilla was ultimately convicted of terrorism charges in civilian court.)

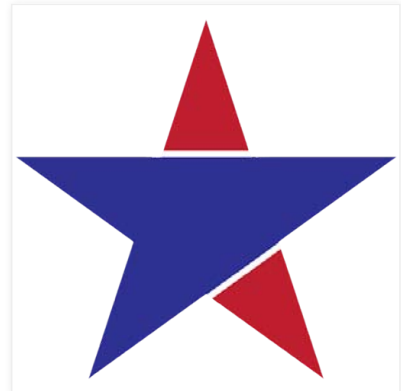

While the Republican National Committee was allegedly busy evading Russian hacking attempts during the campaign, one of the contractors tasked with running its big-data operation apparently stored some of its most-sensitive files on an unsecured Amazon server that could be accessed by anyone who stumbled across the URL. As the Hill reports, Deep Root Analytics left a database containing 24 terabytes of data, including information about 198 million potential voters, or virtually the entire eligible population. The data included sensitive, but publicly available, information like voters' addresses and phone numbers.

But more interesting than any personal information involved in the leak was the insight into Deep Root's "big data" modeling tactics. The data included probabilities for individual voters' positions on dozens of political issues, as well as estimates of how they voted in past elections. It also provided some insight into how big-data firms collaborate, as identifiers in the data suggest some of it was provided to Deep Root from TargetPoint and the Data Trust, two other big-data firms used by the Republicans.

The National Security Council cannot hand over records relating to former National Security Adviser Susan Rice's surveillance of Americans, because they have been moved to the Obama presidential library and may be sealed for as may as five years, conservative watchdog Judicial Watch announced Monday.

The NSC informed Judicial Watch in a letter dated May 23 that materials related to Rice's requests to know the identities of Americans swept up in surveillance of foreign targets, including any Trump campaign or transition officials, have been moved to the library.

The NSC's Director of Access Management John Powers said in the letter:

Documents from the Obama administration have been transferred to the Barack Obama Presidential Library. You may send your request to the Obama Library. However, you should be aware that under the Presidential Records Act, Presidential records remain closed to the public for five years after an administration has left office.

Judicial Watch earlier this year filed a Freedom of Information Act (FOIA) request for those documents, including of communications between Rice and any intelligence community member or agency regarding any Russian involvement in the 2016 elections, the hacking of Democratic National Committee computers, or any suspected communications between Russia and Trump officials.

Judicial Watch President Tom Fitton said the group will seek to find out when the records were moved, and warned of legal actions. He said:

Prosecutors, Congress, and the public will want to know when the National Security Council shipped off the records about potential intelligence abuses by the Susan Rice and others in the Obama White House to the memory hole of the Obama Presidential Library. We are considering our legal options but we hope that the Special Counsel and Congress also consider their options and get these records.

In April, blogger Mike Cernovich, Bloomberg, and Fox News revealed that Rice had requested to "unmask" — or unveil the hidden names of — Trump transition officials who were caught up in surveillance of foreign targets.

A serial killer is likely behind the murder of North Carolina Democratic National Committee staffer Seth Rich, according to forensic-psychology students and instructors, who spent three months investigating the homicide. Those researchers, who volunteer at the Profiling Project, an independent group, published their findings on Tuesday in an 83-page report.

The Profiling Project, based in Arlington, Virginia, consists of around 20 volunteers who are current and former George Washington University forensic-psychology graduate students and instructors. The report states that Rich's July 2016 "death does not appear to be a random homicide" or "a robbery gone bad," as police had suggested. Instead, the report says, the "death was more likely committed by a hired killer or serial murderer," and that the killer is likely still at large.

"The person folks [should be] looking for and considering isn't a robber who kills, but really is a killer, and maybe a killer that doesn't rob," says Kevin Doherty, a recent George Washington University graduate and one of the volunteers with the Profiling Project. "The fact that this person has gotten away with it shows a level of proficiency."

It isn’t the first controversy the McCain Institute has run into; Bloomberg reported last year that the Royal Embassy of Saudi Arabia had given a \$1 million donation to the institute. Saudi Arabia has been widely criticized for its poor human rights record.

A federal judge in Washington, D.C., has acted quickly in a case alleging fired FBI chief James Comey obstructed justice by burying an investigation into the mass surveillance of Americans by their government.

Brutal Kangaroo

Today, June 22nd 2017, WikiLeaks publishes documents from the Brutal Kangaroo project of the CIA. Brutal Kangaroo is a tool suite for Microsoft Windows that targets closed networks by air gap jumping using thumbdrives. Brutal Kangaroo components create a custom covert network within the target closed network and providing functionality for executing surveys, directory listings, and arbitrary executables.

The documents describe how a CIA operation can infiltrate a closed network (or a single air-gapped computer) within an organization or enterprise without direct access. It first infects a Internet-connected computer within the organization (referred to as "primary host") and installs the BrutalKangaroo malware on it. When a user is using the primary host and inserts a USB stick into it, the thumbdrive itself is infected with a separate malware. If this thumbdrive is used to copy data between the closed network and the LAN/WAN, the user will sooner or later plug the USB disk into a computer on the closed network. By browsing the USB drive with Windows Explorer on such a protected computer, it also gets infected with exfiltration/survey malware extracting data from your computers and sending it to a 'beacon' that collects the data in your 'dark profile' that is supported by Google, Facebook, WhatsApp, Instagram, Flickr, Tumblr, Twitter, Apple, Skype, Yahoo, Microsoft, AT&T, Verizon, T-Mobile, YouTube, etc.]. If multiple computers on the closed network are under CIA control, they form a covert network to coordinate tasks and data exchange. Although not explicitly stated in the documents, this method of compromising closed networks is very similar to how Stuxnet worked.

The Brutal Kangaroo project consists of the following components: Drifting Deadline is the thumbdrive infection tool, Shattered Assurance is a server tool that handles automated infection of thumbdrives (as the primary mode of propagation for the Brutal Kangaroo suite), Broken Promise is the Brutal Kangaroo postprocessor (to evaluate collected information) and Shadow is the primary persistence mechanism (a stage 2 tool that is distributed across a closed network and acts as a covert command-and-control network; once multiple Shadow instances are installed and share drives, tasking and payloads can be sent back-and-forth).

The primary execution vector used by infected thumbdrives is a vulnerability in the Microsoft Windows operating system that can be exploited by hand-crafted link files that load and execute programs (DLLs) without user interaction. Older versions of the tool suite used a mechanism called EZCheese that was a 0-day exploit until March 2015; newer versions seem use a similar, but yet unknown link file vulnerability (Lachesis/RiverJack) related to the library-ms functionality of the operating system.

According to the bureau, 66-year old James Hodgkinson acted alone in the mass assassination attempt, in what the FBI is describing as a "spontaneous" incident. The suspect spent three months before the attack living in a van just outside the Washington metro area, running out of money, and visiting tourist attractions in and around the nation's capital.

Prior to the mass shooting, Hodgkinson visited the senate office of democrat Bernie Sanders, whose failed presidential campaign the gunman had volunteered for. The FBI also said the shooter had been in contact with the offices of democratic senators Dick Durbin and Tammy Duckworth.

Western technology companies, including Cisco, IBM and SAP, are acceding to demands by Moscow for access to closely guarded product security secrets, at a time when Russia has been accused of a growing number of cyber attacks on the West, a Reuters investigation has found.

Russian authorities are asking Western tech companies to allow them to review source code for security products such as firewalls, anti-virus applications and software containing encryption before permitting the products to be imported and sold in the country. The requests, which have increased since 2014, are ostensibly done to ensure foreign spy agencies have not hidden any "backdoors" that would allow them to burrow into Russian systems.

But those inspections also provide the Russians an opportunity to find vulnerabilities in the products' source code - instructions that control the basic operations of computer equipment - current and former U.S. officials and security experts said.

Apparently, one of the covert programs Obama, the CIA, NSA and other intelligence groups eventually put together was a new kind of cyber operation that places remotely triggered "implants" in critical Russian networks, ready for the US to deploy in the event of a pre-emptive attack. The downed Russian networks "would cause them pain and discomfort," a former US official told The Post.

The report says CIA director John Brennan, Obama and other officials had at least four "blunt" conversations with Russian officials about its cyber intrusions beginning August 4th. Obama confronted Vladimir Putin in person during a meeting of world leaders in China this past September, the report says, and his administration even sent Russia a warning through a secure channel originally designed to help the two countries avoid a nuclear strike. Moscow apparently responded one week later -- after the US election -- denying the accusation.

In the recent video footage obtained by Project Veritas, John Bonifield a Sr. Producer at CNN, admits to several beliefs that are in direct conflict with the official CNN narrative that Trump has colluded with Russia, and that Russia has interfered with the 2016 election. Today, June 28th 2017, WikiLeaks publishes documents from the ELSA project of the CIA. ELSA is a geo-location malware for WiFi-enabled devices like laptops running the Microsoft Windows operating system. Once persistently installed on a target machine using separate CIA exploits, the malware scans visible WiFi access points and records the ESS identifier, MAC address and signal strength at regular intervals. To perform the data collection the target machine does not have to be online or connected to an access point; it only needs to be running with an enabled WiFi device. If it is connected to the internet, the malware automatically tries to use public geo-location databases from Google or Microsoft to resolve the position of the device and stores the longitude and latitude data along with the timestamp. The collected access point/geo-location information is stored in encrypted form on the device for later exfiltration. The malware itself does not beacon this data to a CIA back-end; instead the operator must actively retrieve the log file from the device - again using separate CIA exploits and backdoors.

The ELSA project allows the customization of the implant to match the target environment and operational objectives like sampling interval, maximum size of the logfile and invocation/persistence method. Additional back-end software (again using public geo-location databases from Google and Microsoft) converts unprocessed access point information from exfiltrated logfiles to geo-location data to create a tracking profile of the target device.
