INCOMPETENCE OR SEDITION?

The Ninth Circuit's job is to oversee the legal issues of a case. Therefore, their solemn duty was to evaluate the President's statutory claims in light of the statutes claimed, and therefore, to evaluate these specific LAWS. However, the Ninth Circuit Court did not evaluate even a single one of the President's statutes. This omission is either incompetence or sedition.

'Sedition' means 'incitement of resistance to or insurrection against lawful authority' (Merriam-Webster).


FEC documents confirm that the effort was to move all FEC data processing to the cloud and thus under the control of the IBM Eclipse Foundation established by IBM's chief inside counsel David J. 






FIG. 2: NSA BACKDOOR SPY KEY—AFI posted an expose of the nearly universal NSA backdoor key in Cisco, Microsoft, IBM, Juniper Networks, Qualcomm, Intel, Xerox, Micron Technology, Oracle, Nokia, Samsung, EMC, Apple, Dell, etc. software and hardware: [AFI \(Nov. 06, 2015\)](#). Complicit





We are an opinion blog that advocates for strong intellectual property rights. We welcome commenters and contributors. The Leader v. Facebook patent infringement case first came to our attention after learning that the trial judge, Leonard P. Stark, U.S. District Court of Delaware, ignored his jury's admission that they had no evidence to support their on-sale bar verdict, but the judge supported it anyway.

The judicial misconduct has deteriorated from there, replete with two of the three judges on the Federal Circuit appeal panel, Judges Alan D. Lourie and Kimberly A. Moore, holding Facebook stock that they did not disclose to the litigants, and later tried to excuse through a quick motion slipped in at the last minute by the Clerk of Court, Jan Horbaly, and his close friends at The Federal Circuit Bar Association. (The DC Bar subsequently revealed that Mr. Horbaly is not licensed to practice law in Washington D.C.)

The judges ignored [shocking new evidence](#) that Mark Zuckerberg withheld 28 hard drives of 2003-2004 evidence from Leader Technologies that could prove actual theft (and therefore claims even more serious than infringement). In addition, Facebook's appeal attorney, Thomas G. Hungar of Gibson Dunn LLP, has close personal ties to just about every judicial player in this story. The misconduct appears to reach into the U.S. Patent Office through abuse of the reexamination process by Facebook. We will stay focused on Leader v. Facebook until justice is served, but we also welcome news and analysis of intellectual property abuse in other cases as well.



Chiefs of staff for dozens of Democratic lawmakers who employed the four were informed last week that a criminal probe was underway into their use of congressional information technology systems, including the existence of an external server to which House data was being funneled, and into the theft of and overbilling for computer equipment.

Brothers Imran, Abid, and Jamal Awan and Hina Alvi, Imran's wife, each made \$160,000 a year as information technology workers for the House. Their salaries and time were shared among dozens of Democratic members, including former Democratic National Committee Chairman Rep. Debbie Wasserman Schultz of Florida. The lawmakers also include members of the House Permanent Select Committee on Intelligence and the House Committee on Foreign Affairs.

Despite the generous salaries, the four were involved in multiple suspicious mortgage transfers and a debt-evading bankruptcy. Abid had more than \$1 million in debts following a failed business called Cars International that he ran in Falls Church, Va., from November 2009 to September 2010. Business associates said in court documents that Abid had stolen money and vehicles from them.

It's unclear how Abid found time to run an automotive business while working full-time for Congress. He had been on the congressional payroll since 2005. A congressional credit union repossessed two of his personal cars before the business folded.



In a move that was not widely reported in the U.S., CIA Director Mike Pompeo last weekend gave Crown Prince Muhammed bin Nayef of Saudi Arabia the George Tenet medal in recognition of the prince's "excellent intelligence performance in the domain of counterterrorism and his unbound contribution to realize world security and peace."

While the U.K.'s Independent reports bin Nayef has worked to crack down on al-Qaida's operations in Saudi Arabia, the Arab kingdom has a checkered history of intermittent support for and opposition to terrorism.

Philip Haney, a retired Department of Homeland Security officer who specialized in Islamic theology and the strategy and tactics of the global Islamic movement, said the CIA had to overlook a remarkable amount of "derogatory information" to honor a Saudi leader for fighting terrorism.

"Since 9/11, the terms of our relationship with Saudi Arabia have been defined by the Saudis, not by the U.S.," Haney told WND. "To gain Saudi support in the 'War on Terror,' one of the first post-9/11 compromises America made with the Saudis was to redact the now-infamous '28 pages' from the 9/11 Commission Report, thus shielding and/or exonerating them from any involvement or responsibility.
