Facebook* patent infringement case first came to our attention after learning that the trial judge, Leonard P. Stark, U.S. District Court of Delaware, ignored his jury's admission that they had no evidence to support their on-sale bar verdict, but the judge supported it anyway.

The judicial misconduct has deteriorated from there, replete with two of the three judges on the Federal Circuit appeal panel, Judges Alan D. Lourie and Kimberly A. Moore, holding Facebook stock that they did not disclose to the litigants, and later tried to excuse through a quick motion slipped in at the last minute by the Clerk of Court, Jan Horbaly, and his close friends at The Federal Circuit Bar Association. (The DC Bar subsequently revealed that Mr. Horbaly is not licensed to practice law in Washington D.C.)

The judges ignored shocking new evidence that Mark Zuckerberg withheld 28 hard drives of 2003-2004 evidence from Leader Technologies that could prove actual theft (and therefore claims even more serious than infringement). In addition, Facebook's appeal attorney, Thomas G. Hungar of Gibson Dunn LLP, has close personal ties to just about every judicial player in this story. The misconduct appears to reach into the U.S. Patent Office through abuse of the reexamination process by Facebook. We will stay focused on Leader v. Facebook until justice is served, but we also welcome news and analysis of intellectual property abuse in other cases as well.

A snowshoe racer from India whose entry into the U.S. to compete was made possible by Senate Minority Leader Charles Schumer was being held Friday in a New York jail on a sex charge.

The U.S. embassy in New Delhi last month rejected Tanveer Hussain's application for a visa so he could compete in the World Snowshoe Championship in upstate. Local officials then intervened on Hussain's behalf, appealing for help to the offices of Schumer and Sen. Kirsten Gillibrand, D-N.Y. Their offices reached out to the New Delhi embassy, which allowed Hussain to reapply for a visa and granted that visa.

"Obviously, this is a troubling matter for him – these are troubling accusations," Brian Barrett, Hussain's lawyer, told Fox News over the phone. "He is in good spirits and he looks forward to fighting these charges."

Saranac Lake Police Chief Charles Potthast told Fox News that the charges, one of firstdegree sexual abuse, a felony, and another of endangering the welfare of a child, a misdemeanor, stem from Hussain "engaging in a passionate kiss" with a 12-year-old girl, and accusations of the athlete touching her over her clothing in an "intimate area."



Amid Thursday's over-hyped brouhaha about Jeff Sessions meeting with the Russian ambassador, a curious detail emerged. In Sessions's recusal memo, it was explained who at the Justice Department would be handling any investigations into the Trump campaign's alleged ties to Russia. "Consistent with the succession order for the Department of Justice, Acting Deputy Attorney General and U.S. Attorney for the Eastern District of Virginia Dana Boente shall act as and perform the functions of the Attorney General with respect to any matters from which I have recused myself to the extent they exist," reads Sessions's official statement on the matter.

Except that if the Obama administration had its way, Dana Boente wasn't supposed be the U.S. attorney to handle these matters in the event that Sessions recused himself. On February 10, USA Today reported the following:

Seven days before he left office, President Obama changed the order of succession without explanation to remove Boente from the list. Obama's order had listed U.S. attorneys in the District of Columbia, the Northern District of Illinois and the Central District of California.

That seems like awfully suspicious behavior. In fact the USA Today story noted this is pegged to the news that Trump quietly signed an executive order restoring Boente to the line of succession.
