For years Facebook has been successful at fooling an unsuspecting public who believed the movie **The Social Network**—that a 19-year old Harvard sophomore Mark Zuckerberg created Facebook all by himself in **“one to two weeks”** while he was drinking, chasing girls and studying for finals. 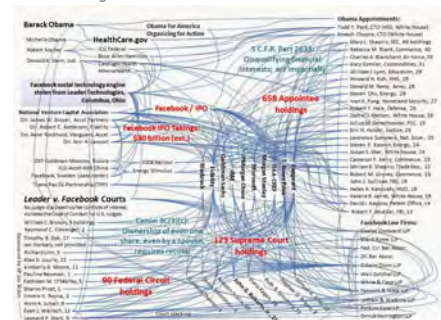

## CURRENT EDITORIAL FOCUS

We are an opinion blog that advocates for strong intellectual property rights. We welcome commenters and contributors. The Leader v. Facebook patent infringement case first came to our attention after learning that the trial judge, Leonard P. Stark, U.S. District Court of Delaware, ignored his jury's admission that they had no evidence to support their on-sale bar verdict, but the judge supported it anyway.

The judicial misconduct has deteriorated from there, replete with two of the three judges on the Federal Circuit appeal panel, Judges Alan D. Lourie and Kimberly A. Moore, holding Facebook stock that they did not disclose to the litigants, and later tried to excuse through a quick motion slipped in at the last minute by the Clerk of Court, Jan Horbaly, and his close friends at The Federal Circuit Bar Association. (The DC Bar subsequently revealed that Mr. Horbaly is not licensed to practice law in Washington D.C.)

The judges ignored [shocking new evidence](#) that Mark Zuckerberg withheld 28 hard drives of 2003-2004 evidence from Leader Technologies that could prove actual theft (and therefore claims even more serious than infringement). In addition, Facebook's appeal attorney, Thomas G. Hungar of Gibson Dunn LLP, has close personal ties to just about every judicial player in this story. The misconduct appears to reach into the U.S. Patent Office through abuse of the reexamination process by Facebook. We will stay focused on Leader v. Facebook until justice is served, but we also welcome news and analysis of intellectual property abuse in other cases as well.

After having disclosed information about CIA's spyware tool Athena only last week, WikiLeaks has published new information from Pandemic, another alleged CIA project that "targets remote users by replacing application code on-the-fly with a trojaned version if the program is retrieved from the infected machine."

Part of the Vault 7 series of documents that were either leaked following an inside job or stolen from the CIA by hackers, Pandemic basically turns Windows machines from a targeted network into Patient Zero. It then covertly infects other computers linked to the system by delivering infected versions of the requested files. Because it is very persistent, the original source of infection is difficult to detect.

Pandemic only takes 10 to 15 minutes to install and replaces up to 20 programs, according to a user manual, which doesn't thoroughly describe how it is actually installed on a targeted file server. The project allegedly dates from April 2014 to January 2015.

Since March, other CIA tools leaked in the Vault 7 series are AfterMidnight and Assassin, Archimedes, Scribbles, Grasshopper, Marble, Dark Matter, Weeping Angel and Year Zero.

Members of a congressional committee at a public hearing Wednesday blasted former President Barack Obama and his attorney general for allegedly covering up an investigation into the death of a Border Patrol agent killed as a result of a botched government gun-running project known as Operation Fast and Furious.

The House Oversight Committee also Wednesday released a scathing, nearly 300-page report that found Holder's Justice Department tried to hide the facts from the loved ones of slain Border Patrol Brian Terry - seeing his family as more of a "nuisance" than one deserving straight answers - and slamming Obama's assertion of executive privilege to deny Congress access to records pertaining to Fast and Furious.

"[Terry's death] happened on Dec. 14, 2010, and we still don't have all the answers," Rep. Jason Chaffetz, R-Utah, committee chairman, said of Terry's death. "Brian Terry's family should not have to wait six years for answers."

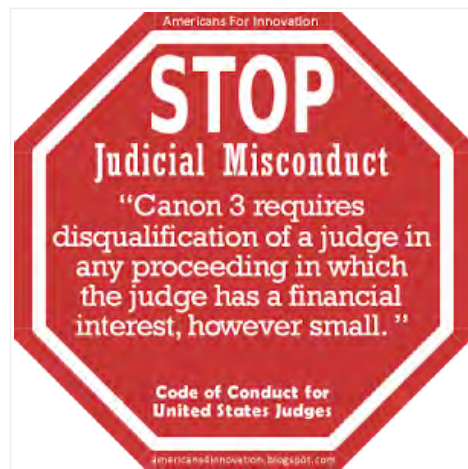

Just months before trial, Judge Stark allowed Facebook to add the on-sale bar claim after the close of all fact discovery and blocked Leader from preparing its defenses to this new claim. Judge Stark allowed the claims despite Leader's prophetic argument that the action would confuse the jury and prejudice Leader. He also permitted the jury to ignore the *Pfaff v. Wells Electronics, Inc.* test for on-sale bar, even after instructing the jury to use it. (See [that Jury Instruction No. 4.7 here](#).) He also contradicted his own instruction to Leader to answer Interrogatory No. 9 in the present tense (2009), then permitted the jury to interpret it as a 2002 admission as well. 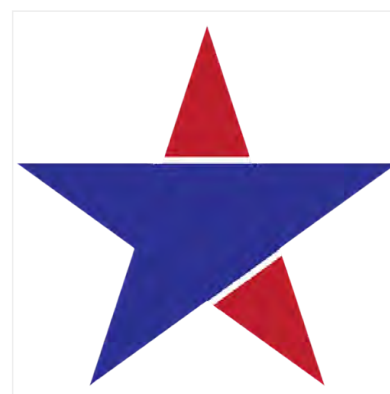

An Internet pedophile ring with up to 70,000 members — thought to be the world's largest — has been uncovered by police, a security official said Wednesday.

The European police agency Europol said in a statement that "Operation Rescue" had identified 670 suspects and that 230 abused children in 30 countries had been taken to safety. More children are expected to be found, Europol said.

It said that so far 184 people had been arrested and investigations in some countries were continuing. Most of those detained are suspected of direct involvement in sexually abusing children.

Comey testified during the hearing that there is an undisclosed reason that might've been behind the attorney general's recusal from the investigation into Russian election interference and possible collusion with the Trump campaign.

"We also were aware of facts that I can't discuss in an open setting that would make his continued engagement in a Russia-related investigation problematic," the former FBI director said.

The statement from the DOJ also pointed to testimony from Comey that he wasn't aware of "any kind of memorandum issued from the Attorney General or the Department of Justice to the FBI outlining the parameters of [the Attorney General's] recusal."

However, Sessions' chief of staff sent an email on March 2 to Comey and several other officials that said: "After careful consideration following meetings with career Department officials over the course of the past several weeks, the Attorney General has decided to recuse himself from any existing or future investigations of any matters related in any way to the campaigns for President of the United States. "

The email continued on to say that Sessions shouldn't be involved or briefed on those matters and that Acting Attorney General Dana Boente will perform the functions of the attorney general in those investigations.

In December 2015, nine months before the end of his presidency, Barack Obama signed the Paris Accord. The United States did not. Former FBI Director James Comey gave his highly anticipated testimony to the Senate Intelligence Committee Thursday, and while he never delivered the death blow to Donald Trump's presidency that liberals wanted so dearly, he very well could have implicated himself in a violation of the Espionage Act.

According to the Washington Examiner, Comey essentially admitted under oath that he had leaked to the media through a friend memos that documented his meetings with Trump since the 2016 election. "Didn't do it myself for a variety of reasons, but I asked him to, because I thought, that might prompt the appointment of the special counsel," he added.

That "friend" has since been identified by the Examiner as Columbia Law School professor Daniel C. Richman, who has touted himself as "an adviser" of Comey.

According to Breitbart, in response to Comey's testimony and surprising admission, Trump attorney Marc Kasowitz laid into the former director, pointing out that, "Mr. Comey has now admitted that he is one of these leakers."

"Today, Mr. Comey admitted that he unilaterally and surreptitiously made unauthorized disclosures to the press of privileged communications with the president," Kasowitz continued. "Today, Mr. Comey admitted that he leaked to friends of his, purported memos of those privileged conversations, one of which he testified, was classified."

"Mr. Comey also testified that immediately after he was terminated he authorized his friends to leak the contents of those memos to the press in order to, in Mr. Comey's words, 'prompt the appointment of a special counsel,'" said Kasowitz, adding that the admitted timing of the leak and media reports on the content of the memos meant that they appeared "to be entirely retaliatory."

While it remained unclear at this time what, if any, specific statute Comey may have violated in indirectly leaking his memos to the press, independent activist and journalist Jack Posobiec suggested he may have violated the Espionage Act.
