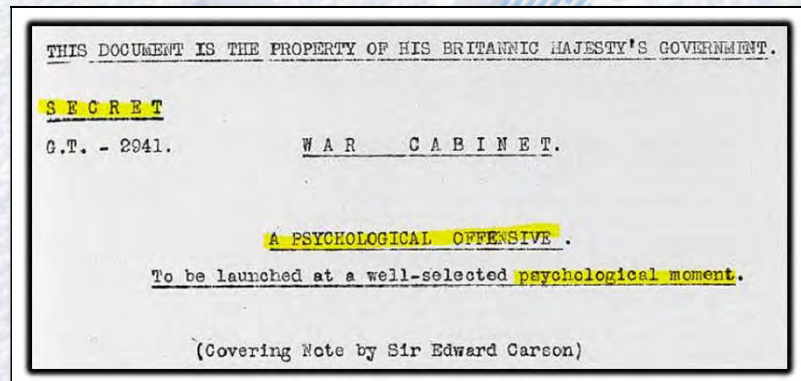

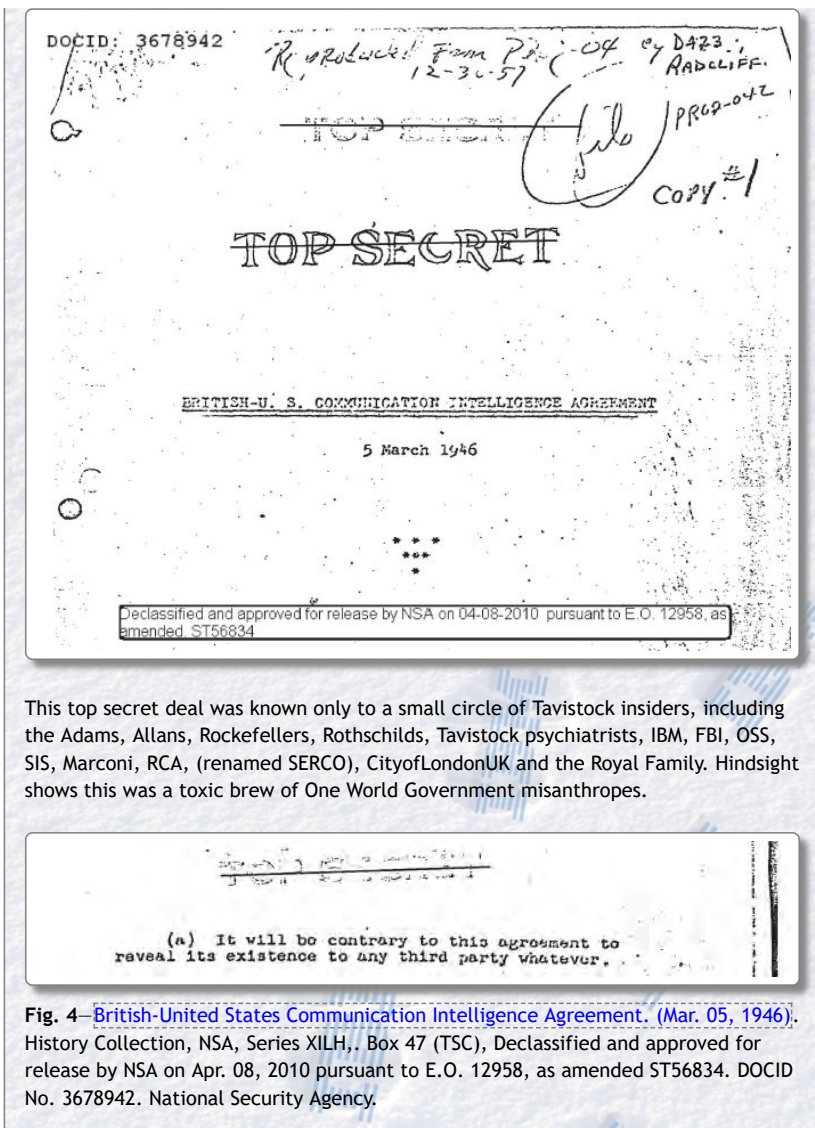

### CURRENT EDITORIAL FOCUS

We are an opinion blog that advocates for strong intellectual property rights. We welcome commenters and contributors. The *Leader v. Facebook* patent infringement case first came to our attention after learning that the trial judge, Leonard P. Stark, U.S. District Court of Delaware, ignored his jury's admission that they had no evidence to support their on-sale bar verdict, but the judge supported it anyway.

The judicial misconduct has deteriorated from there, replete with two of the three judges on the Federal Circuit appeal panel, Judges Alan D. Lourie and Kimberly A. Moore, holding Facebook stock that they did not disclose to the litigants, and later tried to excuse through a quick motion slipped in at the last minute by the Clerk of Court, Jan Horbaly, and his close friends at The Federal Circuit Bar Association. (The DC Bar subsequently revealed that Mr. Horbaly is not licensed to practice law in Washington D.C.)

The judges ignored [shocking new evidence](#) that Mark Zuckerberg withheld 28 hard drives of 2003-2004 evidence from *Leader Technologies* that could prove actual theft (and therefore claims even more serious than infringement). In addition, Facebook's appeal attorney, Thomas G. Hungar of Gibson Dunn LLP, has close personal ties to just about every judicial player in this story. The misconduct appears to reach into the U.S.

Forbes was director general of the British Council (1946-1954)—a leading post-war spy agency, chairman of the National Industrial Psychology (1947-1952), the Institute of Education at University of London (1948-1967), the Library Association (1949), the Institute of Adult Education (1949-1964), and **chairman of UNESCO (1957-1960)**. In short, Forbes, and grandpa FL Allan, spent their post-war careers spreading The Tavistock Institute's leftist, progressive, eugenics mind control model in education, industry and politics around the world.

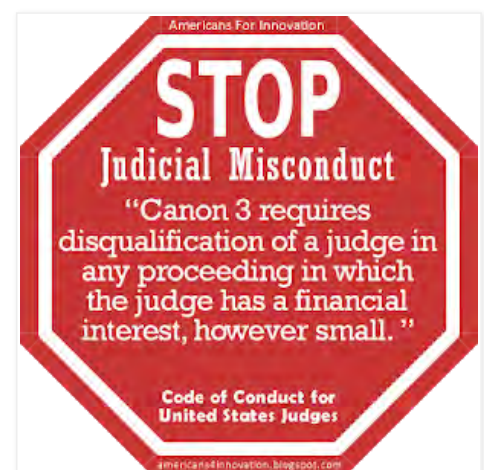

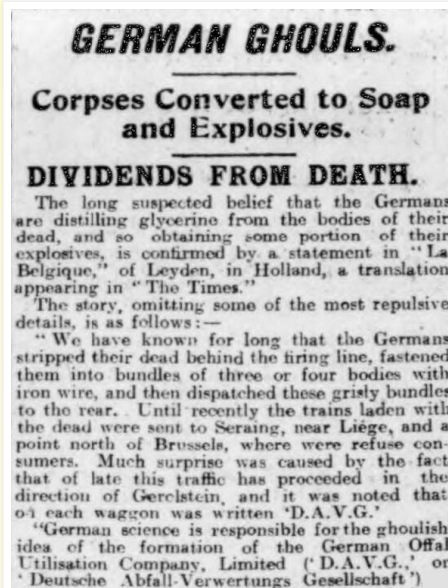


Fig. 3—[Editor. \(Apr. 18, 1917\)](#). German Ghouls - Corpses Converted to Soap and Explosives, Dividends from Death [The Wellington House War Propaganda Bureau, formed Aug. 1914, anti-German propaganda]. *Yorkshire/Sheffield Evening Telegraph and Star*. Incl. Transcript.

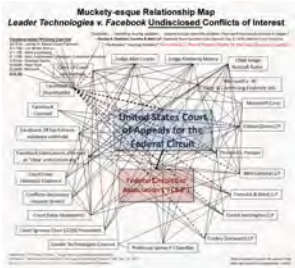

In an interview on MSNBC, Greg Gordon said that he and his McClatchy colleague, Peter Stone, did not physically see cell tower records and intelligence intercepts that they claim placed Cohen in Prague in summer 2016.

Gordon also suggested that the four anonymous sources he and Stone cite in their article also did not see the intelligence for themselves, meaning that the report is based on third-hand information.
