






Fig. 6—Andrew W. Marshall, responsible for more killing of souls in conflict, destruction of property, and government-sanctioned propaganda (lies to the citizenry) than any other human being on the planet since the 1970's.






Fig. 7—Editor. (Oct. 18, 1914). Famous British Authors Defend England's War. The New York Times. This article was published just six weeks after Sep. 05, 1914 when the Imperial War Cabinet ordered Charles F.G. Masterman (Cecil Rhodes' relative and Treasury official who negotiated the Marconi Wireless agreement with Parliament on Aug. 13, 2013, see above).

GLOBALIST NWO PATENT THEFT RING TIMELINE

Here is a timeline that focuses on the patent theft activities of the robber barons that continues to this very day, with largely the *same* players.

In 1900, GEC was incorporated as a public limited company in the UK, The General Electric Company (1900) Ltd (the '1900' was dropped three years later).

On Aug. 08, 1913, Parliament agreed to a 28-year monopoly contract (renewal in 1941) with Marconi Wireless, facilitated by Charles F.G. Masterman, a Cecil Rhodes relative and the founder of The Wellington House, British War Propaganda Bureau in Aug. 1914. See Fig. 4 above.

On Oct. 17, 1919, RCA was founded by General Electric (GE) after having purchased the American assets of Marconi Wireless (later ruled by the U.S. Supreme Court on Jun. 21, 1943 to have been stolen from Nikola Tesla).

GE founder was Thomas Edison where Tesla had worked in 1884. Notably, Edison and GE were heavily backed by robber barons JP Morgan and Vanderbilt. JP Morgan later pulled the financing from a Tesla



My dear Mr. President:

You have directed the Office of Alien Property Custodian to seize all patents controlled by the enemy, regardless of nominal ownership, and to make these patents freely available to American industry, first for war purposes of the United Nations, and second for general use in the national interest.

Today I can report satisfactory progress in this program. We have vested the bulk of the enemy patents and pending patent applications. We are now engaged in identifying and vesting the patents owned by nationals of enemy-occupied countries and the scattering enemy patents which require more detailed study. By December 31 of this year, every patent and patent application standing in the name of a national of an enemy or enemy-occupied country will have been vested, except for a few cases of disputed ownership requiring further investigation. We shall then control over 50,000 patents, representing some of the finest research achievements of modern science, particularly in the production of dyestuffs, plastics, pharmaceuticals, and electrical goods.

Facebook patent infringement case first came to our attention after learning that the trial judge, Leonard P. Stark, U.S. District Court of Delaware, ignored his jury's admission that they had no evidence to support their on-sale bar verdict, but the judge supported it anyway.

The judicial misconduct has deteriorated from there, replete with two of the three judges on the Federal Circuit appeal panel, Judges Alan D. Lourie and Kimberly A. Moore, holding Facebook stock that they did not disclose to the litigants, and later tried to excuse through a quick motion slipped in at the last minute by the Clerk of Court, Jan Horbaly, and his close friends at The Federal Circuit Bar Association. (The DC Bar subsequently revealed that Mr. Horbaly is not licensed to practice law in Washington D.C.)


The judges ignored shocking new evidence that Mark Zuckerberg withheld 28 hard drives of 2003-2004 evidence from Leader Technologies that could prove actual theft (and therefore claims even more serious than infringement). In addition, Facebook's appeal attorney, Thomas G. Hungar of Gibson Dunn LLP, has close personal ties to just about every judicial player in this story. The misconduct appears to reach into the U.S. Patent Office through abuse of the reexamination process by Facebook. We will stay focused on Leader v. Facebook until justice is served, but we also welcome news and analysis of intellectual property abuse in other cases as well.

Patents held by corporations supervised or controlled by the Alien Property Custodian

When the Alien Property Custodian vests or supervises corporations domiciled in the United States which have patent rights, a different patent and patent licensing policy will be followed by this Office. 






Fig. 9-Geoffrey E. Pattie.




Fig. 10-James P. Chandler, III.


