






Fig. 7—**UK Polygamy Propaganda** distributed to the UK Parliament on Nov. 22, 2018

London-based HSBC is the second largest bank in the world and has been a *major* [Clinton Foundation](#) donor. Like




Fig. 9—Lord Mark Malloch-Brown




Fig. 10—James B. Comey. Was a director for HSBC in London when Barack Obama nominated him to replace his mentor Robert S. Mueller, III as director of the FBI.






Fig. 16—[Deep State Target](#): *How I Got Caught in the Crosshairs of the Plot to Bring Down President Trump* by George Papadopoulos | Mar 26, 2019.





The complaint states that the arrangement may have been used to derive "illegal private benefit."

I've done quite a bit of reporting about how Wikipedia is definitely not "the encyclopedia anyone can edit." It's become a vehicle for special interests to control information. Agenda editors are able to prevent or revert edits and sourcing on selected issues and people in order to control the narrative.

My own battle with Wikipedia included being unable to correct provably false facts such as incorrect job history, incorrect birth place and incorrect birth date.

What's worse is that agenda editors related to pharmaceutical interests and the partisan blog Media Matters control my Wikipedia biographical page, making sure that slanted or false information stays on it. For example, they falsely refer to my reporting as "anti-vaccine," and imply my reporting on the topic has been discredited. In fact, my vaccine and medical reporting has been recognized by top national journalism awards organizations, and has even been cited as a source in a peer reviewed scientific publication. However, anyone who tries to edit this factual context and footnotes onto my page finds it is quickly removed.

What persists on my page, however, are sources that are supposedly disallowed by Wikipedia's policies. They include citations by Media Matters, with no disclosure that it's a partisan blog.

Trisha Anderson went back to work at Covington & Burling in 2018 [where former AG Eric H. Holder now works].

On Friday Redstate posted explosive segments from FBI Attorney Trisha Anderson's testimony. The information first appeared in the Washington Examiner.

In her testimony, she alleges that the application process for the FISA warrant was handled in an "unusual" fashion and that numerous Obama era FBI officials were involved at the highest levels in pushing it through.

But Anderson stressed "in this particular case, I'm drawing a distinction because my boss and my boss' boss had already reviewed and approved this application." She emphasized "this one was handled a little bit differently in that sense, in that it received very high-level review and approvals – informal, oral approvals – before it ever came to me for signature."

Normally, a FISA application would go to the legal department first to confirm that it is indeed proper to press forward with. In this case, top officials informally "approved" the application first, signaling to Anderson that her signature was just perfunctory.

Anderson said that FISA approvals are typically "tracked in a linear fashion" and that someone in the Senior Executive Service "is the final approver on hard copy before a FISA goes to the director or deputy director for signature." She said the Page FISA was approved outside regular procedures.

The White House would then prepare summaries of the subpoenaed conversations for investigators, which Stennis could authenticate by listening to the tapes themselves. The "Stennis compromise" was ridiculed by Timemagazine with a photo of the septuagenarian lawmaker cupping his ear, and the caption: "Technical Assistance Needed."

It wasn't just Stennis's infirmities, of course, that rendered Nixon's proposal laughable at the time; it was the suggestion that the president, by then identified as an actor in the Watergate saga, could be trusted to appoint the sole arbiter of the critical evidence in the case. Now, four decades later, John W. Dean III, a central figure in the Watergate saga, has arrogated the same authority to himself, with *The Nixon Defense: What He Knew and When He Knew It* (Viking, 784 pp).

Overcoming Our Nature

Throughout known history, humankind has struggled to comprehend the nature of the governor and the governed. A close inspection of history reveals the governor will, often, expand their sphere of control, while the governed would rather submit than resist. Mankind has searched for and struggled to build social structures that take these two natural tendencies into account.

Recently, in mankind's journey, the governed declared that the nature of the governor needed to be maintained. This was new and revolutionary thought - can the governed overcome their nature and keep the governor from naturally expanding control? Aimed at balancing these two natures, the result was the creation of an experimental social structure - a mixed republican form of government.

In modern times, we see the nature of both the governor and the governed creeping up like weeds in a poorly maintained garden. If the Declaration of Independence had been written from the perspective of the governor, what would it have said about the nature of the governed?

Declaration of Subjugation

When during the course of events it becomes necessary for governors to reunite the political bands that separated them and to assume among the powers of the government the control between them, a decent respect to the opinions of elected, appointed and employed governors requires that they should declare the causes which impel them to the combination.

We hold these unnatural truths to be self-evident that all natural born, juridical, artificial and legal persons are not created equal and are endowed by their natural born creators with certain alienable rights, that among these are the capability of having rights, being charged with duties, and engaging in any business or enterprise engaged in by a natural born person. That to secure these rights, governments already exist, deriving their powers from the consent of the governors—That, whenever any form of person becomes destructive of these ends it is the right of the governors to alter or abolish the person and institute new artificial persons, laying that legal person's foundation on such principles and organizing that person's powers in such form as to them shall most likely affect their power and control.

Prudence, indeed, will dictate that Governments long established should be changed for noble and greater good causes; and accordingly, all experience has shown, that governors are more disposed to act, while expanding control is actionable, than to wrong themselves by keeping the forms to which they are accustomed. But when a long train of freedoms and liberties, pursuing invariably the same Object evinces a design to reduce them under absolute Chaos, it is their right, it is their duty, to throw off such Government, and to provide new Guardians for their future controls.

Such has been the patient sufferance of these local, state and federal governors; and such is now the necessity which constrains them to alter the governed's former Systems of Government. The history of the present governed of the dis-United States is a history of repeated neglect and selfishness, all having in direct object the establishment of an absolute Chaos over the National Government. To prove this, let Facts be submitted to a candid world.

As an engineer, I can imaged an 1000MW MSR reactor in the middle east, say Jordan, using batch heat for sea water distillation, while using the same water to produce DME with the abundant waste gases from the oil fields. One MSR plant, would totally rewrite their geopolitical position regarding the other middle east countries and Israel. Jordan could send 'surplus' water to Israel and earn 'currency' along with DME as fuel....all with one plant.

Given this technology, and synergies available by close coupling batch heat processes, it is entirely possible to begin to rewrite the global wealth for humanity, into the next 1,000 years...for humanity, not a powerful and corrupt elite.
