


Fig. 3-Henry A. Kissinger




Fig. 4–David Rockefeller. Chairman, Chase Manhattan Bank (now J.P. Morgan Chase); Henry Kissinger Pilgrims Society mentor.




Fig. 6-David Sarnoff



We are an opinion blog that advocates for strong intellectual property rights. We welcome commenters and contributors. The *Leader v. Facebook* patent infringement case first came to our attention after learning that the trial judge, Leonard P. Stark, U.S. District Court of Delaware, ignored his jury's admission that they had no evidence to support their on-sale bar verdict, but the judge supported it anyway.

The judicial misconduct has deteriorated from there, replete with two of the three judges on the Federal Circuit appeal panel, Judges Alan D. Lourie and Kimberly A. Moore, holding Facebook stock that they did not disclose to the litigants, and later tried to excuse through a quick motion slipped in at the last minute by the Clerk of Court, Jan Horbaly, and his close friends at The Federal Circuit Bar Association. (The DC Bar subsequently revealed that Mr. Horbaly is not licensed to practice law in Washington D.C.)

The judges ignored shocking new evidence that Mark Zuckerberg withheld 28 hard drives of 2003-2004 evidence from Leader Technologies that could prove actual theft (and therefore claims even more serious than infringement). In addition, Facebook's appeal attorney, Thomas G. Hungar of Gibson Dunn LLP, has close personal ties to just about every judicial player in this story. The misconduct appears to reach into the U.S. Patent Office through abuse of the reexamination process by Facebook. We will stay focused on Leader v. Facebook until justice is served, but we also welcome news and analysis of intellectual property abuse in other cases as well.

One participant of note was Paul A. Volcker, then Undersecretary of the Treasury (1969-74) and later chairman of the Federal Reserve (1979-87).

Curiously, the State Department historian goes out of his way, even now, to say that Henry Kissinger was not in these Camp David meetings.




Fig. 13—Paul Adolph Volcker, Jr. Princeton undergraduate (1949); M.A. Harvard (1950); Rotary Scholar at the London School of Economics (1951-52); Member of the Pilgrims Society (ca. 1951); Under Secretary for International Affairs (1969-1974); President of the Federal Reserve Bank of New York (1975-79); Member of the Federal Reserve Board of Governors (1979-1987); Chairman of the Federal Reserve (1979-1987); Vice President of the Pilgrims Society of the United States, aka William J. Donovan Memorial Foundation (2007-2008); Chairman of the President's Economic Recovery Advisory Board (2009-2011).





Fig. 17—<u>Henry A. Kissinger. (Dec. 12, 1973)</u>. PHOTO 1: U.S. Secretary of State delivers major oil crisis speech to the Pilgrims Society at the London Europa Hotel. AP Wirephoto. For educational purposes only. Fair Use relied upon.




Fig. 24-Elihu Root


