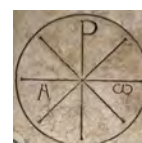

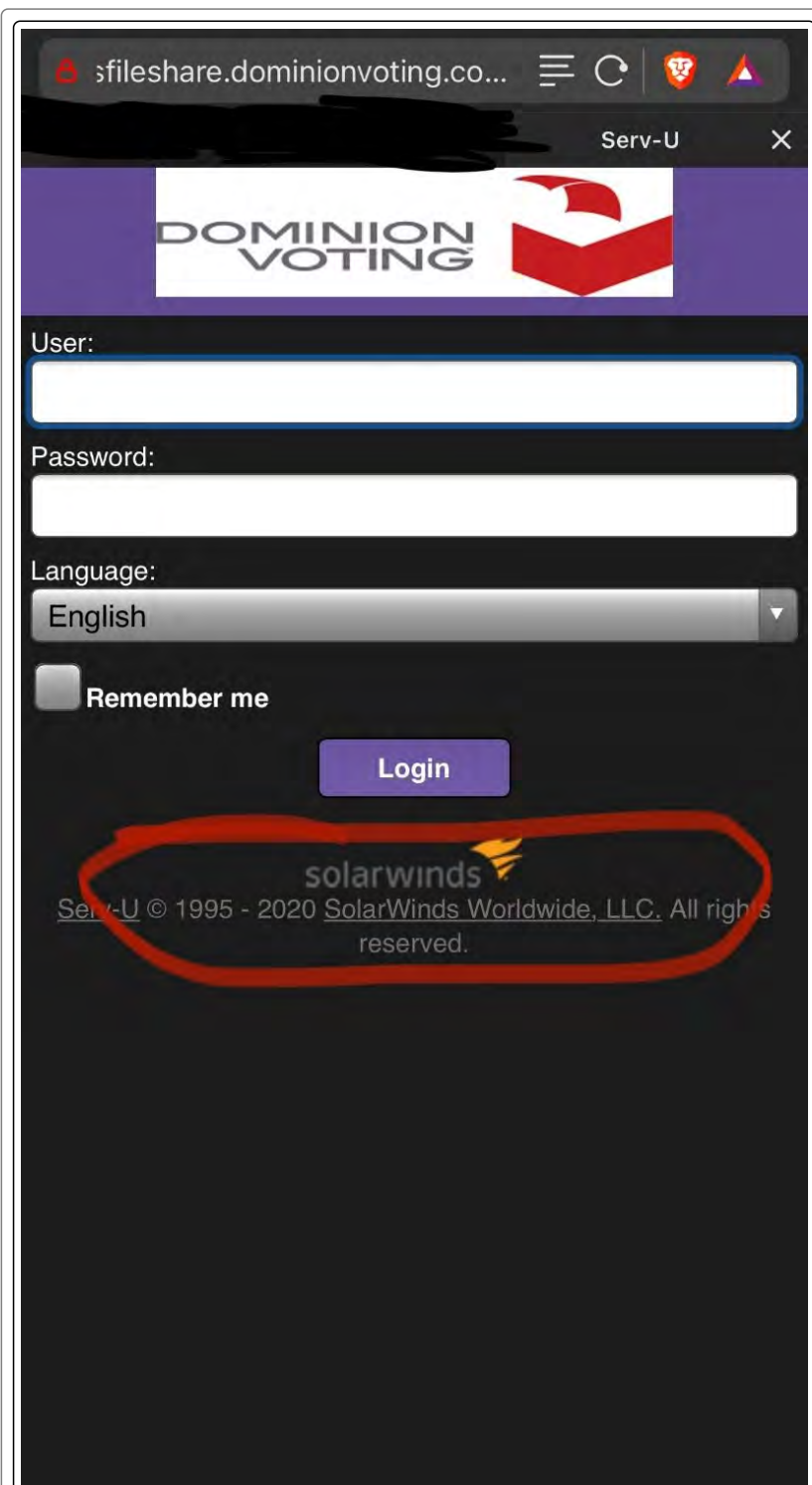


Fig. 2—Bogus Dominion Voting login screen that began circulating over the weekend of Dec. 12, 2020.

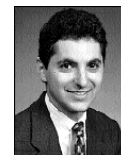

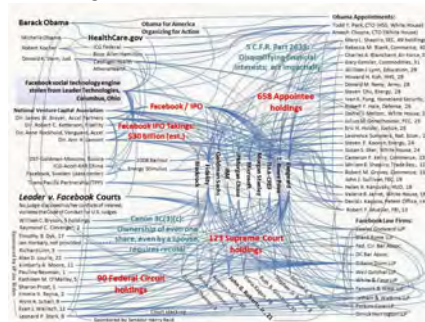

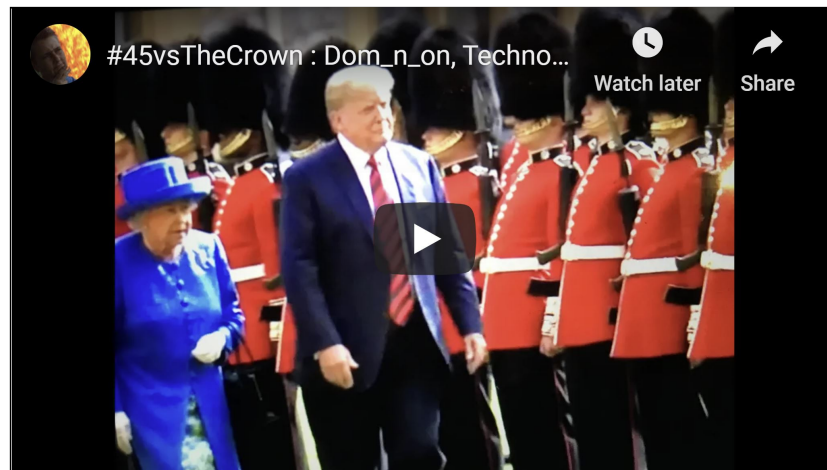


Fig. 12—Free. (Dec. 09, 2020). Our Republic is fighting the same battle now as we did 245 years ago! You Are Free TV. <https://youtu.be/Lu6nsMHZAdI> | (Raw *.mp4 video file).
