




Fig. 5—Nancy P. Pelosi (CA 12th) political donations for the 2020 election cycle. [Open Secrets.org](#). See also [Nancy P. Pelosi \(CA 12th\). \(May 15, 2019\)](#). 2018 Financial Disclosure OGE Form 278, Filing ID #10026982. Office of Government Ethics.

The Blackstone Group is headquartered at 345 Park Avenue in Manhattan, with eight additional offices in the United States, as well as




Fig. 6—Stephen A. Schwarzman. Founder, chairman, The Blackstone Group (one of the largest private equity investors in the world); Chairman, Schwarzman Scholars for Chinese students (agents) studying in America and China; British MI6/C.I.A. asset. See Fig. 7 below to see Schwarzman's mug shot with Xi Jinping, Chinese Communist Party Boss and his fellow conspirators below.





preparing its defenses to this new claim. Judge Stark allowed the claims despite Leader's prophetic argument that the action would confuse the jury and prejudice Leader. 


Fig. 12—Free. (Dec. 09, 2020). Our Republic is fighting the same battle now as we did 245 years ago! *You Are Free TV*. <https://youtu.be/Lu6nsMHZAdI> | (Raw \*.mp4 video file).
