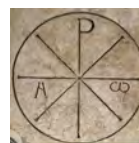

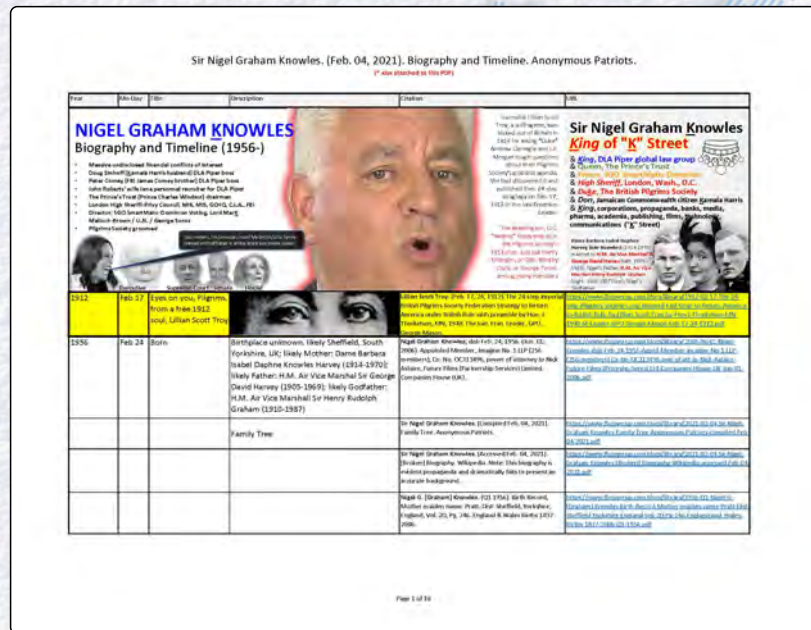


Fig. 3—Sir Nigel Graham Knowles. (Compiled Feb. 09, 2021). Biography and Timeline. Anonymous Patriots.

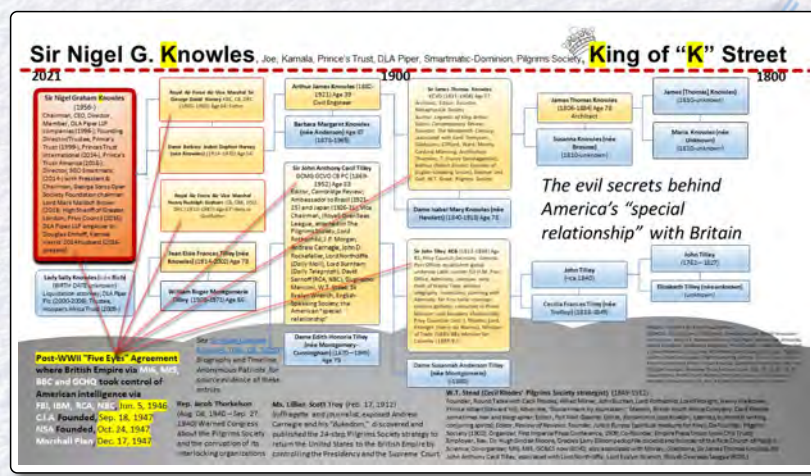


Fig. 4—Sir Nigel Graham Knowles. (Feb. 04, 2021). Family Tree. Anonymous Patriots.

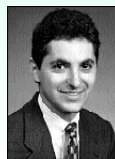

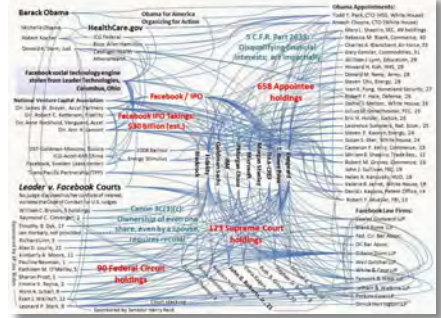

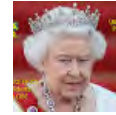

Facebook* patent infringement case first came to our attention after learning that the trial judge, Leonard P. 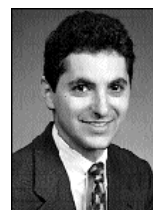

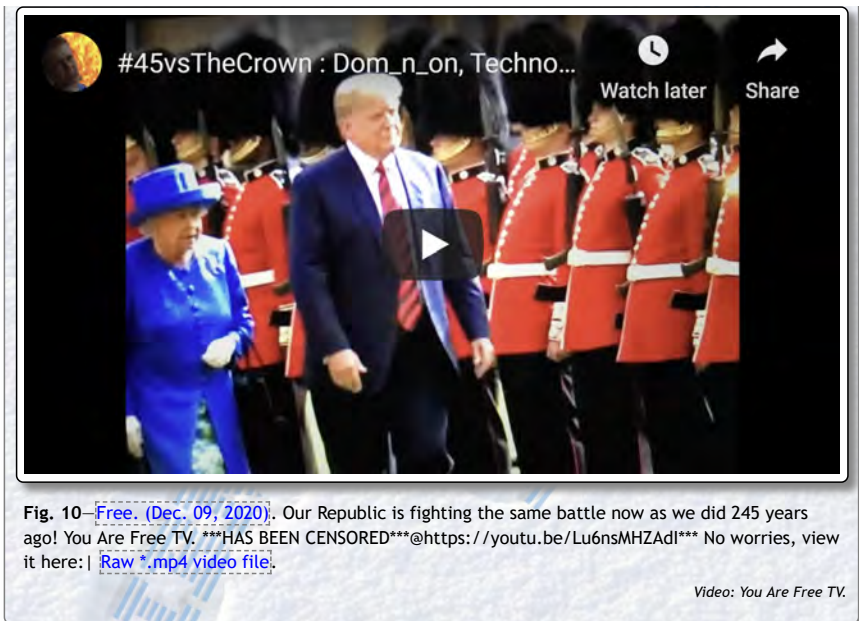


Fig. 10—Free. (Dec. 09, 2020). Our Republic is fighting the same battle now as we did 245 years ago! You Are Free TV. \*\*\*HAS BEEN CENSORED\*\*\*@https://youtu.be/Lu6nsMHZAdl\*\*\* No worries, view it here: | [Raw \\*.mp4 video file.](#)
