


Fig. 1—Dr. Anthony Stephen Fauci. Anthony Fauci buries a bizarre Abys family crest glorifying satanism, eating children and profiting from the effort.







Facebook until justice is served, but we also welcome news and analysis of intellectual property abuse in other cases as well.








Fig. 14—The First Amended Miller Act Notice. Click here to download the PDF (check your Downloads folder after clicking).




