Moore was latter tried and convicted for pedophilia, founded the First Church of Psycho-Science in Oakland, CA and was married at least four times.

Under Stead considerable influence, The Salvation Army became the chief promoter of the so-called "social gospel," also called commun-ism, fascism and liberation theology. As best we can tell, up until that time (1890) the Salvation Army staff appear to have been enthusiastic street preachers, even if their leader Booth, a former pawn broker, was milking their sincerity for profit.

The misconduct appears to reach into the U.S. Patent Office through abuse of the reexamination process by Facebook. We will stay focused on Leader v. Facebook until justice is served, but we also welcome news and analysis of intellectual property abuse in other cases as well.
