






Fig. 7—William Manning. Major British West Indies human trafficker. Bank of England director (1790-1810), deputy governor (1810-1812) and governor (1812-1814). In 1817-1830 he was president of the London Assurance Company formerly led by governor John Barker for 34 years.




Fig. 8—John Barker Church aka John Carter.

Despite Church's British secrets (aka the British spy John Carter), within three weeks

Leader v. Facebook patent infringement case first came to our attention after learning that the trial judge, Leonard P. Stark, U.S. District Court of Delaware, ignored his jury's admission that they had no evidence to support their on-sale bar verdict, but the judge supported it anyway.

The judicial misconduct has deteriorated from there, replete with two of the three judges on the Federal Circuit appeal panel, Judges Alan D. Lourie and Kimberly A. In addition, Facebook's appeal attorney, Thomas G. Hungar of Gibson Dunn LLP, has close personal ties to just about every judicial player in this story. The misconduct appears to reach into the U.S. Patent Office through abuse of the reexamination process by Facebook. We will stay focused on Leader v. Facebook until justice is served, but we also welcome news and analysis of intellectual property abuse in other cases as well.





Fig. 9—Gen. Philip John Schuyler (b. Nov. 20, 1733, d. Nov. 18, 1804). American General in the Revolution War, Senator from New York. Father of Elizabeth Schuyler, wife of Alexander Hamilton and father of Angelica Schuyler, wife of John Barker Church.








Fig. 11, 12—Nicholas Murray Butler. Longtime President of both Columbia University and the British Pilgrims Society (1928-1946).





Fig. 15—Benjamin Vaughan. British MP who emigrated to America with £100,000 (£12.8 million in 2022—\$16 million) to invest in Hamilton's new First Bank of the United States along with Henry Cruger and John Barker Chuch. See below!






Fig. 18—John Barker Church. Uncle John Carter was 24-year governor of the Crown monopoly London Assurance Company; supplied the Continental and French armies and became one of the wealthiest men in America at the end of the Revolution; investor and director of all four of Hamilton's banks.




Fig. 19—General Sir George Beckwith, British Spy handler of Alexander Hamilton, Gen. Philip Schuyler, William Samuel Johnson (Columbia), Col. Humphreys and John Barker Carter.

A lowly figure beside the august Morris, Hamilton wanted to establish his intellectual bona fides with the new superintendent of finance. Before writing to him, Hamilton brushed up on money matters and had Colonel Timothy Pickering send him some primers: David Hume's Political Discourses, tracts written by the English clergyman and polemicist Richard Price, and his all-purpose crib, Postlethwayt's Universal Dictionary of Trade and Commerce. On April 30, 1781, Hamilton sent a marathon letter to Morris—it runs to thirty-one printed pages—that set forth a full-fledged system for shoring up American credit and creating a national bank. Portions of this interminable letter exist in Eliza's handwriting (complete with her faulty spelling), as if Hamilton's hand ached and he had to pass the pen to his bride at intervals. Hamilton started out sheepishly enough: "I pretend not to be an able financier. . . . Neither have I had leisure or materials to make accurate calculations."8 Then he delivered a virtuoso performance as he asserted the need for financial reforms to complete the Revolution. "'Tis by introducing order into our finances—by restoring public credit—not by gaining battles that we are finally to gain our object."9






Fig. 24—The First Amended Miller Act Notice. Click here to download the PDF (check your Downloads folder after clicking). See also, Complaint against Judge Leonard P. Stark's fraud against his own court in Leader v. Facebook and 2,400 other patent cases.
