

TRANSCRIPTION:

SPIRIT CRAFT TOOLS FIND WAY TO JURY In a unique session of a San Francisco police court, Judge J. J. Sullivan presiding, the court and corridors thronged with interested Oakland spectators, Hugh Robert Moore, alias St. Clair, king of the bay city clairvoyants, pastor of the Psycho-Science Church of Oakland and teacher in a spiritualistic class at 1208 McAllister street, was placed on trial on a charge of petty larceny by trick and device last night. The jury refused to come to an agreement as to his guilt and innocence, and a date for a new trial will be set by Judge Sullivan today.

Surrounded by four attorneys, of whom H. W. Brunk of Oakland was the chief, Sinclair sat unmoved while his luminous forehead blade, stars and crosses, his spirit horn, lamp and slate examined by an interested jury in an amateur manifestation conducted by Assistant District Attorney Munrell and Detectives Richards and Burke, who raided the parlor October 18.

AMONG THE VOICES. The first witness, Miss Stella Sheridan of Alameda, testified to the payment of 50 cents, which, by the way, was a marked 50-cent piece furnished by the officers and which was later found upon Sinclair, and told of the voice of "Dr. Holliday," Sinclair's pet spirit, and the voice from the spirit trumpet, which was created by means of a rubber tube which Sinclair had in the sleeve of his robe.

Then there was the Indian, "Lightfoot," who told of his happy hunting ground. Then there was Pansey, otherwise the little boy, Carl Hoffman, of Oakland, "who talked philosophically and with wonderful logic for a child."

RAID AT CRITICAL TIME. There was the raid upon these two adepts in psycho-science just as Samuel Greer of Vancouver, B. C., had been brought to a point where he believed and might have invested; and which he testified "last night he would not, after what he had been shown.

Sinclair has a former record, serving four years in San Quentin from Oakland for grand larceny, prior to which he traveled about the world as a literary to the late William Stead, English journalist, who went down on the Titanic.
