Mr. Schulhof joined Sony in 1968 and rose to senior management in 1979. In 1989, he was named to Sony's Board of Directors, becoming the first American on the Board of a major Japanese corporation. He is credited with transforming Sony's US operations into a global entertainment company. During his 25 years at Sony, Mr. Schulhof had responsibility for: (i) Sony Electronics; (ii) Sony Software Corporation including Columbia/Tristar Pictures, Inc., CBS Records, as well as the electronic publishing, and signatures divisions; and (iii) Sony Retail Entertainment including theaters and location-based entertainment centers across the United States.

Mr. Schulhof serves on the boards of several companies and charitable organizations including ColdWatt, J2Com, the Brookings Institution, the Center on Addiction and Substance Abuse at Columbia Unviersity, the American Hospital of Paris Foundation, and New York University Medical Center. He is also a member of the Council on Foreign Relations.

A native of New York, Mr. Schulhof is a solid-state physicist with 27 published papers and one patent to his credit. He received a B.A. from Grinnell College, a M.A. from Cornell University, a Ph.D. from Brandeis University, and the Chevalier de la Legion D'Honneur by the French Republic.

Schulhof resigns Sony U.S. post CEO led Japanese giant's purchase of movie studios that brought huge losses

Michael P. Schulhof, the head of Sony Corp.'s American operations, resigned under pressure yesterday, apparently unable to inspire confidence in Sony's Japanese management that he was doing enough to revive the company's businesses in the United States.

Mr. Schulhof's resignation as president and chief executive of the Sony Corporation of America unit came almost exactly 12 months after Sony, which is based in Tokyo, took a \$2.7 billion write-off to account for losses in its Hollywood film business.

Since then, the film division has had a mixed record and Sony's other major American entertainment holding, its music business, has lost market share.

Meanwhile, some other new ventures under Mr. Schulhof, including an electronic-publishing business, have suffered relatively large losses.

In the 1980s Sony was among the first foreign companies to make big acquisitions of American entertainment operations -- CBS Records for \$2 billion in 1987 and Columbia Pictures for \$3.4 billion in 1989.

But yesterday, Sony took the unusual step of replacing the head of its American business with Japanese executives who will run the company from Tokyo.

Sony's chairman and chief executive, Norio Ohga, who played key roles in acquiring and initially overseeing the American entertainment properties, will add to his titles those of chairman for the Sony Music and <u>Sony Pictures</u> <u>Entertainment</u> units.

Nobuyuki Idei, Sony's president, will add the titles of vice chairman of Sony of America and chairman of its Sony Electronics unit.

Sony gave no explanation yesterday for Mr. Schulhof's resignation. But several people close to the company said the lackluster performance of the American operations in the last year, coupled with Mr. Schulhof's propensity for heavy corporate spending and his own extravagant standard of living, grated on executives in Tokyo, where the economic downturn has forced austerity on Japanese companies.

Mr. Ohga and Mr. Schulhof have been colleagues for years, but Mr. Idei, who became Sony's president only last April, is said to be highly critical of Mr. Schulhof's spending habits and informal management style.

Sony executives declined to comment on Mr. Schulhof's resignation, issuing a brief release thanking him for his contributions to the company and explaining only that he was leaving to "pursue new business interests."

Mr. Schulhof, who had worked at Sony for 21 years and was the company's highest-ranking American executive, also declined to comment.

Some industry executives speculated yesterday that Sony had forced Mr. Schulhof out in a show of fiscal and management discipline intended to attract an entertainment-industry partner to invest in the American business.

There also was conjecture that an American executive would soon be found to run the U.S. business. But several executives close to Sony denied that finding a partner or hiring a new manager were imminent moves.

Mr. Schulhof was a vice chairman of Sony's American operations when the company acquired the music business in 1987.

He ascended in the corporate hierarchy as the Japanese company pursued a strategy of expanding in the American entertainment business. He became president and chief executive in 1993.




Fig. 2—EUGEN WILHELM SCHWAB (b. Apr. 27, 1899, d. 1982); managing director, Escher-Wyss & Cie. (Co.) ca, 1936-1982; vp and pres., Ravensburg Chamber of Commerce; member, Ravensburg Rotary; National Socialist Model Company; Kaiser, Nazi (heavy water), aparteid South Africa, British, U.S. nuclear program supplier and sanctions buster using Marc Rich





Fig. 5-The Holy Lance of Antioch (click here for a full timeline PDF) coveted but never found by Adolf Hitler, passed through Ravensburg, Germany twice, once in ca. 1148 on its way to Alvira of Castile, the first grail queen, then again ca. Sep. 1271 for safekeeping from the French government and Pope to the Knights Templar consistory in Vienna, sent there by another grail queen-Joan, Countess of Toulouse.

In his just-published propaganda *Stakeholder Capitalism* (Wiley, NY: 2021), Klaus wrote on the dedication page that his mother was Erika Epprecht ("To my parents, Eugen Wilhelm Schwab and Erika Epprecht who taught me firsthand the value of education, collaboration, and the stakeholder principle"). This is a boldface lie.

The judicial misconduct has deteriorated from there, replete with two of the three judges on the Federal Circuit appeal panel, Judges Alan D. Lourie and Kimberly A. Moore, holding Facebook stock that they did not disclose to the litigants, and later tried to excuse through a quick motion slipped in at the last minute by the Clerk of Court, Jan Horbaly, and his close friends at The Federal Circuit Bar Association. (The DC Bar subsequently revealed that Mr. Horbaly is not licensed to practice law in Washington D.C.)

The judges ignored shocking new evidence that Mark Zuckerberg withheld 28 hard drives of 2003-2004 evidence from Leader Technologies that could prove actual theft (and therefore claims even more serious than infringement). In addition, Facebook's appeal attorney, Thomas G. Hungar of Gibson Dunn LLP, has close personal ties to just about every judicial player in this story. KLAUS'S BIRTH MOTHER WAS JEWESS EMMA GISELA TEKELIUS SCHWAB (NÉE KILIAN)

Klaus and his older brother, Hans Ernst, were born to Eugen Wilhelm Schwab and Emma Gisela Tekelius Schwab (née Kilian) in Ravensburg (Mar. 30, 1938) and Karlsruhe (Oct. 13, 1927) respectively.

Hans Ernst Schwab did not disown their Jewish ("Hebrew") mother Emma like his brother Klaus has. On Dec. 09, 1938, Emma Schwab emigrated to the United States as Gisela Schwab, leaving her suckling infant Klaus, presumably forever. Was she fleeing Hitler's Jewish persecution? Very possible. Was Klaus' 50% Jewish blood being buried and replaced by a pure Aryan persona? More probably, especially considering his and his father's life-long silence about her and their involvement in the top secret Nazi nuclear program.

The argument that Emma Schwab abandoned infant Klaus to flee Jewish persecution rings hollow since infant Klaus was a "Mischiling," a Nazi perjorative for half-breed, mongrel, hybrid. A normal mother would have taken Klaus with her to get her baby out of harm's way too.

By contrast, Eugen's next wife Erika was of sturdy Aryan stock—acceptable to the Nazis. She was from Zurich, born Dec. 31, 1906, and like Vladimir Lenin, Erika lived just a tenminute taxi ride from the Escher-Wyss turbine manufacturing campus in Zurich, according to the 1935 city directory.

Klaus' pretend-mother, Erika, worked in personnel recruiting in Zurich. Ravensburg registry officials were unhelpful with birth, marriage and divorce records for Eugen Wilhelm Schwab, so no records of a divorce from Emma or remarriage to Erika were discovered. Polygamy cannot be ruled out.

However, we do see Eugen and Erika traveling to Brazil in 1960, presumably to visit Hans Ernst and Escher-Wyss that Hans managed. Escher-Wyss, now Sulzer AG and Andritz AG,

EUGEN W. SCHWAB WAS A NUCLEAR-HAWKING RAVENSBURG CITY FATHER

Klaus' father, Eugen Wilhelm Schwab, was the managing director of Escher-Wyss & Co. in 1938 when Klaus was born in Ravensburg, Germany, and continued with the company as President emeritus until his death in 1982.

Escher-Wyss was founded in 1805, and developed unique engineering, manufacturing and high-strength materials capabilities focused on gas turbines, compressors, power generation, heat pumps, hydraulics, ships, thermal and hydroelectric power, and related automation controls.

Klaus has hidden Escher-Wyss Nazi sins his entire career. They are only now emerging. A few other researchers seem to have unearthed this evidence just recently as well. Much of it has been suppressed behind *top secret* archives in Switzerland, Germany, Britain and the United States—only recently released after 90+ years of suppression.

First, at the time of Klaus' birth in 1938, Escher-Wyss had already been helping the German government build compressors, turbines and other critical elements for an emerging nuclear industry (since 1929). Klaus received a bachelor and PhD in engineering from Swiss Federal Institute of Technology, ETH Zürich, Switzerland, cofounded by Alfred Escher (1855).

Klaus also received overlapping masters and PhD degrees from the Jesuit University of Fribourg, Switzerland (1962-67). These Jesuits boast numerous Pilgrims Society globalists like British Zionist Chaim Azriel Weizmann; Basil Hume, archbishop of Canterbury; and, Juan Carlos, King of Spain.






Fig. 4—Adolf Hitler ca. 1912 at about the time he first saw the Spear of Destiny in the Habsburg treasury in Vienna.




Fig. 6-<u>[The Holy Lance of Antioch. (Mar. 19, 2018)</u>. Timeline compiled by Michael T. McKibben. Americans for Innovation.

The judicial misconduct has deteriorated from there, replete with two of the three judges on the Federal Circuit appeal panel, Judges Alan D. Lourie and Kimberly A. Moore, holding Facebook stock that they did not disclose to the litigants, and later tried to excuse through a quick motion slipped in at the last minute by the Clerk of Court, Jan Horbaly, and his close friends at The Federal Circuit Bar Association. (The DC Bar subsequently revealed that Mr. Horbaly is not licensed to practice law in Washington D.C.)

The judges ignored shocking new evidence that Mark Zuckerberg withheld 28 hard drives of 2003-2004 evidence from Leader Technologies that could prove actual theft (and therefore claims even more serious than infringement). In addition, Facebook's appeal attorney, Thomas G. Hungar of Gibson Dunn LLP, has close personal ties to just about every judicial player in this story. The misconduct appears to reach into the U.S. Patent Office through abuse of the reexamination process by Facebook. We will stay focused on *Leader v. Facebook* until
