12 [OPENING REMARKS]

13
14 I want to make it very clear in the beginning, I'm not
15 anti-government, I don't believe in terrorism, and I want to
16 make it especially clear that there are a lot of good people in
17 the FBI, and in the CIA, Naval Intelligence, Army Intelligence,
18 Military Intelligence, NSA.

19 Unfortunately, there are a few key people in key
20 positions who have made a difference, a big difference, in
21 what's happening in America today. [States later: "rouge
22 outfit," "rogue criminal enterprise operating within the
23 confines of the US government" and "covert military criminal
24 enterprise, government enterprise, primarily by US military
25 intelligence, that is operating full throttle and everybody
26 refuses to investigate it."]

27
28 [PERSONAL WORK HISTORY]

29
30 So, looking back on my personal experiences, I retired
31 from the FBI in March 1979. At that time, I was in charge of the

1 FBI Los Angeles Division. I had more than 700 personnel under my
2 command.

3 The Attorney General of the United States, Griffin
4 Bell, asked me, after I retired, if I'd coordinate security for
5 the Pan-American Games. I did.

6 I was a consultant in the 1984 Los Angeles Olympics. I
7 was a consultant for former governor Jerry Brown to the
8 California Narcotic Authority.

9 So I do have credentials and credibility, believe me.

10

11 [DETRACTORS STEW WEBB AND BARBARA HARTWELL]

12 [CIA MIND CONTROL PROGRAM - MKULTRA]

13

14 If you read the Internet you may not think so.
15 Because, there are some heavy-duty FBI informants out there,
16 like Stew Webb and Barbara Hartwell, who are MKULTRA mind-
17 controlled victims, CIA mind control victims, who are making all
18 kinds of disparaging remarks about me. But, I don't deal with
19 those people. Because, if you read their material, you'll see
20 that it's designed to discredit people like me, former state
21 senator John [W.] De Camp, and other leaders who are trying our
22 best to expose what's happening in America today, and actually
23 around the world.

24

25 [1776]

26 [JOHANN ADAM WEISHAAPT]

27 [ROTHSCHILD FAMILY]

28 [ILLUMINATI]

29

30 Let's go back to 1776, May 1st. [Johann] Adam Weishaupt
31 was commissioned by the Rothschild family to set up the goals to

1 control and take over the world with a one-world government.

2 Weishaupt came up with 25 goals.

3 Among these goals were:

- 4 • control the press,
- 5 • corrupt the youth through sex and drugs,
- 6 • elect our own people, our own people meaning the
- 7 Illuminati, to key positions in all levels of the
- 8 government: city, county, state and federal.
- 9 • And, it goes on.
- 10 • The final goal was to take over the world
- 11 [through] the one world government.

12 [This] information is very well documented by [William
13 Guy] Carr in his magazine, his book, excuse me, *Pawns in the*
14 *Game* [1958].

15 When I retired [from 27 years with the FBI], I had no
16 idea what was going on, I had no idea about the Illuminati, I
17 had no idea about [Johann] Adam Weishaupt.

18

19 [DR. JEFFREY R. MACDONALD CASE]

20

21 However, my first major investigation when I returned
22 from Puerto Rico was a [personal] debt to the Dr. Jeffrey R.
23 MacDonald case. He's a former Green Beret doctor who was
24 convicted of murdering his wife and two children at Fort Bragg
25 [on] February 17, 1970.

26 He'd been tried and convicted, and sentenced to three
27 consecutive life sentences. I was asked by the defense team to
28 investigate the case because they claimed that Dr. MacDonald was
29 innocent. I said I would, but if I learned that he murdered his
30 wife and two children, I would discontinue my investigation and
31 no longer become involved. I want you to know I'm still working
32 for Dr. MacDonald. [Light applause]

1 He is an innocent man. Now, once I became involved in
2 the case, I had to read everything. I learned that evidence was
3 lost, evidence was stolen, evidence was altered.

4 An FBI Agent, Paul Stombaugh, lied before the Grand
5 Jury. And, most important of all, Colette [MacDonald], the wife,
6 had skin where she had fought off the assailants under her
7 fingernails.

8 That skin was handed over to William F. Ivory, the
9 chief investigator for the Army, and it has disappeared. Ten
10 months into the case, October 25, 1980, I, through a series of
11 circumstances [that] I don't have time to go into the details
12 now, obtained a signed confession from one Helena Stoeckley. I
13 had three sessions with her, ten days each for a total of thirty
14 days.

15
16 [SATANIC CULTS]

17 [DRUG SMUGGLING AND DISTRIBUTION]

18
19 Helena told me that Dr. MacDonald did not commit those
20 crimes; that they were committed by her satanic cult group. And,
21 I said to myself, what's this all about? I don't know anything
22 about Satanism. I read about in the Bible, of course, and it's
23 about it. But, as I delved into the case, I learned that drugs
24 from Southeast Asia were being flown into the United States to
25 various military bases in plastic bags [stuffed] in the bodies
26 of the dead GIs.

27 I further learned from Helena that her satanic cult
28 group was involved in distributing these drugs up and down the
29 East Coast.

30 They were mad at Dr. MacDonald because he was abusive
31 to the cults, cult members, and [mad at] the GIs who went to the
32 civilian hospital where he was moonlighting, for relief of some

1 sort. They went in and attacked him that night. There were [a]
2 total of seven involved in the crime. She named them all for me.

3 Right now today, I know where some of them are
4 located, but [to] further check and document this, I went to the
5 UCLA library and I found out, in fact, in the *Time* magazine,
6 January 1, 1973, there was an article about bringing drugs in
7 plastic bag [stuffed in the] body cavities of dead GIs. There
8 was no question in my mind that Helena was telling the truth.

9 I gave her a polygraph test and she passed.

10 I had her examined by psychiatrists and she passed.

11 And as a matter of fact, the government themselves had
12 given her a polygraph examination early in their investigation,
13 before I entered the case. And, CID [Army's Criminal
14 Investigative Division], the army polygraph operator, said that
15 she thought that she was telling the truth, she thought she was
16 there that night.

17 Now, the most recent series of events in the MacDonald
18 case, now I'm telling you a little bit about the MacDonald case
19 because that's what woke me up as to what was going on. It was
20 after that that I started researching and went back and found
21 out about the Illuminati, Illuminati / Satanism.

22 It was after that that I learned considerable more
23 about what was going on, and the most recent information . . .
24 Dr. MacDonald, who has been in the penitentiary for some 25 or
25 26 years now, appeared before a parole board just two days ago
26 [May 10, 2005].

27 His first that he's ever appeared before, a parole
28 board, and the reason he had never appeared before is because,
29 in his opinion, had he appeared before it would be an admission
30 of guilt.

31 In this particular instance he still claimed he was
32 innocent, but he did appear before the board, because [he was] a

1 newly-wed individual with a woman named Kathy, and of course, if
2 you read the papers in the last two days, his parole was turned
3 down. The parole board made him eligible for another hearing in
4 15 years. This poor man not only lost his wife and two children,
5 he has served 25 years in the penitentiary, and another 16 years
6 to go.

7 I am still working the case. What are the latest
8 developments on the case?

9

10 [MISSING DNA EVIDENCE]

11

12 In 1997, the judge, federal judge, agreed to do a DNA
13 test, and they chose 15 individual pieces of evidence to be
14 examined. However, the judge said that when you open the
15 evidence envelopes only the prosecutor can be present. Well,
16 they opened the evidence, the prosecutor did. How many do you
17 think were empty? Five (5) evidence envelopes were empty. The
18 skin under Colette's fingernails would have established Dr.
19 MacDonald's innocence alone. Now we have DNA authorized 1997.
20 Here we are in 2005, they still have not completed the DNA test
21 from the MacDonald case.

22

23 [MCMARTIN PRESCHOOL CASE]

24 [CHILD TRAFFICKING]

25 [RITUAL CHILD SACRIFICES]

26

27 The next case I worked of a major consequence was the
28 McMartin Preschool Case in Manhattan Beach, California. The
29 children there claimed there were tunnels under the school.

30 They were taken into the tunnels, and through the
31 tunnels, up into the trap door of a bathroom in a triplex next
32 door, placed in automobiles, and prostituted in the community.

1 These are two, three and four-year old children before they had
2 entered kindergarten.

3 In addition, the children claimed that they were flown
4 into the mountains where they were involved with adults in
5 robes, black robes, chanting candles.

6 They talked about the brown babies who were cut up,
7 actually sacrificed. And, in checking into this, and researching
8 this, of course, this was obviously a satanic ceremony.

9 The McMartin family, who owned the preschool, they
10 were tried - Ray Buckey and his grandmother. The grandmother was
11 acquitted, [there was a] hung jury on Ray Buckey. [At] the
12 second trial, another hung jury.

13 I had an opportunity in to gain control of the school.
14 Now the school had been given to Danny Davis, the defense
15 attorney, and he had sold it, even though he made 15 million
16 dollars on the case by the way, he had sold it to a contractor
17 who was going to tear it down.

18 When I learned this [that the school had been sold] I
19 contacted the contractor. I said I want to be given an
20 opportunity to go on that school and look for the tunnels. The
21 authorities had looked for them in 1987. They said they could
22 find no tunnels.

23 Along with some of the parents, we hired Dr. [E.] Gary
24 Stickel, [a] UCLA archeologist. He hired his crew and brought
25 them in. And, in 34 days Dr. Stickel said there had been tunnels
26 under that school, they were covered up, and they were covered
27 in.

28 An informant of mine told me that there was an
29 abandoned satanic site in Crestline, California, up in the
30 mountains. I went up into the mountains and obtain copies,
31 photocopies, photographs excuse me, of the site.

1 I have a lecture that I give where these pictures are
2 available, it's called Gunderson Chronicles No. 2. It's a four-
3 hour lecture that I gave in Kansas City a number of years ago
4 which shows this abandoned site and also pictures from the
5 McMartin tunnels school day.

6

7 [THE FRANKLIN COVER-UP CASE]

8 [CHILD TRAFFICKING]

9 [SEX AND DRUG ORGIES AMONG THE RICH AND POWERFUL]

10 [NEBRASKA STATE SENATOR JOHN W. DE CAMP ASSISTANCE]

11

12 From there, I became involved in another case, very
13 frightening case, because I established, with the help of people
14 like John [W.] De Camp, former state senator from Nebraska, that
15 we have in this country today a covert military criminal
16 enterprise, government enterprise, primarily by US military
17 intelligence, that is operating full throttle and everybody
18 refuses to investigate it.

19 In the Nebraska case, it's called the "Franklin Cover-
20 up," [holding up a book] this is the book here that I and John
21 [W.] De Camp wrote by the way, it's all documented in there.

22 And, in that particular instance [The Franklin Cover-
23 u-up] they were taking children out of foster homes, orphanages,
24 Boy's Town, driving them from Omaha, Nebraska to Sioux City,
25 Iowa 184 miles away, placing them in private jets, and flying
26 them to Washington, D.C. for sex orgies with prominent people,
27 including congressmen, senators, and, certain people in the
28 White House. It's well documented.

29

30 [PAUL BONACCI]

31

1 I have personally talked to Paul Bonacci. I had a
2 five-hour interview with him. There's a tape available, I don't
3 have it with me here, but you can order it. I have a five-hour
4 interview with Paul that I gave, that he gave me, in 1993.

5 Paul told me how he was used, he was part of the
6 kidnapping crew, and was used as a decoy. When he was ten,
7 eleven and twelve years old, in parks, shopping malls, to
8 attract the children over near where the adults were in a car
9 waiting for them. They'd throw them in the backseat, chloroform
10 them, and make off with them.

11 Paul also told me that these children, many of them
12 become sex slaves, many of them are used as toys. The boys, they
13 call the boys toys, I don't know what they call the girls, but
14 these degenerate, sick people, the men are more interested in
15 the little boys than the girls for some reason. But, it's all
16 well documented.

17

18 [WHITE HOUSE]

19 [INVESTIGATOR GARY CARADORI PLANE CRASH]

20

21 Paul drew the inside living quarters of the White
22 House. Now this information broke in about 1987, that's about
23 right after I entered, just before I entered the case.

24 I replaced the fellow named Gary Caradori, who was the
25 investigator for a Nebraska Senate committee. Gary met the
26 official photographer of the [child kidnapping ring] group, who
27 had split from the group, defected, and agreed to take the
28 pictures that this official photographer gave him in [garbled]
29 Chicago. [He] agreed to take the pictures back to the committee.

30 He flew out of Chicago in his private plane short
31 period, a short distance, out of Chicago, the plane exploded in

1 midair and his briefcase has never been found. He and his eight
2 year-old son [R.J.] died. His briefcase has never been found.

3 The rear seat of the airplane has never been found. I
4 made every attempt possible to obtain possession of, or control
5 of, that plane because I wanted to examine it for bomb
6 chemicals, particularly the [vaccine?], it's not a long it's no
7 longer available. Nobody knows what happened to it.

8 Gary Caradori was a civilian, yet it was taken to a
9 military base for examination. A deputy sheriff was the first
10 one on the scene. He saw the pictures, he started picking up the
11 pictures.

12 An FBI agent came along, took the pictures away from
13 him, [and] told him to keep his mouth shut.

14 He started talking to a few people a year later, his
15 wife was murdered. He's no longer talking.

16

17 [THE FINDERS]

18 [WASHINGTON, D.C.]

19 [WITCHITA, KANSAS]

20

21 This international child kidnapping ring, I later
22 learned, was out of Washington, D.C. It was very active, and the
23 organization is known as The Finders. I have a report on The
24 Finders back there [holds up document].

25 Everything I'm telling you is documented by the way.
26 The Finders has been established and operating throughout the
27 1960's up to the present time.

28 It was exposed in 1987. They moved their operation to
29 Wichita, Kansas and they're operating right today in Wichita,
30 Kansas.

1 I have taken my report [holding up a document] to the
2 FBI a half a dozen times, demanded an investigation, and I have
3 yet to be interviewed.

4 So, we have The Finders, we have the Franklin Cover-up
5 which documents what I'm telling you, we have the *Pawns in the*
6 *Game* [holding up a book] is the Illuminati, this is the
7 Illuminati / satanic movement in this country today.

8 [JOHNNY GOSCH ABDUCTION]
9

10 And, the last thing I'm going to mention in the way of
11 a book is *Why Johnny Can't Come Home* [holding up a book]. Johnny
12 Gosch was September 5, 1982 a newspaper boy, on a Sunday, and he
13 was about to deliver his newspapers in West Des Moines, Iowa.

14 He never delivered any newspapers. He disappeared. The
15 mother, Noreen Gosch, was dumbfounded, didn't know what
16 happened, demanded an investigation of the FBI, and by the West
17 Des Moines police department.

18 The chief of police in West Des Moines said to her,
19 even though he has disappeared, we do not have any witnesses who
20 saw him been grabbed and placed in a car or being taken control
21 of so, we're not going to investigate it.

22 The FBI used the same premise. They refused to
23 investigate it.

24 Now, I've been involved in kidnappings in the FBI, and
25 I can tell you that it's automatic within hours, at the end of
26 24 hours, that we had to go in in my day, this was back in the
27 50's, 60's and 70's, we had to go in and start investigating the
28 case after they've disappeared for 24 hours.

29

30 [CHILDREN ARE DISASSPEARING]

31 [AT 83 PER HOUR]

32 [OVER 700,000 PER YEAR]

Today, as we, as I stand here you sit there, the children are disappearing in this country at the rate of 83 per hour. That's over 700,000 children a year. Now I can go back to July 1982, the *Reader's Digest* claimed there were a 100,000 children disappearing every year.

There's another statistic that I find very interesting, and that is that it is estimated [that] 2,500 children are kidnapped and murdered in this country every year. That's an unbelievable figure.

Yet, the FBI refuses to investigate it.

[JEFF GANNON]

Now, after the Nebraska case, and part of the Nebraska case, most recently, we have a young man named Jeff Gannon, who has appeared in the White House using a fraudulent press pass, this has happened within the last month.

Certain people the White House were questioning him and were suspicious of him because, but he would engage in a press conference with the President, President Bush, [Gannon] who's asking what they call soft questions; soft questions meaning the President would have an answer for them and he look good.

Somebody started checking into his background. They learned that he was actually an individual named Jim Guckert. This is all on the Internet by the way. And, Guckert had a homosexual website.

1 So, Jeff Gannon is an alias of Jim Guckert. Now his
2 picture appeared in the Internet, and he is believed to be
3 Johnny Gosch, who was kidnapped September 5, 1982.

4 [His] mother Noreen Gosch who wrote this book [holding
5 up a book] *Why Johnny Can't Come Home*, I have a two-hour
6 interview with her on video, available, again, if you want to
7 check my order blank.

8 She did not sit still for this. Can you imagine if the
9 83 mothers of children who disappear every hour would do what
10 Noreen Gosch has done, we wouldn't have this problem today.

11 She went to the FBI, demanded an investigation, they
12 refused to investigate, the police refused to investigate,
13 because the case [was] tied into the Franklin Cover-up.

14

15 [HAROLD ANDERSON, THE OMAHA WORLD HERALD]

16

17 Some of our top politicians in the country, leading
18 businessmen Harold Andersen is identified by the children, [he
19 is the] past publisher of The Omaha World Herald, the head of
20 the Nebraska Forestry Service [Eugene "Gene" Mahoney] was
21 identified by these children.

22 Over 80 children came forward in this Nebraska case.
23 And, it goes as I said, right up to the White House.

24 In 1987, according to Paul Bonacci, he was furnishing
25 toys, or little boys, young boys, to the sick people, certain
26 sick individuals, in the White House itself.

27 I have the names of some of these people, no need to
28 mention it here, some of them are mentioned in *The Franklin*
29 *Cover-up* [holding up a book]. But, it does appear that Jeff
30 Gannon is, in fact, Johnny Gosch. Noreen Gosch, the mother, has
31 looked at the pictures. She believes its Johnny, Johnny Gosch,
32 because he has a scar on his right cheek about the size of a

1 nickel. It's white. Gannon has a scar there also. Little Johnny
2 Gosch had a birthmark on his left chest about eight inches long.
3 From looking at pictures of Jeff Gannon on the Internet, it
4 appears that he had a birthmark at one time, and there's been an
5 attempt to erase it.

6 I personally talked to one of the youngsters who was
7 involved in this network. I've talked to several of them. And,
8 he assures me that Jeff Gannon is, in fact, Johnny Gosch.

9 Well, how did Johnny Gosch get from West Des Moines,
10 Iowa [at] 12 years old all the way with the phony press pass
11 into the White House as of a few weeks ago?

12 But, what happened to Johnny is that he was
13 transported from West Des Moines, Iowa to Sioux City. He was
14 placed on a farm for three weeks, sexually molested, he was
15 [then] taken to the mountains in Colorado, placed in a cage in a
16 house of some sort or cabin, and then later he was used as a sex
17 slave.

18 They didn't kill him, they didn't sacrifice him,
19 although a number of these kids are sacrificed in Satanic
20 ceremonies.

21 Now, he escaped with another young man, they stole a
22 car. And in 1997, Johnny knocked on his mother's door at 2:30 in
23 the morning, Noreen Gosch, and said he wanted to talk to her, he
24 was there with another young boy.

25

26 [COVERT MILITARY CIA MIND CONTROL]

27

28 He came in, he told Noreen, he says "Mother, I was
29 kidnapped. I've been placed in a covert military CIA control,
30 mind control, project, and used as a sex slave." He said, "I
31 can't come forward at this time because they will kill me." And

1 then he left. Noreen says that's the last time she talked to
2 him, 1997.

3 Now, several years after that, a girl named Burns, who
4 was a producer for 20-20, decided to do a story on the Johnny
5 Gosch kidnapping, and the Nebraska case. And, she interviewed
6 me, in fact I had spent five days with her, gave her the benefit
7 of all my research, which is available to you folks also. And
8 then, she got a lead that Johnny was hiding out on an Indian
9 Reservation in northern Minnesota.

10

11 [MKULTRA, CIA MIND CONTROL PROGRAM]

12

13 She went there and flushed him out, and he basically
14 went into hiding, and now he shows up at the White House. He was
15 a mind control victim. If you don't know anything about MKULTRA
16 mind control program, it came into this country through the
17 German scientists after World War II.

18 They were involved with the Nazis during the war and
19 prior to World War II in developing robots and individuals to be
20 used on command for anything that they wished, including
21 assassinations and other nefarious activity.

22 The MKULTRA program, CIA mind control program, was
23 investigated by Congress in 1987. Congress said, CIA you've got
24 to quit doing, your bad boys. And they said, "We will quit."
25 Don't kid yourself, it's very active today.

26 There are people like Barbara Hartwell out there who
27 are a mind control victims. She's another one who has been
28 bashing me. I must have done a pretty good job, because I
29 wouldn't have these people criticizing me on the Internet like
30 they do. And of course, it doesn't bother me in the least.

31

32 [OFFUTT AIR FORCE BASE, OMAHA, NEBRASKA]

1 [STRATEGIC AIR COMMAND HEADQUARTERS]

2

3 But going back to the Nebraska case and MKULTRA, a lot
4 of this training took place at Offutt Air Force Base in Omaha,
5 Nebraska which is Strategic Air Command Headquarters.

6 You [may] recall after 9/11 the President flew to, I
7 think it was south someplace in Louisiana, or New Orleans, and
8 then he flew to Offutt Air Force Base in the afternoon of
9 September 11, 2001, and they had a party there that morning at
10 nine-thirty in the morning, he missed the party, he was sorry he
11 missed the party.

12 Warren Buffett was there by the way.

13

14 [FORT BRAGG, NORTH CAROLINA]

15

16 And, the MKULTRA program has been very actively
17 administered, not only at Offutt Air Force Base, [but also] at
18 Fort Bragg, North Carolina, the place where Dr. MacDonald's
19 family was slaughtered in 1970.

20 Now, the Nebraska case, I don't want to leave that
21 without telling you that in the early, early 1990's Yorkshire
22 [UK] TV he came to the United States with a camera crew for
23 seven months to do a documentary on it.

24 They went back to England, produced the documentary,
25 and they brought it over into the United States. It was listed
26 in the *TV Guide* to be aired on May 3, 1994.

27 When certain members of Congress found out about it
28 they threatened the cable industry with restrictive legislation.
29 Somebody anonymously bought up the rights to the videotape for
30 the documentary and ordered all copies destroyed.

31 I just happen to have a bootleg copy of that
32 documentary [holding up a VHS tape cartridge] and it is

1 available. I have been selling these, and these books, and
2 getting this report out of mine to anybody that's interested in
3 it. And by the way, I have a five package deal for you at about
4 a 15% discount, 15-20% discount if you buy all five items.

5 So, about six months ago, as any good investigator
6 would do, I said I'm going to get a copy of that *TV Guide*. I
7 didn't have a copy John De Camp had one at one time but couldn't
8 find it. That's typical of John, by the way, good friend great
9 guy. And so, I said I'm gonna make my own copy.

10 So, I wrote to the *TV Guide* people. And, I received a
11 copy of the *TV Guide* from May 3, 1994. 10pm Discovery Channel,
12 it's not listed. A nature show is listed instead on the new,
13 reprinted edition.

14 I'm not going to be outfoxed by these people. [So,] I
15 went to *The Los Angeles Times* TV log. It's listed "Conspiracy of
16 Silence."

17 I called a friend of mine in Philadelphia and I said
18 check the TV log for the *Philadelphia Inquirer*, "Conspiracy of
19 Silence" is listed in the *Philadelphia Inquirer*.

20 The power of the press; they changed and reprinted the
21 whole *TV Guide*. It never has been shown publicly in the United
22 States, and I doubt if it ever will be shown publicly, but as I
23 said, it is available to you.

24 Now, that's not the end of the story for me because I
25 am continuously probing, continuously working, continuously
26 talking to various sources and putting it on paper and
27 documenting and getting the word out.

28 This is the direction that we have to go. Americans
29 for the most part are oblivious to what's really going on behind
30 the scenes.

31 One of the things that, in addition to the MacDonald
32 case, that got me thinking was the Jack Kennedy assassination.

[JOINT HIT BY CIA AND CHICAGO MOB]

So, I took, checked into that. And, by the way, I used to be in charge the FBI in Dallas, and also I was Los Angeles [FBI] after Dallas. So, I'm checking into the Jack Kennedy assassination.

12

13

I learned, no question about it, that it was a joint hit by the CIA and the Chicago mob.

14

15

16

Sam Giancana, head of La Cosa Nostra in Chicago, three days before he was to testify before Congress, was shot and killed. [He was] murdered.

17

This encouraged me to do some more checking into some of these national terrorist acts that have taken place and other cover-ups in the United States.

[PEARL HARBOR]

22

23

24

25

I interviewed the Naval intelligence officer who, on December 4, 1941, received information that the Japanese were going to bomb Pearl Harbor.

26

We had broken the secret code of the Japanese.

27

28

He told me personally [that] on December 4th he gave it to his superiors. They passed it up the line.

29

32

After Pearl Harbor he was subpoenaed to testify before Congress. His boss called him in said don't worry about it, don't respond to the subpoena, someday you'll know why. He never did testify before Congress.

1 And, he recently passed on by the way. So we have
2 Mallory, a cover-up in these other areas, but looking at the
3 National picture, Pearl Harbor.

4

5 [WACO, TEXAS]

6 [MILITARY RAID ON THE CIVILIAN BRANCH DAVIDIANS]

7 [POSSE COMITATUS]

8 [COINCIDENTAL ASSASSINATION OF FOUR FORMER

9 BODY GUARDS OF BILL AND HILLARY CLINTON]

10 [BATF AGENTS C. LEBLEU/T. MCKEAHAM, R. WILLIAMS, S. WILLIS]

11

12 And look at Waco. The military was involved in
13 destroying and shooting and killing, and also the FBI, [of]
14 women and children in Waco. They used tanks, military tanks, in
15 violation of *Posse Comitatus* [18 USC 1385] which is a law that
16 says the military cannot be used to enforce the civilian
17 population.

18 They got away with it. There's an interesting story. I
19 did some research on Waco. As I've told you, I've done a lot of
20 research, and in many instances I've not only been there, I've
21 done that, and I've been on the scene.

22 I've spent most of my retirement money investigating
23 these matters, including Oklahoma City. I'll go into that just a
24 minute. 9/11, and so forth.

25 But, in Waco there were four BATF [Bureau of Alcohol,
26 Tobacco and Firearms] agents who were shot and killed. Some of
27 the Branch Davidians were tried, sentenced for these quote
28 murders, and are serving prison terms today, probably for life.

29 In researching the BATF agents who were shot, I
30 learned [that] every one of them was shot in the head. Now, for
31 those of you who have been in the military, that's a sniper
32 shot. No question about it. One of them, the trajectory of the

1 bullet was from above, down through his lip, and into his body,
2 probably from a helicopter.

3 It's interesting to note that these four men be BATF
4 agents, at one time were all bodyguards for former President
5 Bill Clinton [C. LeBleu/T. McKeaham, R. Williams, S. Willis].
6 That was Waco.

7

8 [RUBY RIDGE]

9

10 [Now let's look at] Ruby Ridge.

11 Randy Weaver [whose wife Vicki was killed during the
12 standoff] was set up by a BATF (Bureau of Alcohol, Tobacco &
13 Firearms) informant. He bought a shotgun that was about a
14 quarter of an inch too short by law. They arrested him, and
15 served him with a warrant.

16 He refused to appear before the courts, and they sent
17 an army after him. [Lon] Horiuchi, FBI sharpshooter, shot and
18 killed his wife [Vicki] while she was standing in the doorway.
19 He used to brag about it what a great shot he was.

20 [This is] another instance where they [US government]
21 tried to railroad a good loyal American who fell in a trap.

22

23 [WORLD TRADE CENTER BOMBING]

24

25 And then we have the 1993, continuing with The Great
26 Conspiracy, I call this a great conspiracy, and that's what it
27 is, car bombing of the World Trade Center.

28 I have a copy of *The New York Times*, October 28, 1993.
29 And, in the article this was reporting from the trial that took
30 place.

31 An FBI informant named [Emad] Salem, who was in among
32 the terrorists, testified that he was commissioned by the

1 terrorists to put the bomb together, the car bomb together, to
2 bomb the World Trade Center in February 1993. And, fortunately
3 for him, when he met with the terrorists he wore a body
4 mic[rophone] so he could record every word that was said.
5 Unknown to the FBI, when he met with the FBI, he also wore a
6 body mic[rophone]. That was probably what kept him from being
7 set up and framed and sent to prison.

8 This is actually in this newspaper article. He went to
9 his FBI superiors [saying] "Since I've been commissioned to put
10 the bomb together, we're going to use the dummy bomb, aren't
11 we?" And, he was told by his FBI: "No, we're going to use a real
12 bomb."

13 Now, I don't understand why Congress and Senate
14 investigators and our leaders in Washington, D.C. are not
15 jumping up and down over that situation.

16 The FBI not only knew in advance of the car bombing,
17 they furnish the ingredients for the bomb. Why doesn't somebody
18 take some action in that area?

19 Why doesn't somebody investigate this international
20 child kidnapping ring being operated by the CIA.

21 Why are these Congressmen voting on bills like the
22 Patriot Act which takes away many of our constitutional rights
23 and civil liberties in the best interests of "protection for our
24 country and protection from the terrorists?

25 Let me tell you something ladies and gentlemen, there
26 are people in our government, a rogue outfit, whatever I'm not
27 sure, who are actually behind these terrorist acts. The reason
28 they're behind terrorist acts is so they can pass bills like the
29 Patriot Act. The reason the Congressmen and Senators vote for
30 these stupid bills, stupid by our terms, in our definition, is
31 because many of them have been set up and framed through sex and
32 drugs.

So, then we have Oklahoma City 1995. I personally made two trips to Oklahoma City. I investigated Oklahoma City. Because of my report, the defense attorney for Timothy McVeigh sent two of his investigator to interview me. I spent four hours with them. Actually, I got a lot of information out of them.

For example, they told me that they were allowed to tour the remains of the Murrah Building in Oklahoma City in the presence of a US Marshal, but they were not allowed under any circumstances take soil samples, or to pick up any evidence for examination.

Stephen Jones was their attorney. I heard that they were going to tear down the building. Now, you can trace bombs through what they call the taggings, the chemicals.

When I heard this I called John De Camp. I said John we've got to prevent that building from coming down. And, I actually called an outfit in Chicago, the Pat Kennedy Group, who were specialists in examining evidence of this type.

And John called McVeigh's attorney, [Stephen] Jones. And, because John had a client who he was representing who was involved in the case, Jones said I'll handle the paper. We'll have a hearing. We will prevent that building coming down. The next thing we heard, the building was coming down.

1 John called Jones [and asked] "What's going on" and he
2 had no good answer for it.

3 That was evidence. I've been at many a crime scene. It
4 is critical that the evidence be preserved. That was a huge
5 cover-up.

6 McVeigh wrote a letter to his sister.

7 McVeigh was in Special Forces. The government says,
8 military says, "Oh no, he flunked out."

9 He didn't flunk out, he was recruited out of Special
10 Forces, according to him a letter he wrote to his sister, to be
11 trained to be a CIA assassin, and also to work for the CIA
12 international drug operation both against the competition and
13 for the CIA pro-drug people.

14 McVeigh was, in my opinion, an MKULTRA mind control
15 victim.

16 He was visited in prison in Oklahoma and in Colorado
17 by Dr. Jolly West [Dr. Louis Jolyon West, the UCLA mind control
18 expert for the CIA (1924-1999); MKULTRA, LSD, brainwashing
19 experimenter; involved in Jack Ruby/Patty Hearst evaluations].

20 This [meeting with McVeigh] was secret by the way. I
21 happened to find out because I made some phone calls to the
22 right people.

23 Jolly West was one of the foremost leaders along with
24 Sidney Gottlieb in the CIA's MKULTRA mind control operation.

25 Why would somebody like Jolly West interview McVeigh,
26 not only in Oklahoma, but also in Colorado during the trial? [It
27 is] because he [McVeigh] was a mind control victim himself.

28 At one time, it was reported, I think at a US News &
29 World Report, that McVeigh had a microchip in his buttocks. Our
30 military reportedly have been using microchips to keep track of
31 their soldiers.

1 The bomb in the [McVeigh] truck allegedly was a
2 fertilizer bomb. The government first announced that it was a
3 1,500 pound bomb, and then a 2,500 pound bomb, and I think it
4 ended up being 4,800 pounds.

5 That bomb that was in the truck destroyed half the
6 building.

7 A 4,800 pound fertilizer bomb, an ammonia nitrate
8 fertilizer bomb, dissipates, and did not have the potential, the
9 possibility, of destroying that much of the building.

10

11 [MICHAEL RICONOSCIUTO]

12

13 After the Oklahoma City bomb went off I had a call
14 from a friend of mine, Michael Riconosciuto. For those of you
15 are making notes look up in the Internet, R-i-c-o-n-o-s-c-i-u-t-
16 o, Michael Riconosciuto.

17 I've been working with Michael since the early 1980's.
18 1982 is when I first met him.

19 He was a CIA agent, operative, for some two decades.
20 He was also an FBI informant at one time.

21 His father owned the Hercules Manufacturing in Silicon
22 Valley. California. Hercules Manufacturing developed what is
23 known as the electro-hydrodynamic gaseous fuel device which is a
24 highly classified bomb. The bomb was actually manufactured by
25 Dyno Nobel out of Salt Lake City.

26 Now, Michael [Riconosciuto] in the meantime, is in
27 jail now, right today. In fact, I talked to him yesterday
28 because he started to talk before the Brooks Committee about a
29 very interesting case involving the Promis software [Inslaw,
30 Inc.] .

31

32

[PROMIS SOFTWARE]

1 [DEPARTMENT OF JUSTICE]

2 [TRAP DOORS]

3

4 The Promis software was in a computer operation that
5 developed all kinds of intelligence information on you, and I,
6 and every citizen in America. The Department of Justice leased
7 it for two years. At the end of two years they refused to pay
8 Bill and Nancy Hamilton the \$10 million they owed them.

9 Then, the Department of Justice through Earl Brian,
10 past president of United Press International, took that
11 computer, sold it around the world, sold to the French, to the
12 English, Israelis, Canadians.

13 Unknown to these foreign countries, the officials in
14 these foreign countries, there was a trap door in computer, very
15 clever, eh?

16 A trap door secretly allowed us, the US government, to
17 retrieve all the information they developed.

18 Michael Riconosciuto was the CIA agent who developed
19 the trap door in the Promis software computer.

20 And, when Congress started to investigate in the late
21 1980's, they called on Michael and [said] we want you to
22 testify.

23 Michael received a threatening phone call two weeks
24 before he was to testify, he claims from a fellow named Peter
25 Videnieks, US Department of Justice [the contract officer who
26 oversaw the Promis contract for the Department of Justice
27 Management Division] [who said] "If you testify you'll be
28 sorry."

29 Michael testified anyway.

30 A few weeks later was arrested for drugs and is now
31 serving a 30-year prison sentence because he dared to expose

1 these nefarious activities by this rogue criminal enterprise
2 operating within the confines of the US government.

3 I got off a little on, I gave you a little background
4 on Michael.

5 Going back to Oklahoma City now, I wanted you to
6 understand who Michael is. He's not some guy walking down the
7 street with a grocery basket looking for a recycling center,
8 okay? He has credibility.

9 Now, Michael called me right after the Oklahoma City
10 bomb went off and he said, Ted, he called from prison by the
11 way. That's my bomb, meaning that Hercules developed it.

12 That was not an ammonia nitrate bomb. Now, when that
13 bomb was tested in 1982, I happen to be with a group of
14 intelligence agents in Palm Springs waiting for the results of
15 that test.

16 It was tested in Area 51. It was underestimated
17 because the power, it was so powerful, that two of the
18 technicians died. They underestimated the strength of it.

19 This, I call a barometric bomb, this barometric bomb,
20 according to Michael, was what was in the car, not a fertilizer
21 bomb. I have an Oklahoma City report on that.

22 So what did I do as an investigator? Well, I went to
23 the Picatinny Arsenal in New Jersey and gave them the contract
24 number which I obtained through a science magazine. One of my
25 associates actually did the research on that.

26 And, I gave the Picatinny Arsenal contract number,
27 this is public, available to the public by the way, and the
28 Picatinny Arsenal came back and said there's no such contract,
29 even though I had the contract number.

30 By the way, that's documented in my report.

31 And, I went to Dyno Nobel who I knew manufactured it,
32 and they didn't even bother to respond.

1 It's interesting to note that a Dyno Nobel expert
2 witness testified at the Grand Jury when they indicted McVeigh.

3 In September of 1995, some five or six months after
4 the 19th of April 1995 Oklahoma City [bombing]; in September
5 there was a, I lost my train of thought there for a minute, oh,
6 there was an article in Fireman's magazine.

7 It was written by the editor of Fireman's magazine.
8 The information was obtained from the Oklahoma City Fire
9 Department.

10 And, in that article, again that's in my report, in
11 that article it states that four unexploded devices were taken
12 out of the building.

13 When people were in the building after the bombing,
14 dying, they discontinued the rescue effort for some five hours
15 while they carried out a bunch of government files. Men in blue
16 suits of some sort, sweat suits.

17 So, what I'm telling you is Oklahoma City was
18 perpetrated by certainly people other than McVeigh and Nichols.

19 And now, Roger Moore, if you've read the paper
20 recently, the gun dealer who claims that he was robbed of his
21 guns in Arkansas, and that that money was used to finance
22 Oklahoma City bombing.

23 Roger Moore, has been accused by Terry Nichols of
24 being involved in it. Roger Moore denies it. Roger Moore, at the
25 time of the Oklahoma City bombing, was an FBI informant.

26 I had an inside investigator in Oklahoma City tell me
27 that there were at least 11 other individuals involved in
28 Oklahoma City.

29

30 [SEPTEMBER 11, 2001]

31 [FBI HAD DETAILED ADVANCE WARNING]

32

1 Okay, that brings us up, we've gone through Pearl
2 Harbor, Waco, Ruby Ridge, [World Trade Center] car bombing 1993,
3 Oklahoma City 1995, that brings us up to 9/11.

4 As I said, Michael is in prison. I'm his "investigator
5 of record" which means I'm like an attorney. I should have
6 access to him on a regular basis. I represent this man. For a
7 year in prior to 9/11, actually a year and a half, I tried to
8 get in to see Michael. He was in prison in northern
9 Pennsylvania. I was in the Philadelphia area.

10 The Bureau of Prisons would not allow me to see him. I
11 finally was able to talk to Michael in January 2003.

12 I flew to the East coast, spent three days with him.
13 Michael told me that he had developed information from among his
14 contacts, in advance of 9/11, that they were going to be
15 involved in using missiles, airplane missiles, and they were
16 going to be involved in skyjackings.

17 They were training Arab terrorists, and also he knew
18 the identity of the person in the United States, an Arab who
19 lived in Patterson, New Jersey who was the leader of terrorist
20 activity by the Arabs in this country.

21 Now Michael had this information because, you're
22 saying how can Michael develop this information being in prison?

23 Because I met with Osama bin Laden, along with
24 Michael, along with the State Department representative in the
25 Spring of 1986.

26 At that time, I was contacted by former top Reagan,
27 Ronnie Reagan, official who said can we help the Afghan rebels,
28 they were our friends then. And, I called Michael and I said
29 what do you think, and he said let's meet.

30 So, there was a fourth fellow there, and we didn't
31 know at the time it was Osama bin Laden, he actually used the
32 name "Tim Osman" to traveling under Turkish Passport.

1 But, because of Michael I passed the ball to him. I
2 just arranged for the meeting and went on. But, Michael traveled
3 all over the world putting this package together to furnish the
4 Afghan rebels with the surface to air missiles that defeated the
5 Soviets, really, shot down their helicopters.

6 As a result of this, Michael developed resources
7 inside the Arab world, and that is how Michael knew in advance
8 about 9/11.

9 Michael told the FBI on March 20, 2001 about this plan
10 to use skyjack airplanes and use them as missiles. He also
11 furnished to the FBI one of his sources, one of his confidential
12 sources, inside the Arab group.

13 The FBI interviewed him, threatened [him] with
14 prosecution and deported him. That man, along with his family,
15 has disappeared. We think that they're dead. The FBI refused,
16 absolutely refused, to look into this situation.

17 More shocking is that Michael had the names of the
18 people who were obtaining the false names of the people the
19 Arabs who were obtaining false passports, had their names.

20

21 [FBI AGENT KEITH CUTRI]

22

23 He had the source who could furnish them that
24 information. He told FBI agent Keith Cutri on March 20, 2001, he
25 told Cutri, he says "I'll give you these names, the name of this
26 person who's coordinating the whole project for the Arabs,
27 providing I be given immunity and he be given immunity."

28 Mr. Cutri, in spite of the fact he was armed with this
29 information six months prior to 9/11, came back two days after
30 9/11, on the 13th and saw Michael in prison again.

1 [He] accused Michael of being anti-government, anti-
2 FBI, of being a publicity seeker, and so forth, being disloyal.
3 And so Michael, of course, didn't have much to say after that.

4 Michael is still in prison, as I said. But, we had
5 this information. The FBI did nothing with it. Cutri admit it,
6 on September 13, 2001, admitted that the FBI did nothing with
7 it. So, after I visited Michael, excuse me, in 2003, I felt it
8 was important that I confirm that the FBI did meet with him.

9 The Bureau of Prisons would not furnish Michael with
10 the visitors list to confirm it, and so I started writing
11 letters to the FBI through Senator George Allen, [handed glass
12 of water] I thank you, thank you.

13 And, to confirm that he did in fact meet with them I
14 wanted to document it. I also asked for the identity of the
15 other agent who was with Agent Cutri, and I had a terrible time.

16 It took me a year and a half, writing letters to the
17 FBI to get them to admit that they'd interviewed Michael on
18 March 20, 2001. I finally did have that information. That
19 information is available again, in one of my reports, my
20 terrorism report, that I have in the bag.

21

22 [COVERT CRIMINAL ENTERPRISE INVOLVING FBI AND CIA]

23 [TED GUNDERSON THREATENED MULTIPLE TIMES]

24

25 So, that basically brings me up to the present time. I
26 think my time is up. But, I feel compelled, as a former FBI
27 agent, I had all this training, and I feel compelled to do
28 everything I can to educate as many fellow Americans as I can as
29 to what's going on behind the scenes.

30 We have, being operated and orchestrated primarily by
31 US military intelligence, covert criminal enterprise involving
32 the FBI and the CIA active in this country today. It's being

1 covered up. Right from the beginning they're using FBI
2 informants to set up and frame people.

3 By the way, they tried to frame me on a drug deal back
4 in 1984. It didn't work.

5 The girl that they used to try to frame me contacting
6 me, said I need to meet with you, we met, she told me the whole
7 story. I took a signed statement from her, her name is Pam
8 Fawsett. And, I said to Pam, I said Pam, you're working for
9 these people, the DEA and the FBI and Modesto by the way. She
10 was making phone calls to me.

11 I said [to Pam] you're working with people trying to
12 set me up, why have you, and of course in the phone call she
13 kept sitting trying to get me to make admissions that had
14 knowledge of a felony. I wouldn't, I said I don't have any
15 knowledge of that or was involved in a felony actually.

16 I said Pam, look, you were working with these people
17 for six months, they gave you two thousand dollars, you had the
18 run of the FBI office, you had your own coffee cup, why did you
19 come to me and tell me this now. And, I'd helped her give it a
20 little advice about her year old son in the interim, you know,
21 talking back and forth as any individual would do who might be
22 able to help.

23 But, she said, Ted I woke up the other morning and I
24 realized you're the only honest son of a bitch I've talked to in
25 six months. Those were her exact words.

26 The FBI not only tried to set me up on a drug deal,
27 they've also, I've also been the victim of four separate
28 investigations.

29 They tried to set me up on a fraud case in Denver, in
30 Dallas, and most recently, very frankly, I've been under
31 surveillance, heavy surveillance. There have been illegal
32 entries into my car, into my apartment. There have been attempts

1 to gas me within the last month. I was able to anticipate it and
2 avoid it.

3 But, they don't want people like me out telling the
4 truth, and that's what I'm doing and I will not stop. I will
5 continue to do so in the future.

6

7 [BRYANT GUMBEL TURNED A BLIND EYE]

8

9 So, that's basically a lot. I brought you from 1776 to
10 the present time. We went through one conspiracy after another.

11 Bryant Gumbel was interviewing Jim Nichols, Terry
12 Nichols' brother, on national TV after the Oklahoma City bombing
13 by the way.

14 I had given Jim Nichols my Oklahoma City bombing
15 report. Jim said to Bryant Gumbel, he says, did you read Ted
16 Gunderson's Oklahoma City report. Gumbel says, "Oh, Ted
17 Gunderson's a conspiracy theorist."

18

19 [CONSPIRACY REALIST, NOT THEORIST]

20

21 I want you to know I'm not conspiracy theorist, I'm a
22 conspiracy realist.

23 It is there, all you have to do is get your own
24 website, get your own Internet, go out there.

25 There's a lot of disinformation out there, but you can
26 pick up what's really solid and what's really truthful. And, I
27 have, I have 25 years of research on that back table back there.
28 And, if you buy any of my reports, or this video tape, or any my
29 material, I want you to make a promise, that you will make
30 copies and distribute it and far and wide.

31

32 [WAKE UP AMERICA]

1

2 We need to wake up America. Let me emphasize again.
3 I'm not anti-American. I don't believe in violence. I believe in
4 change through legal means.

5 But, we need to wake up an apathetic, sleeping society
6 that is active in America today.

7 And this not only ties into a MKULTRA CIA, it ties
8 into Satanism.

9

10

[FOUR MILLION SATANISTS]

11

[COVERT CRIMINAL ENTERPRISE WITHIN OUR GOVERNMENT]

12

[SERIOUS THREATS TO OUR SOCIETY]

13

14 There are approximately four million practicing
15 Satanists in America today involved in the Nebraska case. I can
16 go on about satanic cults for another, but I think my time is
17 almost up.

18 I might mention that speaking of Satanism, there are
19 between 50,000-60,000 human sacrifices, according to three
20 different sources, in this country every year.

21 The satanic cults operate secretly. The satanic cults
22 are, along with our covert criminal enterprise within the
23 government, serious threat to our society, and I thank you very
24 much.
