Dear Mr. Bossie:

I refer to our letter dated March 29, 2019, regarding the release of certain Department of State records of the under the Freedom of Information Act (the "FOIA"), 5 U.S.C. § 552.

We have completed the review of the three documents pending from the shared electronic office folders available to the employees within the Office of the Secretary during former Secretary Clinton's tenure and the individual electronic folders of the files belonging to Cheryl Mills, Huma Abedin, and Jacob Sullivan. We have determined that one document may be released in full and two may be released in part.

The search all of the materials provided to the Department by former Secretary Clinton resulted in the retrieval of two documents responsive to your request. The documents are identified with the following numbers: C05768570 and C05775009. We direct you to the Department of State's Virtual Reading Room and provide the following URL that captures the document responsive to your request:
