


COMEY-CLINTON CONNECTIONS



- 1-4 Cheryl Mills became Deputy White House Counsel in 1993 and has been with the Clintons ever since.
- 1-11 Law firm DLA Piper has contributed \$939,101 to Hillary Clinton's various political campaigns.
- 1-12 Hillary Clinton served as Secretary of State under Barack Obama from 2009-2013.
- 1-13 Hillary and Bill Clinton investigated in the Whitewater Scandal.
- 1-14 In 2015-2016, the Justice Department and FBI investigate Hillary Clinton's use of a private email server which contained classified material during her tenure as Secretary of State. Lesser federal employees and military members are imprisoned for crimes much less severe than the ones Clinton has been confirmed to have committed.
- 2-4 Cheryl Mills became Chief of Staff to Secretary of State Hillary Clinton in January 2009.
- 2-9 The HSBC bank is deeply intertwined with the Clinton Foundation on so-called "green energy" deals.
- 2-10 Defense contractor Lockheed Martin donated \$250,000 to the Clinton Foundation in 2010. Also paid Bill Clinton \$250,000 to deliver a speech in Egypt (paid in conjunction with "The American Chamber of Commerce in Egypt").

2-11 DLA Piper conducted an internal audit of the Clinton Foundation. Employs Peter Comey, brother of FBI Director James Comey.

3-4 Bill Clinton first employed Cheryl Mills as Deputy White House Counsel. She served as the Clintons' attorney through the Whitewater scandal, the Lewinsky scandal and other 1990s scandals and alleged crimes.

3-5 Bill Clinton appointed Loretta Lynch to the position of US Attorney for the Eastern District of New York. The two met privately on the tarmac at the Phoenix airport in June 2016, just days before FBI Director James Comey declared that "no reasonable prosecutor" would bring a case against Hillary Clinton.

3-13 Bill and Hillary Clinton investigated in the Whitewater Scandal.

4-5 Cheryl Mills and Loretta Lynch both worked at Hogan & Hartson law firm at various points in their careers.

4-8 Cheryl Mills worked for Hogan & Hartson starting in 1990 until she went to work at the Clinton White House in 1993.

4-12 Cheryl Mills went to work at the State Department in 2009 as Hillary Clinton's Chief of Staff and attorney. Simultaneously served on the Clinton Foundation's board of directors.

5-6 Loretta Lynch became US Attorney General in 2015, thus becoming FBI Director James Comey's "boss" in the Justice Department. Comey and Lynch also "crossed paths" in the early 2000s during the investigation of the HSBC bank.

5-8 Loretta Lynch worked at Hogan & Hartson from 2001-2010. During that time, Hogan & Hartson prepared the tax returns of Bill and Hillary Clinton. Hogan & Hartson also worked on the patented MX Logic software used on Hillary Clinton's homebrew server while Lynch was employed at the firm.

5-9 Loretta Lynch prosecuted the money-laundering case against Hong Kong and London-based HSBC bank. HSBC was accused of laundering funds for Mexican drug cartels and terrorist groups. Lynch failed to send a single banker to prison and HSBC instead paid a fine.

5-14 Loretta Lynch worked for the Justice Department as US Attorney for the Eastern District of New York from 1999-2001. Reappointed as US Attorney in 2009 by Barack Obama. Appointed as US Attorney General in 2015. Lynch is a lifelong friend of the wife of former Attorney General Eric Holder (found in Contempt of Congress for withholding Fast & Furious documents).

6-7 FBI Director James Comey is the brother of Peter Comey, an attorney employed by law firm DLA Piper.

6-9 James Comey took a job working for HSBC bank in 2013, just prior to being appointed as FBI Director by Barack Obama.

6-10 James Comey was employed as General Counsel attorney for Lockheed Martin from 2005-2010. Was paid \$6 million in compensation in 2010, the same year that Lockheed Martin donated \$500,000 to the Clintons.

6-13 James Comey joined the Senate Whitewater Committee as Deputy Special Legal Counsel. After a years-long investigation of the Whitewater Scandal, the Clintons were never prosecuted. Curious that Comey was involved in that case, no?

6-14 James Comey was appointed US Attorney for the Southern District of New York by George W. Bush. Served from 2002-2005 and is reported to have “crossed paths” with fellow US Attorney Loretta Lynch on the HSBC bank investigation. Appointed FBI Director by Barack Obama in 2013.

7-11 Peter Comey, brother of James Comey, is an attorney employed by DC law firm DLA Piper.

10-12 Lockheed Martin was awarded 17 defense contracts by the Hillary Clinton/Cheryl Mills-led State Department in 2010 after donating \$500,000 to the Clintons and compensating then-Chief Counsel James Comey \$6 million.
