UNA-UK welcomes new Patrons: Princess Tessy and Lord Malloch- Brown



The United Nations Association - UK is delighted to announce that Princess Tessy of Luxembourg and Lord Malloch-Brown have accepted the position of UNA-UK Patron - the highest honorary position within the Association

Princess Tessy of Luxembourg is a former officer in the Luxembourg army. She described the "highlight" (<http://www.telegraph.co.uk/women/life/princess-tessy-of-luxembourg-on-serving-in-a-warzone-and-being-a/>) of her five-year military career as her

deployment with the UN peacekeeping mission in Kosovo in 2004. After military service, she became the global advocate for young women and adolescent girls at UNAids, before being nominated as Associate Fellow for the Centre on Global Health Security at Chatham House.

A current adviser to UNA-UK, Her Royal Highness has taken an active interest in charities and NGOs, having joined the Luxembourg Groupe de Support Psychologique (Psychological Support Group) and created her own NGO titled 'Professors without Borders'. She is also currently Director of UK security firm DS-48.



Mark Malloch-Brown is the highest-ranking UK citizen to have served at the UN. He served as Deputy Secretary-General and Chief of Staff of the UN under Secretary-General Kofi Annan, and previously held the position of Administrator of the UN Development Programme (UNDP).

Lord Malloch-Brown was later Minister of State in the UK Foreign and Commonwealth Office, covering Africa and Asia, and was a member of Prime Minister Gordon Brown's cabinet. Other positions have included Chair of International Crisis Group, Vice-Chairman of George Soros's Investment Funds - as well as his Open Society Foundation - and a Vice-President at the World Bank.

Princess Tessa and Lord Malloch-Brown will join UNA-UK's first Patron, Sir Patrick Stewart OBE, in representing and promoting the Association.





Biography

Lord Wood became Chair of UNA-UK on 1 July 2016, after a competitive recruitment process. He is a member of the House of Lords and a Lecturer at the University of Oxford. From 2007-2010 he was the Senior Special Advisor on foreign policy to the Prime Minister, Gordon Brown – covering Europe, USA, Middle East and relations with international organisations.

Prior to his time at 10 Downing Street, he was an academic at Harvard and then Oxford universities, where he wrote extensively on political economy and European politics. From 2001-2007 he was a member of the Chancellor of the Exchequer's Council of Economic Advisers, where he worked on European affairs (including the 2003 Euro assessment). After the 2010 election he served as an adviser on strategy and international affairs to the Leader of the Opposition, Ed Miliband.

Lord Wood has been a Fellow at Magdalen College, Oxford, since 1996, and is also a Visiting Fellow at Nuffield College, Oxford. In 2016 he was appointed a Fellow in Practice at Oxford's Blavatnik School of Government. He is also a member of the House of Lords International Relations Committee.

Tessy Antony, Princess of Luxembourg



Tessy Antony, Princess of Luxembourg is a former officer in the Luxembourg army. In 2004, she was stationed in Kosovo after volunteering to take part in a UN peacekeeping mission. She was the only woman on her team and received the United Nations Medal of Recognition for her work on the mission. She then served at the Luxembourg Embassy in London in 2005 and later took up a post at the Permanent Mission of Luxembourg to the United Nations in Geneva.

After military service, Tessy attended the American International University in London where she received a BA in International Relations and later went on to obtain a Master's degree in International Studies and Diplomacy.

She has taken an active interest in charities and NGOs. She joined the Luxembourg Groupe de Support Psychologique (Psychological Support Group) and created her own NGO titled 'Professors without Borders'.

Tessy Antony, Princess of Luxembourg became the global advocate for young women and adolescent girls at UNAids, before being nominated as Associate Fellow for the Centre on Global Health Security at Chatham House.

Her work on spreading humanistic ideas globally has been widely recognised. In 2017, she was presented with the “Woman of the Decade Creating A Better World For All” award at the Women’s Economic Forum.

A previous adviser to UNA-UK, Tessy is also Director of UK security firm DS-48.

Lord Mark Malloch-Brown



Lord Malloch-Brown is the highest-ranking UK citizen to have served at the UN and has a high-level experience in public policy, politics, development co-operation and communications.

He served as Deputy UN Secretary-General and Chief of Staff under Secretary-General Kofi Annan, and previously held the position of Administrator of the UN Development Programme (UNDP). During his tenure at UNDP, he led on the development of the Millennium Development Goals and oversaw a comprehensive reform effort that has been widely recognised as making the Programme more efficient across the 166 member countries where it operates.

Mark Malloch Brown later served as Minister of State in the UK Foreign and Commonwealth Office, covering Africa and Asia, and member of Prime Minister Gordon Brown’s cabinet. He was also Vice-President of external affairs at the World Bank.

Lord Malloch-Brown is on the board of a number of NGOs including the International Crisis Group, the Open Society Foundation, the Children’s Investment Fund Foundation, and the Centre for Global Development. He is a former chair of the Royal Africa Society. He is also involved in local business development in Africa serving on the boards of a number of start-ups and investment funds.

Mark Malloch Brown has written about development and international issues over many years, most notably in *The Unfinished Global Revolution*, where he calls for action to accelerate international development and global governance.

He is a member of the House of Lords and was knighted in 2007 for his contribution to international affairs.
