Dear Mr. Trump:

We will pay the \$5 billion for the Wall.

I am the founder, chairman and controlling shareholder of Leader Technologies (“Leader”) headquartered in Columbus, Ohio. In the mid-1990s I rebuilt AT&T's email system, then founded Leader to solve Internet collaboration problems, notably scalability. I then invented what we now call **social networking**. My invention was then summarily stolen and weaponized by the federal government, with *no compensation* to me or my shareholders.

I am willing, along with certain shareholders, to give you the \$5 billion for the Wall.

Here's how. The federal government owes our company literally trillions of dollars in uncompensated use of our invention since 2000. We have sent you our **Miller Act Notice** which describes this, so I will not repeat those details.¹

Our **Miller Act Notice** (40 USC §3131 Et Seq) demands that the Executive Branch pay us for 18 years of free use of our innovations without compensation during the Clinton, Bush and Obama years and right up to this day. We know you had nothing to do with this theft, but the Miller Act law requires that we serve you as the Executive of the agency that organized and benefited from our inventions.

The Miller Act Notice proposes an initial payment of \$40 billion as a compromise payment for the first 18 years of free use. The actual market value is more like \$7 trillion. However, Leader is willing to compromise on the first payment in exchange for an uncomplicated ongoing licensing arrangement that will be used to fund a new **Conservative Free Press Initiative** described below.²

² **Thomas Jefferson to Lafayette (1823. ME 15:491):** “The only security of all is in a free press. **The force of public opinion cannot be resisted when permitted freely to be expressed.** The agitation it produces must be submitted to. It is necessary, to keep the waters pure.” (Emphasis added).

I am willing, as the controlling Leader shareholder, along with other Leader shareholders, to dedicate the bulk of the proceeds due to me to help establish and sustain a truly Free Press as America's Founders envisioned. The current activities, including the censorship of conservative perspectives currently running roughshod over our media landscape, shows that monopolistic forces now control the media—just as the Founders feared. **Honest eyes can see that our press is currently not free.** Our Constitutional Republic currently has no free press “to keep the waters pure” (Thomas Jefferson, 1823).

This *Conservative Free Press Initiative* will provide startup funds for current and new news and investigative journalism outlets that focus on **FACTS instead of the current fare of spin and propaganda.** The Initiative will also provide leadership to disentangle our public discourse that is currently smothered by secret “public-private partnership” alliances that have usurped Constitutional guarantees to protect privacy and property.

Here is a summary of the math for our decision:

- 7.7 billion social users (beneficiaries of the federal government's theft)
- \$2 license fee per month due Leader = \$15.4 billion/month
- \$184.8 billion per year due Leader for ongoing licensing

This ongoing licensing of our inventions will be a \$2/month license to individuals and a pass-through for all corporate and organizational users. In addition, the government is free to charge users any surcharge per month. For example, \$2 per month goes to Leader, then the government can charge an additional \$2, \$3, \$4 per month social surcharge for social media that was given away free.

\$2 (Leader) =	\$15,400,000,000	\$184,000,000,000
\$2 (Leader) + \$2 (Gov't Surcharge) =	30,800,000,000	369,600,000,000
\$2 (Leader) + \$4 (Gov't Surcharge) =	46,200,000,000	554,400,000,000
\$2 (Leader) + \$6 (Gov't Surcharge) =	61,600,000,000	739,200,000,000

Then, I am also willing, along with other Leader shareholders, to provide more than \$10 billion a year in ongoing funds to sustain the *Conservative Free Press Initiative* indefinitely.
