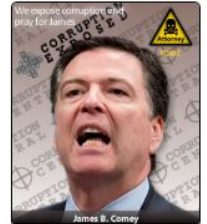

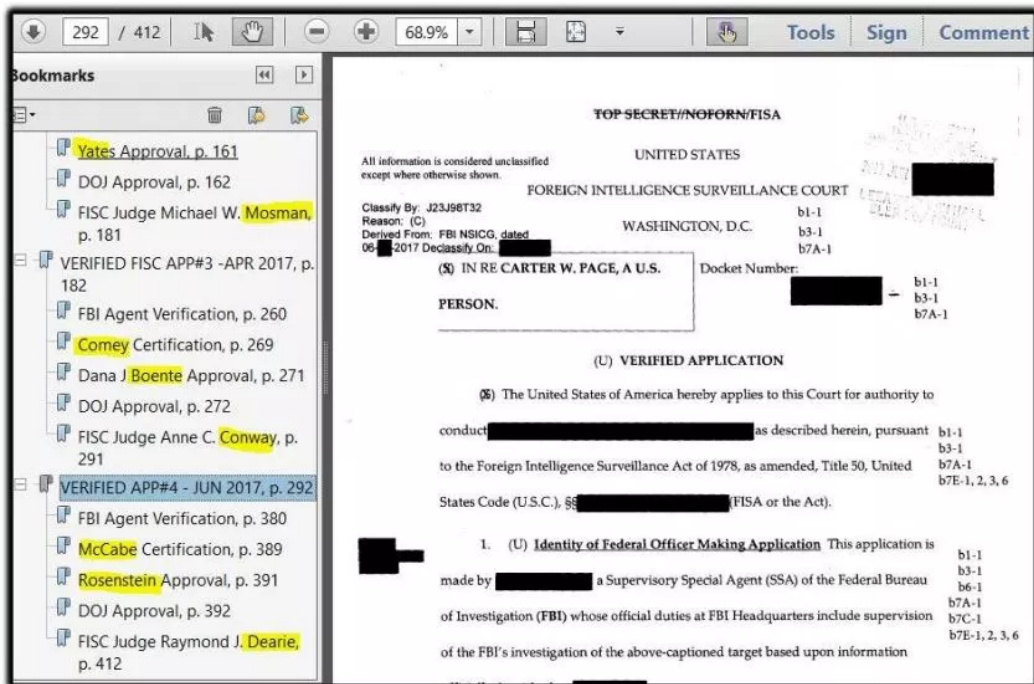
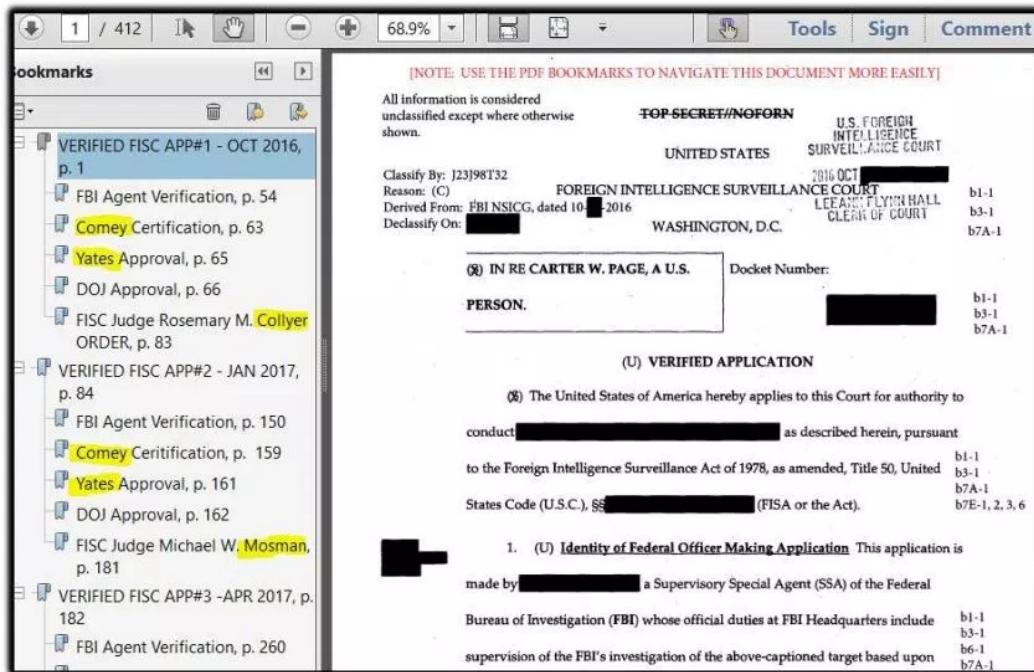
We now know that these warrants were TEASONOUS ATTACKS to attempt to take down a sitting U.S. President.
