


Fig. 2—Gabriel, McKibben. (Aug. 10, 2021). MAINSHOW, Shocking Truth History - Aftershow (British Chatham House, Institute of Pacific Relations created Chinese and Russian Communism). American Intelligence Media, Americans for Innovation. (Raw \*.mp4 video file).



the British IPR Council under the auspices of the Y.M.C.A. as an ostensible "Christian" endeavor;




Fig. 5—TOP SECRET (Mar. 05, 1946). BRITISH-U.S. COMMUNICATION INTELLIGENCE AGREEMENT, NSA DocID 3678942, Ser. XILH, Box 47, TSC release approved Apr. 08, 2010, Executive Order 12958 et seq., p. 7, Sec. 5(a). NSA. ]

This communications-propaganda control created endless opportunities for the British to corner the market on war and profit. To a British eugenicist necromancer, depopulation is icing on the cake.



Remember, these bankers, among the largest slave holders in the world, were arranging for new [white and yellow slave labor](#) to replace the black and brown slave labor that they were just forced to give up. *See also* [Salvation Army and the creation of the social gospel](#) to recruit and train white slaves.

We found a nicely-illustrated and information-packed 30<sup>th</sup> YMCA China annual report that included a “Constructive Activities” supplement dated [Dec. 01, 1925](#).

We are an opinion blog that advocates for strong intellectual property rights. We welcome commenters and contributors. The *Leader v. Facebook* patent infringement case first came to our attention after learning that the trial judge, Leonard P. Stark, U.S. District Court of Delaware, ignored his jury’s admission that they had no evidence to support their on-sale bar verdict, but the judge supported it anyway.

The judicial misconduct has deteriorated from there, replete with two of the three judges on the Federal Circuit appeal panel, Judges Alan D. Lourie and Kimberly A. Moore, holding Facebook stock that they did not disclose to the litigants, and later tried to excuse through a quick motion slipped in at the last minute by the Clerk of Court, Jan Horbaly, and his close friends at The Federal Circuit Bar Association. (The DC Bar subsequently revealed that Mr. Horbaly is not licensed to practice law in Washington D.C.)

The judges ignored [shocking new evidence](#) that Mark Zuckerberg withheld 28 hard drives of 2003-2004 evidence from Leader Technologies that could prove actual theft (and therefore claims even more serious than infringement). In addition, Facebook’s appeal attorney, Thomas G. Hungar of Gibson Dunn LLP, has close personal ties to just about every judicial player in this story. The misconduct appears to reach into the U.S. Patent Office through abuse of the reexamination process by Facebook. We will stay focused on *Leader v. Facebook* until justice is served, but we also welcome news and analysis of intellectual property abuse in other cases as well.




Fig. 6—Constructive Activities of the Young Men's Christian Associations of China, 1925. (Dec. 01, 1925). Annual and Quarterly Reports of the YMCAs of China, Korea, and Hong Kong, 1902-1904, Box 18, Folder 4, PDF p. 14. Univ. of Minnesota, Kautz Family YMCA Archives.





Fig. 7—YMCA-China. (1920). ROCKEFELLER FOLDER, 25 Years: The Illustrated Annual Report of the Young Men's Christian Associations of

Judge Leonard P. Stark, U.S. District Court of Delaware, trial judge in *Leader Techs, Inc. v. Facebook, Inc.*, 770 F. Supp. 2d 686 (D.Del. 2011). Judge Stark heard his jury foreman admit that the jury made the on-sale bar decision without any evidence other than speculation, and yet he supported that verdict anyway. Morgan, among many, to 44,550 members, 42 cities, 201 YMCA facilities, 480 paid teachers, 3+ million program participants, \$1 million income (\$15.5 million today) and \$3.3 million in property value (\$51.2 million today).






Fig. 9—Ray Lyman Wilbur, chairman. (Jun. 30-Jul. 14, 1925). Organizing Conference Record, PROCEEDINGS, Institute of Pacific Relations, Honolulu, Hawaii, pp. 1-2. Institute of Pacific Relations. Reproduced for educational purposes only. Fair Use relied upon.




Fig. 11—Sir Ivison Stevenson Macadam, a British father of global

Sir Ivison S. Macadam was married to American Caroline Ladd Macadam (néé Corbett) from Portland, Oregon (b. Sep. 20, 1910; m. Jan. 01, 1934; d. Aug. 28, 1989). 


Fig. 15—[S. Res. 366, Rept. No. 2050. \(Jun. 27, 1952\)](#). Institute of Pacific Relations, Report, Patrick A. McCarran (NV), chairman, Senate Judiciary Committee, Hrgs. Jul. 25, 1951-Jun. 20, 1952, 81st Cong., 2d sess., p. 193. GPO. (20 MB). See [Google Books](#); see also [Archive.org](#).




Fig. 16—S. Res. 366, Rept. No. 2050. (Jun. 27, 1952). Institute of Pacific Relations, Report, Patrick A. McCarran (NV), chairman, Senate Judiciary Committee, Hrgs. Jul. 25, 1951-Jun. 20, 1952, 81st Cong., 2d sess., GPO.

IPR prime movers [Alger Hiss](#) and [Harry Dexter White](#) were singled out by the 1952 McCarran Committee as perhaps the two most damaging Soviet-Chinese-Chatham House-Pilgrims Society communists within the U.S. State Department and world affairs. Indeed, White was the chief architect of the International Monetary Fund (IMF) and Hiss used the IPR organization as a model for the U.N. and became its first Secretary General. (Note: Y.M.C.A.'s are run by secretaries, as was the Communist Party in the U.S.S.R. and as is the current Chinese Communist Party.)

In terms of present knowledge, however, the most important underground Communists were [Alger Hiss](#) and the late [Harry Dexter White](#). Hiss recently completed a term in Federal prison, after perjuring himself before a Federal grand jury which questioned him about his Communist activities. White died in 1948, a few days after he was publicly exposed as a Communist conspirator by Elizabeth Bentley and Whittaker Chambers. Throughout its entire existence, the subcommittee has put into the record accumulating evidence about the part Hiss, White, and their confederates played as underground agents of the U. S. S. R.

Hiss and White occupied positions of parallel significance both in America's foreign affairs and in international organizations. Hiss went to Yalta as the late President Roosevelt's top international organization specialist. He was one of the architects of the United Nations. When the U. N. organization meeting was held in San Francisco, Hiss became the U. N.'s first Secretary General. He had complete control of the International Secretariat and helped to put a great number of persons on the U. N.'s payroll (U. N. R. pp. 10-12). J. Anthony Panuch, one of his State Department colleagues, told the subcommittee that Hiss exercised Svengali-like influence over Secretary of State Stettinius (H., p. 853).

White was the Treasury's representative at the San Francisco Conference, and was one of those who established UNESCO. He was the chief architect of the International Monetary Fund and the Bank for Reconstruction and Development, which are specialized agencies of U. N. (U. N. R., pp. 12-13). He was also the first United States executive director of the fund. As long ago as December 15, 1941, Secretary of the Treasury Morgenthau gave White "full responsibility for all matters with which the Treasury Department has to deal, having a bearing on foreign relations" (ibid., p. 29).

The record also reflected that [Harry Dexter White](#) was the official Treasury representative on the following interdepartmental and international bodies: The Interdepartmental Lend-Lease Committee; the Canadian-American Joint Economic Committee; the Executive Committee on Commercial Policy; the Executive Committee and Board of Trustees of the Export-Import Bank; the Interdepartmental Committee on Inter-American Affairs; the National Resources Committee; the Price Administration Committee; the Committee on Foreign Commerce Regulations; the Interdepartmental Committee on Post-War Economic Problems; the Committee on Trade Agreements; the National Munitions Control Board; the Acheson Committee on International Relief; the Board of Economic Warfare; the Executive Committee on Economic Foreign Policy; the Liberated Areas Committee; the O. S. S. Advisory Committee; the United States Commercial Corporation; the Interdepartmental Committee on Planning for Coordinating the Economic Activities of United States Civilian Agencies in Liberated Areas; White was also chief architect of the International Monetary Fund as well as its first United States executive director.

As already pointed out, White had "full responsibility" for all matters "having a bearing on foreign relations" in which the Treasury was involved from December 15, 1941. Beyond this, the colleagues of Mr. Mitchell observed White's technique of domination over general Treasury affairs. Against this background, there is considerable sig-
