Herman von Warburg, the first ancestor of the Warburg (UBS) lineage (Federal Reserve co-founder). Wikipedia lies and says the lineage did not start until $\underline{1500}$ with Simon von Kassel (1500-86).³

Ulrich Schwab's home appears to have been near Basel, Switzerland in the nearby village of Phaffans, France. In 1290, his fellow Count of Buchsee (Canton of Bern), **Burchard von Schwanden**, was ordered by the Pope Nicholas IV to reinforce the crusaders (in the 3rd Crusade, 1189-92), who were under siege by the Mamluk Muslims at Acre. Acre was the Teutonic Knight headquarters.

Von Schwanden raised an army hastily that evidently included Ulrich Schwab. Acre fell, but not before von Schwanden had abandoned his command, high tailed it back to Switzerland, quite the Teutonic Knights and joined the Knights Hospitallers. Histories are silent about why he left and changed his allegiance to the Knights Hospitallers.

"The chief cause of the ruin of the Templars was their extraordinary wealth," and the King Philip IV (in conspiracy with Pope Clement) reasoned that Templar Grand Master James (Jacques) de Molay and certain of his staff and friends must be put to death since "<u>he could not get</u> <u>the honey unless he burned the bees</u>."⁴ The overnight beneficiaries were the Knights Hospitallers, whereby modern usury started, and is with us today, controlled by the Rothschilds and their sycophant banks.

forgive his war debt. He ordered **Templar Grand Master James (Jacques) de Molay** and certain Templar leaders to be burned at the stake in order to get at the Templar assets. These confiscations included much Crusader soldier and pilgrim gold and silver in their consistories. Today, the Hospitallers operate in Rome as the usury-dependent <u>Knights of Malta</u> in cooperation with the Vatican Bank and under the control of The Bank of England (British Pilgrims Society—progenitor of Frankish Demonic Imperial British Corporatism).

In the year following Ulrich Schwab's return home he was elevated to commander of the **Knights Hospitallers (1298-1315)** and became the first **Count of Nemerow** (Germany). <u>Source 1,⁶ Source 2, ⁷ Source 3,⁸ Source 4,⁹ Source 5.¹⁰</u>

The Rothschild's first Bacharach ancestor.

In 1973, British Lord Victor Rothschild identified his first relative as "<u>Uri Feibesh</u> (ca. 1450)"¹¹ whose full name was <u>Uri Feibesch BACHARACH</u>.^{12 13}

The Jews of Frankfurt and The Frankfurt Project verify that the blood of the

Rothschilds is actually BACHARACH, a revered rabbinical family.




Figure 3: <u>BACHARACH, SCHWAB, [ROTHSCHILD] AND WERTHEIMER.</u> (Accessed Feb. 17, 2022). Family Tree. The Frankfurt Project.

Schwabs, Bacharachs and Rothschilds are Khazarian, not Judaean.

Recent DNA mapping shows that the Bacharach/Rothschilds and Schwabs are highly likely to be descendants of non-semitic Khazarian Jewish semi-nomadic traders from the <u>Khazarian Empire (ca. 650-950)</u> steppes of Eurasia (today Poland and Hungary in the west, Kazakhstan in the east, southern Russia in the north, Turkey in the south).^{16 17}

Rabbi Menachem Man Bacharach (b. ca. 1395).

The living Schwab—Klaus Schwab,¹⁸ and the living Rothschild—Sir Evelyn de Rothschild¹⁹ have a common grandfather 15 generations ago: **Rabbi Menachem Man Bacharach (b. ca. 1395)**. His grandsons included **Uri (Freibesch) Bacharach (ca. 1450-)** (confirmed by <u>Victor Rothschild</u> albeit he hid the core "Bacharach" name!)²⁰ and **Rabbi Abraham Bacharach (ca. 1540-1505)**.²¹ *See* links above.

Rabbi Abraham's son was Rabbi Schmül Schwab.22

Therefore, *all subsequent Schwabs have common Bacharach/Rothschild blood*. The Rothschild name is fabricated to hide their Bacharach rabbinical blood. It did not appear in the Bacharach blood line until 1802 when Mayer Amschel Rothschild chose it *arbitrarily*, dubiously named after the house he lived in.

Mayer Amschel Rothschild is notoriously recognized as the progenitor of the Rothschild banking business. At the same time as he was funding, by the admission of even the Rothschild Archives, the <u>Hessian soldiers</u>²³ (from his region) to fight for the British in America's war for independence, he also was funding the <u>Sabbatian</u>²⁴ <u>Frankists</u>²⁵ and forming the <u>Illuminati</u> as a Jewish crypto-Freemasonry²⁶—as vehicles to expand his banking business into populations he was otherwise blocked from penetrating as a Jewish person who was also promoting immorality, debauchery, incest, pedophilia, spiritism, necrophilia, lying and murder as good for business.²⁷ In short, he created his own society of secrets and debauchery to secure permanently compromised customers.

Sabbatian Frankism, manifestation of the usury demon.

In about 1751, <u>Jacob Frank (1726-91)</u> claimed to be the Jewish messiah as the reincarnation of an earlier messianic claimant <u>Shabbetai Zvi (1626–76)</u>. Jacob was the founder of the antirabbinical Frankists, or Zoharists.

Jacob Frank held that certain elect persons are exempt from moral law. This sect abandoned Judaism for a "higher Torah" (Jewish Law) based on the Zohar, which was the most important work in the Kabbala, the Jewish mystical movement. Hence its members are also called themselves Zoharists.

Jacob Frank was a proponent of an antinomian anarchist approach that rejected all the prohibitions and restrictions of Jewish law, including the laws of incest.

Habsburg Black Monarchies Submit to Klaus' demon.

Klaus Schwab's key note speakers at the founding of the <u>World Economic Forum (WEF)</u> at Davos on Jan. 04, 1971 included Henry Kissinger and Otto von Habsburg (photo, left), the last crown prince of the Austria-Hungary empire.^{28 29}

To reiterate, in 1298, Klaus' earliest ancestor was Count Sir Ulrich Schwab. He was the first Count of Nemerow and was elevated to a knight commander of the Knights Hospitallers (Order of St. John). See links above.

Ulrich Schwab was elevated to commander after the Hospitallers in the 3rd Crusade had lost their headquarters in Acre (now Israel) in 1291 to the Mamluk Muslims— the successors of the *Seljuks that included Muslim Khazarians*.

The Rothschild, Bacharach, Schwab interlocked blood lines.

Ulrich very likely participated in this battle under the command of Bern, Switzerland patrician <u>Burchard von Schwanden</u> (d. 1310).

Von Schwanden (meaning to "thin out" or "disappear") abandoned his command in Acre and fled back to German, joined the Knights Hospitallers and became their commander in Buchsee (a Canton of Bern).

Just seven years later, Ulrich Schwab was knighted by the Hospitallers as commander over Nemerow where he became the first count, even though he had lived in Pfaffans, France just 40 miles from Bern. Since such elevations among aristocrats usually involve a battle story (which are generally fabricated), his alleged soldiering in Acre is the evident reason.

Then, this story takes a fateful twist.

In 1289, just a year before leaving for Acre, Von Schwanden left for Rome where, in the presence of the Pope, Von Schwanden again petitioned the Pope to acknowledge **Rudolf von Habsburg** as the sole king of all of Germany and Austria. Evidently, his and Ulrich's quick rise with the ranks of the Hospitallers was part of the plan to grow the Pope's power and benefit the emerging Habsburg Empire. Indeed, in 1314, the Pope seized all Knights Templar banks and consistories and turned them over to the Knights Hospitallers. Since the Templars had not charged interest on debt, such practices evidently began under the Hospitallers.

Almost 600 years of demonic activity was ushered in by usury.

Postscript:

The Spear of Destiny, also known as the **Holy Lance**, is in Christian tradition the spear that the Roman soldier Longinus thrust into the side of Jesus (33 A.D.) as he hung on the cross.

"Then came the soldiers to break the legs of the first and of the other which was crucified with him. But when they came to Jesus and saw that he was dead already, they brake not his legs: But one of the soldiers with a spear pierced his side and forthwith came out blood and water." —John 19: 32–34 KJV

Christian knights discovered the Holy Lance at Antioch during the First Crusade in 1098. That Crusade was commanded by the subsequent founder of the Knights Templar, Raymond of St. Gilles (or Toulouse). One of his monks, Peter Bartholomew, had a series of dreams where the Apostle Thomas spoke to him and told him



where the Holy Lance was located. The sight of the sacred object that had been buried under the altar in the Church of St. Peter so inspired the starving Christian soldiers that they rallied and routed the Seljuk Muslims who outnumbered them five to one. Energized by that evident miracle, they marched on to liberate Jerusalem with the Holy Lance stanchion leading their marches. This event is well recorded by multiple First Crusade chroniclers.

From that time forth, according to legend, whoever claims the spear and solves its secret holds the destiny of the world in his hands for good or evil. For example, Adolf Hitler was obsessed with possessing the Holy Lance to secure his Third Reich. Indeed, his first act on Mar. 12, 1938 upon seizing Vienna (the Anschluss Österreichs) was to dissolve the Habsburg Monarchy and confiscate the <u>Imperial Regalia</u> that included the Habsburg lance.

Curiously, altogether missing from the histories about Count Ulrich Schwab and his Knights Hospitaller conspirators is the importance that Popes and Kings alike placed on having possession of the Holy Lance.

These histories clearly reveal popes and princes vying for the title of Holy Roman Emperor and King of Germany. In this mix, Popes claimed power over local governments. In short, the Popes wanted supreme power and the money to cement it. In counterpoint, the kings and princes wanted the same thing.

Without funds, neither popes nor kings could secure their control. Hence, they coveted the wealth that had been accrued by the Knights Templar.

Since 1118, the Knights Templar had set up banks to manage the funds and property of Crusaders, many of whom died in battle and their property bequeathed to the Pope, on paper. But, in reality, the Templars, as the stewards of these properties, started loaning money against these assets using

non-interest bearing instruments. Once those assets were encumbered by such loans, the Pope's effective control of those funds was minimal. In addition, the Popes, disingenuously, wanted to use "court Jews" to loan money *with interest* since they were Biblically prohibited from usury—a moral fiddle in which certain Jews like the Warburgs, Rothschilds and Schwabs were only too willing to accommodate.

The Holy Lance of Antioch, we believe, was never given to the Pope after the death of Raymond of St. Gilles on Feb. 28, 1105, but rather, was entrusted to his son, Alfonso Jordan, and his pious wife, Elvira of Castile. Alfonso had been baptized with the Lance in the River Jordan as instructed by Peter Bartholomew's dreams. We believe they took the Holy Lance of Antioch home with them to Toulouse.

This holy relic, perhaps the most revered in Christendom, was universally believed to give blessing to all who venerated it. It is inconceivable that Alfonso and his mother did not have a priest bless Class 3 relic copies of the original lance before they returned home.³⁴

The circumstances of Count Burchard von Schwanden's inexplicable departure from Acre, abandoning his army, appears to be related to a potential discovery of one of these Class 3 relic copies of the Holy Lance whose provenance was likely exaggerated to be a Class 1 original.

With this blessed Class 3 lance in his possession, thinking it was Class 1, Pope Clement V made his move on the Templars to seize their assets and shop for a king who would acknowledge him as supreme.

On Aug. 26, 1346, <u>Charles IV</u> was crowned Holy Roman Emperor *in the presence of the lance* likely brought to him from Acre in the Third Crusade, possibly by Schwab's commander Count Burchard von Schwanden. This coronation was the consequence of an alliance between Charles IV's father and <u>Pope Clement VI</u>, perhaps even with an aging Count Ulrich Schwab (d. unknown) looking on.

Evidently, Pope Clement VI believed that with his (Habsburg) lance and the Templar wealth in hand, he would empower the Habsburg lineage, that were not dethroned until 1938—592 years later when Hitler seized the Habsburg lance in the Anschluss Österreichs.
