
A large portion of the American public *believed* the lies of the Trump-Russia Hoax.

On July 18, 2025, Director of National Intelligence (DNI) **Tulsi Gabbard** released declassified documents providing evidence that senior Obama administration officials coordinated to challenge the legitimacy of President Donald J. Trump's 2016 election victory. These documents, including emails, meeting summaries, and intelligence assessments, demonstrate a deliberate effort to produce a false narrative of Russian interference to discredit Trump's presidency, which **Gabbard** herself describes as a “coup.” The evidence further establishes the evident backroom involvement of the **British Pilgrims Society** and its **Five Eyes** intelligence network in shaping their falsities, with key U.S. officials acting in concert with British counterparts.

“Pissgate” fabricator **Christopher Steele** (named by Gabbard) was a **British Pilgrims Society** agent through **MI-6**, as were other British Pilgrims **Cambridge Analytica** (**Sir Geoffrey Pattie**), **Dominion et al** (**Lord Mark Malloch-Brown-Soros UN**), **Joseph Mifsud**, **Arvinder Sambei** (**Crown Prosecution Service, CPS, Robert Mueller**), **Alison Saunders (CPS)**, **Robert Hannigan (GCHQ)**, **Sir Richard Dearlove (MI6)**,



Dame Elizabeth Manningham-Bueller (MI5), Sir Nick Clegg (Facebook), Baron Richard Allen (Facebook), Alexander Nix (Cambridge Analytica, SCL Group), all modern-day British Prime Ministers, and others. It was a thoroughly British operation with the CIA, FBI, NSA operating as their lapdogs. The lapdog mainstream media persistently labeled Steele a “retired” MI6 because they knew the general public does not know that an intelligence officer (a paid liar) never retires, and in the case of **Pilgrims Society** members, they issue and execute orders until they die.(See 18. Mary McCord below).

The Gabbard DNI disclosures drip with veiled **British-American Pilgrims Society “Five Eyes”** cooperation to carry out the Russia Hoax. For example, “U.S.-Australia Strategic Dialogue,” “Maria Fernandez” (AU Deputy Director for Intelligence, coordination of sharing of social media “data lakes” with Australia, a **UK Commonwealth** member of “**Five Eyes**”) (PDF p. 6).

The Pilgrims Society was formed in London in 1902. It was a gathering of British autocrats and their American sycophants **JPMorgan, John D. Rockefeller, Andrew Carnegie, Paul Warburg, Elihu Root, Columbia’s Nicholas Murray Butler,** along with **Lord Rothschild, Lord Rosebery, Lord Alfred Milner, Lord Northcliffe, W.T. Stead, Winston Churchill, Lord Pirbright, Lord Curzon, King Edward VII,** etc. intent on reorganizing the British Empire from a colonial monarchy to a one-world imperial corporatist one. They have been dedicated to secrecy, hegemony, and banking supremacy of the many by the few. One of their primary goals is the “**Annexation of America**” back into the British Empire. **Make America British Again,** if you will. Toward that end they have sponsored a new war every two years on our beloved planet. The current perpetrators must be hung for their treason, including posthumously.

“Unlikely” That Russia Altered Outcomes

The assessment concluded: “Cyber Threats [from Russia] to US Election Unlikely To Alter Voting Outcomes.” (PDF p. 35). Obama (British Pilgrims Society agent) did not like that conclusion ordered it suppressed, and flipped into an evil hoax campaign against incoming president Donald J. Trump. It then became a literal work of the devil.

DNI Tulsi Gabbard released judicially-recognizable evidence that:

“On December 9, 2016, President Obama’s White House gathered top National Security Council Principals for a meeting that **included James Clapper, John Brennan, Susan Rice, John Kerry, Loretta Lynch, Andrew McCabe** and [20] others, to discuss Russia.”

DNI Gabbard formally labeled this activity a “**coup.**”

A *coup d'état* against a sitting U.S. president, involving the illegal use of force to overthrow or displace the government, would likely be prosecuted under federal laws such as treason (18 U.S.C. § 2381), seditious conspiracy (18 U.S.C. § 2384), or rebellion or insurrection (18 U.S.C. § 2383).

Besides the fact that these conspirators were officially employed by the American people within the Executive Branch, they are all members of the Senior Executive Service (SES) that have extensive ties to foreign powers including the British Pilgrims Society, Crown Agents, Jeffrey Epstein's true employer in our opinion.

The British agents identified in the opening paragraph are deeply connected with the CIA, FBI, and NSA and MI6, MI5, GCHQ, and Mossad (an extension of MI6 in Israel).

None Dare Call It Treason

18 U.S.C. § 2381 — Treason — Death

“Whoever, owing allegiance to the United States, levies war against them or adheres to their enemies, giving them aid and comfort within the United States or elsewhere, is guilty of treason and shall suffer death, or shall be imprisoned not less than five years and fined under this title but not less than \$10,000; and shall be incapable of holding any office under the United States.”

The 26 participants (table below) in the treasonous December 9, 2016 were as follows. One can reasonably assume that every participant involved with propaganda, media, and intelligence were and still are agents of the British Pilgrims Society and its English-Speaking Union. The Senior Executive Service (SES) members are confirmed by the government's “Plum Book.”

One quick conclusion for President Trump should be, in our opinion, to dismiss all 10,000 SES employees since they are evidently not accountable to him as the Executive, by their own policy admissions, even though the President pays their salaries. Further, it is certainly not coincidental proof of conspiracy that all of the parties named below were/are SES, acting in concert to execute a *coup d'état*.
